


11.1 **Test Setup**



11.2 Measurement Procedure

- 1. Place the EUT on the table and set it in transmitting mode.
- 2. The testing follows FCC KDB 987594 D02 In-Band Emissions procedure:
 - Set the span to encompass the entire 26 dB EBW of the signal a.
 - Set RBW = same RBW used for 26 dB EBW measurement b.
 - Set VBW ≥ 3 X RBW C.
 - Number of points in sweep \geq [2 X span / RBW]. d.
 - Sweep time = auto. e.
 - f. Detector = RMS
 - Trace average at least 100 traces in power averaging (rms) mode g.
 - Use the peak search function on the instrument to find the peak of the spectrum. h.
- For the purposes of developing the emission mask, the channel bandwidth is defined as 3. the 26 dB EBW.
