





Fig.1 Photograph of the SAR measurement System




Fig.2.3 Photograph of the Tissue Simulant Fluid liquid depth 15cm for Flat (Body)




Fig.2.5 Photograph of the Tissue Simulant Fluid liquid depth 15cm for Flat (Body)




Fig.2.4 Photograph of the Tissue Simulant Fluid liquid depth 15cm for Flat (Body)




Fig.4 Right Head Section / Ear-Tilt Position(15°)




Fig.7 Body worn- EUT front to flat phantom and distance between flat phantom and mobile phone is 1.5 cm




Fig.12 Left side view of device
