# **3. TEST METHODOLOGY**

The tests documented in this report were performed in accordance with ANSI C63.4 (2001) and FCC CFR 47 2.1046, 2.1047, 2.1049, 2.1051, 2.1053, 2.1055, 2.1057, 15.207, 15.209 and 15.247.

# 3.1 EUT CONFIGURATION

The EUT configuration for testing is installed on RF field strength measurement to meet the Commissions requirement and operating in a manner that intends to maximize its emission characteristics in a continuous normal application.

### **3.2 EUT EXERCISE**

The EUT was operated in the engineering mode to fix the TX frequency that was for the purpose of the measurements.

According to its specifications, the EUT must comply with the requirements of the Section 15.207, 15.209 and 15.247 under the FCC Rules Part 15 Subpart C.

### **3.3 GENERAL TEST PROCEDURES**

#### **Conducted Emissions**

The EUT is placed on the turntable, which is 0.8 m above ground plane. According to the requirements in Section 13.1.4.1 of ANSI C63.4 (2001) Conducted emissions from the EUT measured in the frequency range between 0.15 MHz and 30MHz using CISPR Quasi-peak and average detector modes.

#### **Radiated Emissions**

The EUT is placed on a turn table, which is 0.8 m above ground plane. The turntable shall rotate 360 degrees to determine the position of maximum emission level. EUT is set 3m away from the receiving antenna, which varied from 1m to 4m to find out the highest emission. And also, each emission was to be maximized by changing the polarization of receiving antenna both horizontal and vertical. In order to find out the max. emission, the relative positions of this hand-held transmitter (EUT) was rotated through three orthogonal axes according to the requirements in Section 13.1.4.1 of ANSI C63.4. (2001)

(b) Except as provided in paragraphs (d) and (e), the field strength of emissions appearing within these frequency bands shall not exceed the limits shown in Section 15.209. At frequencies equal to or less than 1000 MHz, compliance with the limits in Section 15.209 shall be demonstrated using measurement instrumentation employing a CISPR quasi-peak detector. Above 1000 MHz, compliance with the emission limits in Section 15.209 shall be demonstrated based on the average value of the measured emissions. The provisions in Section 15.35 apply to these measurements.

### **3.5 DESCRIPTION OF TEST MODES**

The EUT has been tested under operating condition.

Test program used to control the EUT for staying in continuous transmitting and receiving mode is programmed.

There are two sources of power adapters and two batteries (please refer EUT description). After verified, the worst data in the test report is Delta / PA-14.

Channel Low (2402MHz)  $\cdot$  Mid (2441MHz) and High (2480MHz) with highest data rate (worst case) are chosen for full testing.

The field strength of spurious radiation emission was measured in the following position: EUT stand-up position (X axis), lie-down position (Y, Z axis). The worst case (Y axis) was reported.



# 4. INSTRUMENT CALIBRATION

The measuring equipment, which was utilized in performing the tests documented herein, has been calibrated in accordance with the manufacturer's recommendations for utilizing calibration equipment, which is traceable to recognized national standards.



# 5. FACILITIES AND ACCREDITATIONS

### 5.1 FACILITIES

All measurement facilities used to collect the measurement data are located at

The sites are constructed in conformance with the requirements of ANSI C63.7, ANSI C63.4 (2001) and CISPR Publication 22.

### 5.2 EQUIPMENT

Radiated emissions are measured with one or more of the following types of linearly polarized antennas: tuned dipole, biconical, log periodic, bi-log, and/or ridged waveguide, horn. Spectrum analyzers with pre-selectors and quasi-peak detectors are used to perform radiated measurements.

Conducted emissions are measured with Line Impedance Stabilization Networks and EMI Test Receivers.

Calibrated wideband preamplifiers, coaxial cables, and coaxial attenuators are also used for making measurements.

All receiving equipment conforms to CISPR Publication 16-1, "Radio Interference Measuring Apparatus and Measurement Methods."

### 5.3 LABORATORY ACCREDITATIONS AND LISTING

The test facilities used to perform radiated and conducted emissions tests are accredited by National Voluntary Laboratory Accreditation Program for the specific scope of accreditation under Lab Code: 200600-0 to perform Electromagnetic Interference tests according to FCC PART 15 AND CISPR 22 requirements. No part of this report may be used to claim or imply product endorsement by NVLAP or any agency of the US Government. The maximum peak output power of the intentional radiator shall not exceed the following:


- 1. For systems using digital modulation in the bands of 902-928 MHz, 2400-2483.5 MHz, and 5725-5850 MHz: 1 watt.
- 2. Except as shown in paragraphs (b)(3) (i), (ii) and (iii) of this section, if transmitting antennas of directional gain greater than 6 dBi are used the peak output power from the intentional radiator shall be reduced below the stated values in paragraphs (b)(1) or (b)(2) of this section, as appropriate, by the amount in dB that the directional gain of the antenna exceeds 6 dBi.


According to §15.247(c), in any 100 kHz bandwidth outside the frequency bands in which the spread spectrum intentional radiator in operating, the radio frequency power that is produced by the intentional radiator shall be at least 20dB below that in the 100kHz bandwidth within the band that contains the highest level of the desired power, In addition, radiated emissions which fall in the restricted bands, as defined in §15.205(a), must also comply with the radiated emission limits specified in15.209(a).



- 2. The turntable shall be rotated for 360 degrees to determine the position of maximum emission level.
- 3. EUT is set 3m away from the receiving antenna, which is varied from 1m to 4m to find out the highest emission.
- 4. Set the spectrum analyzer in the following setting in order to capture the lower and upper band-edges of the emission:
  - (a) PEAK: RBW=VBW=1MHz / Sweep=AUTO
  - (b) AVERAGE: RBW=1MHz / VBW=10Hz / Sweep=AUTO
- 5. Repeat the procedures until all the PEAK and AVERAGE versus POLARIZATION are measured.




- 1. For direct sequence systems, the peak power spectral density conducted from the intentional radiator to the antenna shall not be greater than 8dBm in any 3kHz band during any time interval of continuous transmission.
- 2. The direct sequence operating of the hybrid system, with the frequency hopping operation turned off, shall comply with the power density requirements of paragraph (d) of this section.






#### **Test Plot**

#### PPSD (CH Mid)










#### **Test Plot**
