## Appendix E. CDMA2000 1xRTT Test Modes for HAC

The phone was tested in all normal configurations for the ear usage. These test configurations are tested at the high, middle and low frequency channels of each applicable operating mode, if applicable; each configuration is tested with the antenna in its fully stowed and deployed positions. The signal was setup by linking an over the air connection between the DUT and an Agilent 8960 (E5515C Wireless Communications Tester). The CDMA radio is available on IS-95 (Radio Configuration 1) and CDMA2000 1xRTT (Radio Configuration 3). The DUT supports IS-95 2G networks, CDMA2000 1xRTT for Cellular band and PCS band. The maximum peak field is chosen for HAC testing for worst case scenario. A full HAC measurement in this report is done in eighth rate of RC3+SO55 mode for Cellular and PCS band.
