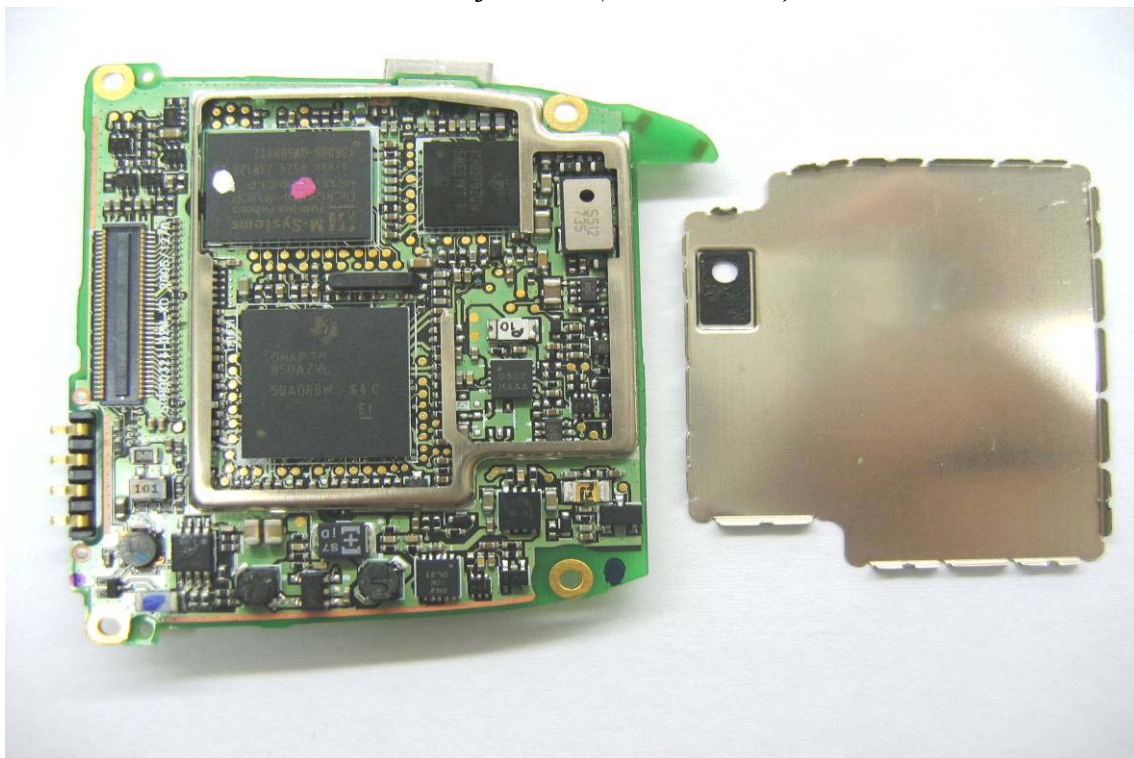

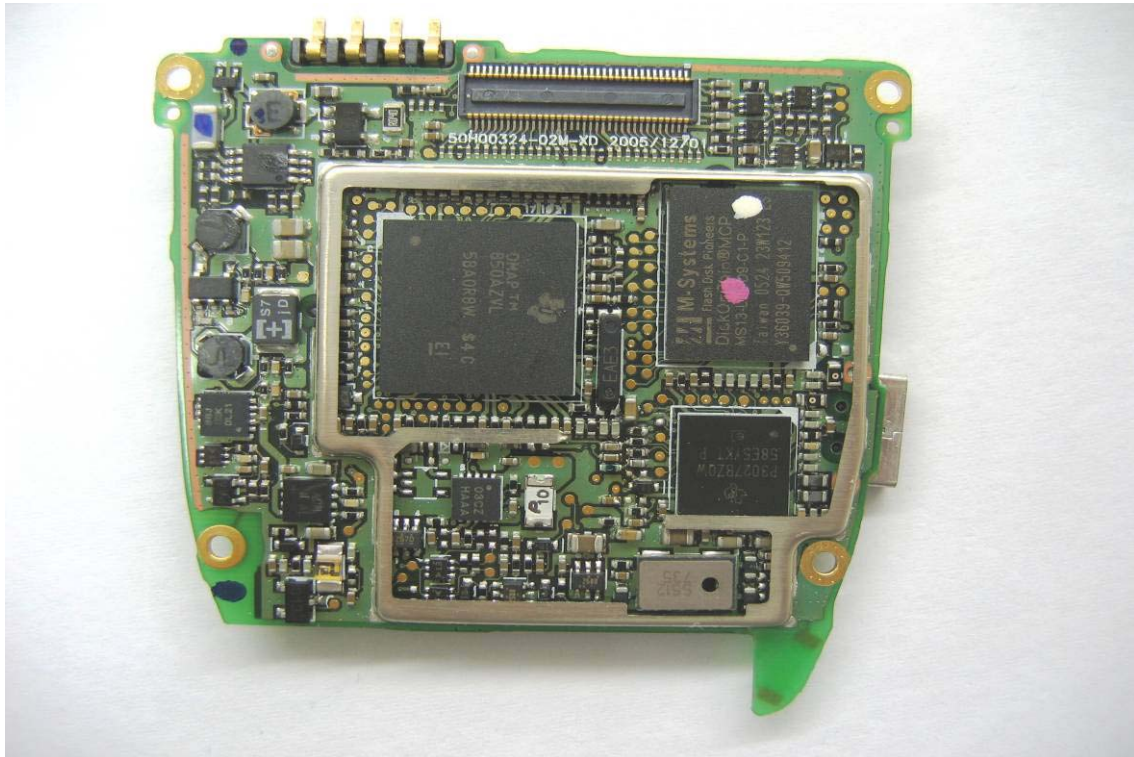


Internal of EUT-2 (GSM Module)

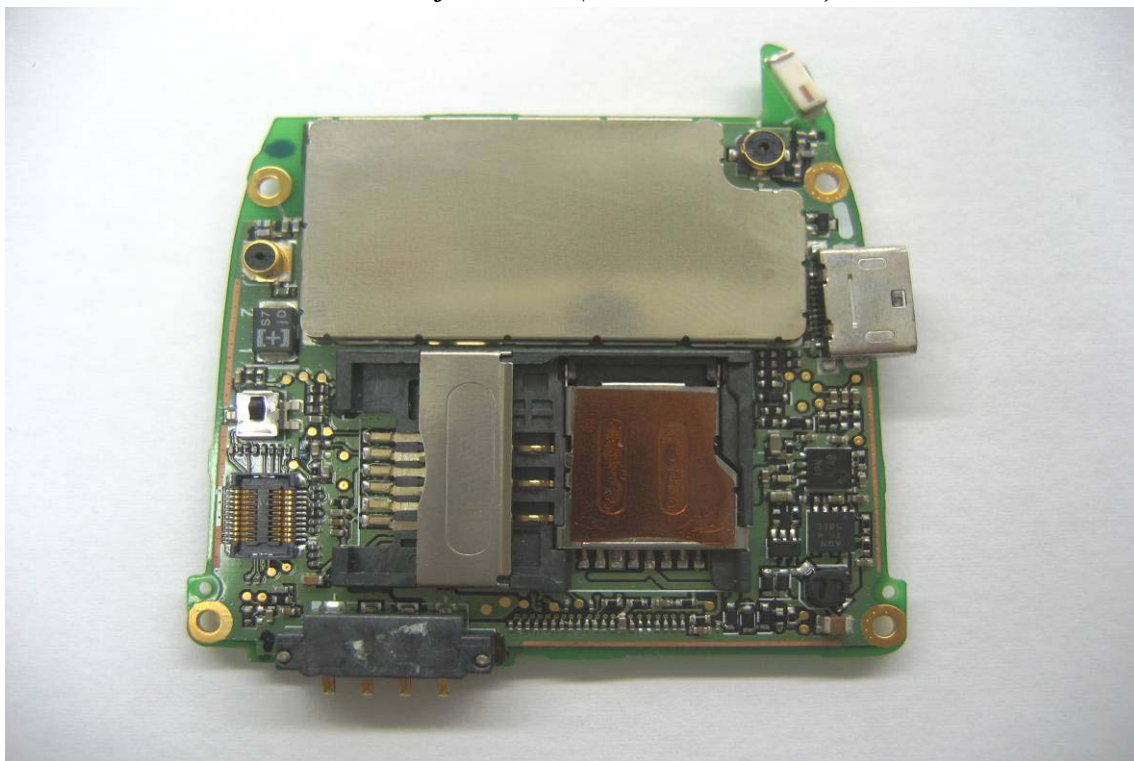

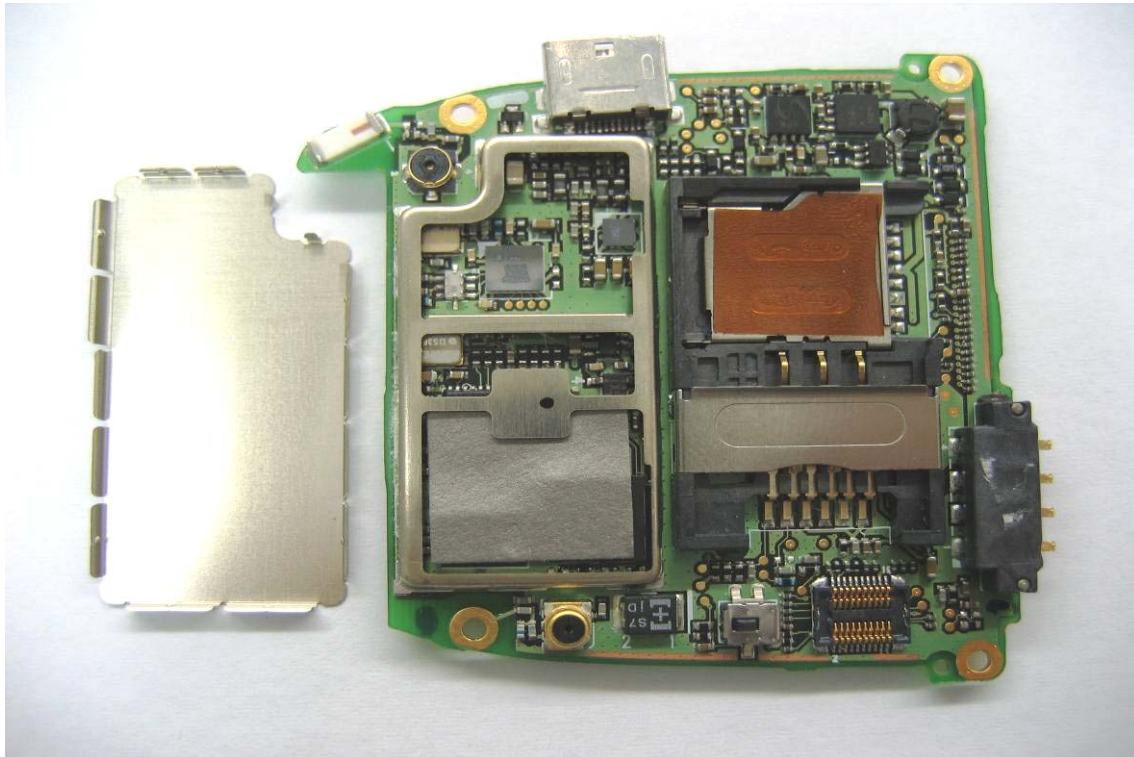


Internal of EUT – 4 (Bluetooth Module)

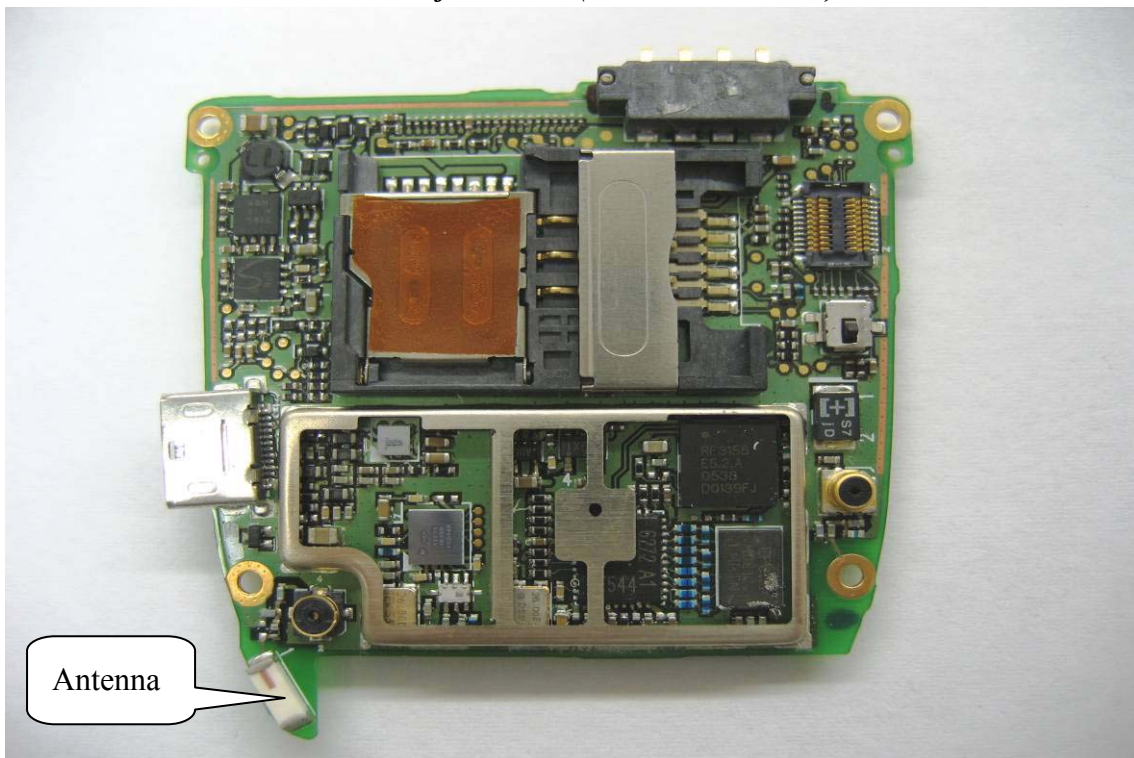

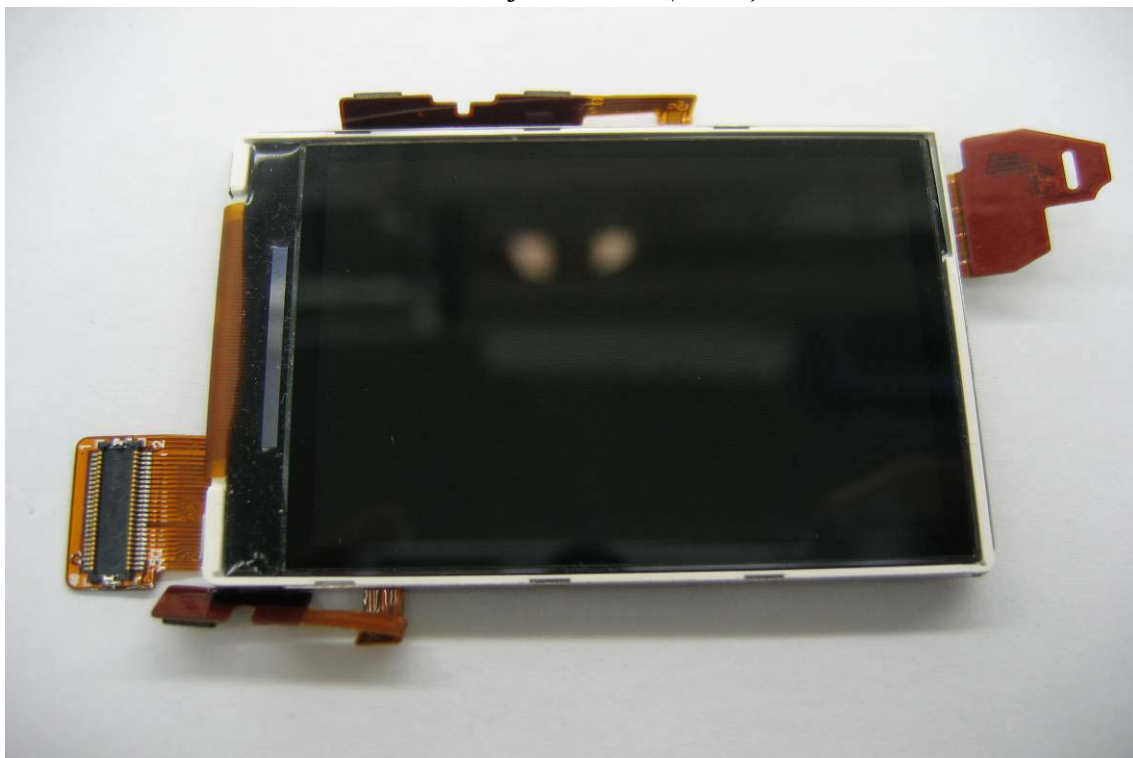

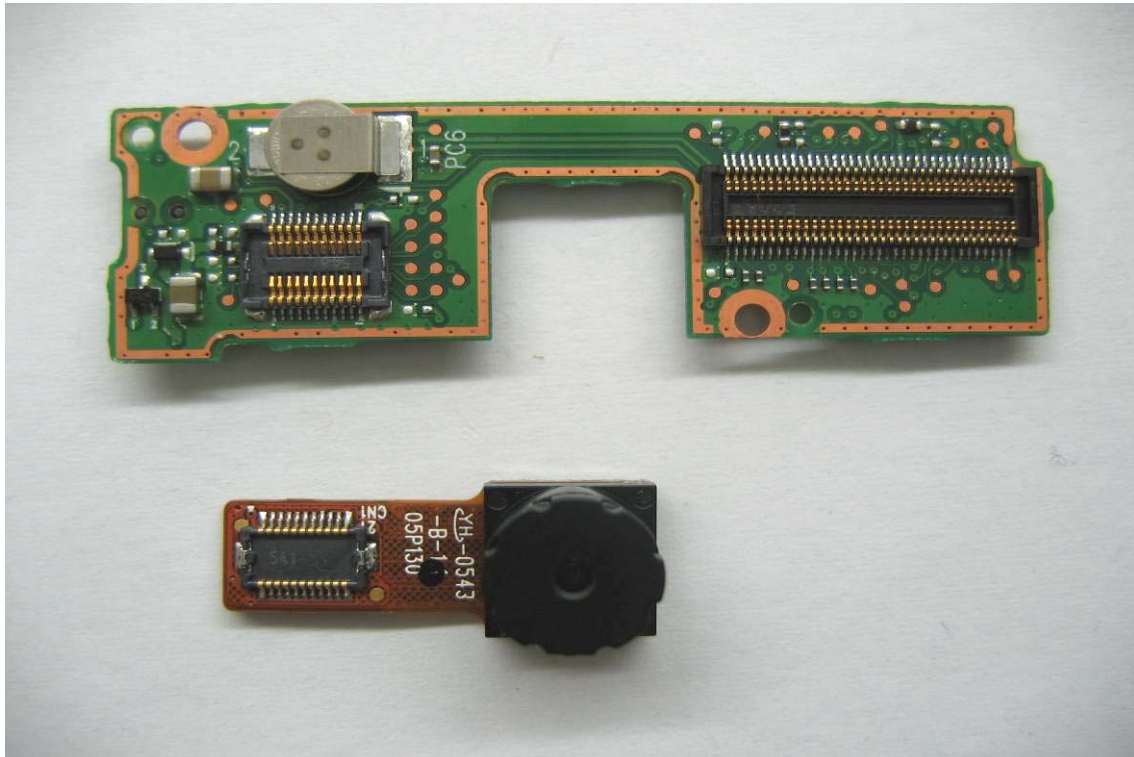
