Test mode: GFSK Test channel:2440MHz Middle








Figure 1. Below 30MHz

Figure 2. 30MHz to 1GHz




Figure 3. Above 1 GHz

Test Procedure:

- a. The EUT was placed on the top of a rotating table 0.8 meters above the ground at a 3 meter semi-anechoic camber. The table was rotated 360 degrees to determine the position of the highest radiation.

Otherwise the emissions that did not have 10dB margin would be re-tested one by one using peak, quasi-peak or average method as specified and then reported in a data sheet.
- g. Test the EUT in the lowest channel (2402MHz),the middle channel (2440MHz),the Highest channel (2480MHz)






Figure 1. 30MHz to 1GHz
