## 4 SAR Evaluation

#### 4.1 RF Exposure Compliance Requirement

#### 4.1.1 Standard Requirement

According to KDB447498D01 General RF Exposure Guidance v05

4.3.1. Standalone SAR test exclusion considerations

Unless specifically required by the published RF exposure KDB procedures, standalone 1-g head or body and 10-g extremity SAR evaluation for general population exposure conditions, by measurement or numerical simulation, is not required when the corresponding SAR Exclusion Threshold condition, listed below, is satisfied.

#### 4.1.2 Limits

The 1-g and 10-g SAR test exclusion thresholds for 100 MHz to 6 GHz at test separation distances  $\leq$  50 mm are determined by:

[(max. power of channel, including tune-up tolerance, mW)/(min. test separation distance, mm)]  $\cdot$  [ $\sqrt{f}(GHz)$ ]  $\leq 3.0$  for 1-g SAR and  $\leq 7.5$  for 10-g extremity SAR, where

f(GHz) is the RF channel transmit frequency in GHz

Power and distance are rounded to the nearest mW and mm before calculation<sup>17</sup> The result is rounded to one decimal place for comparison

The test exclusions are applicable only when the minimum test separation distance is  $\leq$  50 mm and for transmission frequencies between 100 MHz and 6 GHz. When the minimum test separation distance is < 5 mm, a distance of 5 mm is applied to determine SAR test exclusion

#### 4.1.3 EUT RF Exposure

The Max Conducted Peak Output Power is 1.61dBm in highest channel(2.480GHz);

The best case gain of the antenna is -1.5dBi.

EIRP= 1.61dBm + (-1.5)dBi = 0.11dBm

0.11dBm logarithmic terms convert to numeric result is nearly 1.0257mW

According to the formula. calculate the EIRP test result:
