A. Purpose of Test

C. **Test Site**

All testing was performed at MET Laboratories, Inc., 4855 Patrick Henry Drive, Building 6, Santa Clara, California 95054. All equipment used in making physical determinations is accurate and bears recent traceability to the National Institute of Standards and Technology.


Radiated Emissions measurements were performed in a 10 meter semi-anechoic chamber (equivalent to an Open Area Test Site). In accordance with §2.948(a)(3), a complete site description is contained at MET Laboratories. In accordance with §2.948(d), MET Laboratories has been accredited by the National Voluntary Laboratory Accreditation Program

(Lab Code: 100273-0).

D. Description of Test Sample

The FSN-8519-1 Remote Unit, Equipment Under Test (EUT) is part of an RF signal amplifier system, consisting of the InterReach Fusion SingleStar Hub unit which communicates with the InterReach Fusion Remote Access Unit. The Hub unit connects to a base station and receives RF signal, which then converts the signal to IF signal. The IF signal is distributed to external Remote Access Unites (RAU) via coax cabling. The Remote Access Unit converts the signal back to RF and transmits it to and from wireless devices located with the RAU's area of coverage. DC power is also provided to RAU, from the Hub, via the coax cabling.

Radiated & Conducted Emission




Figure 1. Block Diagram of Test Configuration

A modulated carrier was supplied to both the Up Link and Down Link port at an appropriate RF level. The EUT is not equipped with any method of controlling the RF output power.

I. Method of Monitoring EUT Operation

A Spectrum Analyzer and a Power Meter was use to monitor the EUT's transmitter channel and power output.

Test Requirements: § 2.1046 Measurements required: RF power output:

§ 2.1046 (a) For transmitters other than single sideband, independent sideband and controlled carrier radiotelephone, power output shall be measured at the RF output terminals when the transmitter is adjusted in accordance with the tune-up procedure to give the values of current and voltage on the circuit elements specified in § 2.1033(c)(8). The electrical characteristics of the radio frequency load attached to the output terminals when this test is made shall be stated.

§ 2.1046 (b) For single sideband, independent sideband, and single channel, controlled carrier radiotelephone transmitters, the procedure specified in paragraph (a) of this section shall be employed and, in addition, the transmitter shall be modulated during the test as specified and as applicable in § 2.1046 (b) (1-5). In all tests, the input level of the modulating signal shall be such as to develop rated peak envelope power or carrier power, as appropriate, for the transmitter.

§ 2.1046 (c) For measurements conducted pursuant to paragraphs (a) and (b) of this section, all calculations and methods used by the applicant for determining carrier power or peak envelope power, as appropriate, on the basis of measured power in the radio frequency load attached to the transmitter output terminals shall be shown. Under the test conditions specified, no components of the emission spectrum shall exceed the limits specified in the applicable rule parts as necessary for meeting occupied bandwidth or emission limitations.

§ 22.913 Power and antenna height limits.

§ 22.913(a): The Effective radiated power (ERP) of base transmitters and cellular repeaters must not exceed 500 watts.

§ 2.1049 Occupied Bandwidth

Test Requirement(s): § 2.1049 Measurements required: Occupied bandwidth: The occupied bandwidth, that is the

frequency bandwidth such that, below its lower and above its upper frequency limits, the mean powers radiated are each equal to 0.5 percent of the total mean power radiated by a given emission shall be measured under the specified conditions of § 2.1049 (a) through (i) as

applicable.

Test Procedures: As required by 47 CFR 2.1049, occupied bandwidth measurements were made with a Spectrum

Analyzer connected to the RF ports for both Uplink and Downlink


The modulation characteristics of signal generator's carrier was measured first at a maximum RF level prescribed by the OEM. The signal generator was then connected to either the Uplink or Downlink input at the appropriate RF level. The resulting modulated signal through the EUT

was measured and compared against the original signal.






Plot 1. AMPS Downlink Input




Plot 2. AMPS Downlink Output




Plot 3. AMPS Uplink Input




Plot 4. AMPS Uplink Output




Plot 5. CDMA Downlink Input




Plot 6. CDMA Downlink Output




Plot 7. CDMA Uplink Input




Plot 8. CDMA Uplink Output




Plot 9. TDMA Downlink Input

§ 2.1053 Radiated Spurious Emissions

Test Requirement(s): § 2.1053 Measurements required: Field strength of spurious radiation.

§ 2.1053 (a) Measurements shall be made to detect spurious emissions that may be radiated directly from the cabinet, control circuits, power leads, or intermediate circuit elements under normal conditions of installation and operation. Curves or equivalent data shall be supplied showing the magnitude of each harmonic and other spurious emission. For this test, single sideband, independent sideband, and controlled carrier transmitters shall be modulated under the conditions specified in paragraph (c) of § 2.1049, as appropriate. For equipment operating on frequencies below 890 MHz, an open field test is normally required with the measuring instrument antenna located in the far-field at all test frequencies. In the event it is either impractical or impossible to make open field measurements (e.g. a broadcast transmitter installed in a building) measurements will be accepted of the equipment as installed. Such measurements must be accompanied by a description of the site where the measurements were made showing the location of any possible source of reflections which might distort the field strength measurements. Information submitted shall include the relative radiated power of each spurious emission with reference to the rated power output of the transmitter, assuming all emissions are radiated from half-wave dipole antennas.

- § 2.1053 (b): The measurements specified in paragraph (a) of this section shall be made for the following equipment:
 - (1) Those in which the spurious emissions are required to be 60 dB or more below the mean power of the transmitter.
 - (2) All equipment operating on frequencies higher than 25 MHz.
 - (3) All equipment where the antenna is an integral part of, and attached directly to the transmitter.
 - (4) Other types of equipment as required, when deemed necessary by the Commission.
- **§ 22.917 Emission limitations Cellular equipment:** The rules in this section govern the spectral characteristics of emissions in the Cellular Radiotelephone Service.
- § 22.917 (a) Out of band emissions. The power of any emission outside of the authorized operating frequency ranges must be attenuated below the transmitting power (P) by a factor of at least $43 + 10 \log(P)$.



Electromagnetic Compatibility Intentional Radiators CFR Title 47 Part 22 Subpart H

Test Procedures:

As required by 47 CFR 2.1053, *field strength of radiated spurious measurements* were made in accordance with the procedures of TIA/EIA-603-A-2001 "Land Mobile FM or PM Communications Equipment Measurement and Performance Standards".

Radiated emission measurements were performed inside a 10 meter semi-anechoic chamber. The EUT was set at a distance of 3m from the receiving antenna. The EUT's RF ports were terminated to 50ohm load. The EUT was set to transmit at the low, mid and high channels of the transmitter frequency range at its maximum power level. The EUT was rotated about 360° and the receiving antenna scanned from 1-4m in order to capture the maximum emission. A calibrated antenna source was positioned in place of the EUT and the previously recorded signal was duplicated. The maximum EIRP of the emission was calculated by adding the forward power to the calibrated source plus its appropriate gain value. These steps were carried out with the receiving antenna in both vertical and horizontal polarization. Harmonic emissions up to the 10th or 40GHz, which ever was the lesser, were investigated.

§ 2.1051 Spurious Emissions at Antenna Terminals

Test Requirement(s):

§ 2.1051 Measurements required: Spurious emissions at antenna terminals: The radio frequency voltage or powers generated within the equipment and appearing on a spurious frequency shall be checked at the equipment output terminals when properly loaded with a suitable artificial antenna. Curves or equivalent data shall show the magnitude of each harmonic and other spurious emission that can be detected when the equipment is operated under the conditions specified in § 2.1049 as appropriate. The magnitude of spurious emissions which are attenuated more than 20 dB below the permissible value need not be specified.

§ 22.917 Emission limitations for Broadband PCS equipment: The rules in this section govern the spectral characteristics of emissions in the Broadband Personal Communications Service.

§ 22.917 (a) Out of band emissions. The power of any emission outside of the authorized operating frequency ranges must be attenuated below the transmitting power (P) by a factor of at least $43 + 10 \log(P) dB$.

Test Procedures:

A modulated carrier generated by the signal generator carrier was connected to either the Uplink or Downlink RF port at a maximum level as determined by the OEM A spectrum analyzer was connected to either the Uplink or Downlink port depending on the circuitry being measured. The spectrum analyzer was set to 1MHz RBW and 3MHz VBW. The spectrum was investigated from 30MHz to the 10th harmonic of the carrier.


The inter-modulation requirements were performed in a similar manner as described above. The spectrum analyzer was set to 100 KHz RBW and 300 KHz VBW. Two modulated carriers were injected into the EUT. One carrier was set at the band edge of either the Uplink or Downlink band and the other at carrier set at 6MHz deviation from the first carrier. The in band spurious emissions were investigated.

Test Results: The EUT complies with the requirements of this section. There were no detectable spurious






Plot 13. AMPS Downlink Low CH Conducted Emissions 30 MHz - 10 GHz




Plot 14. AMPS Downlink Mid CH Conducted Emissions 30 MHz - 10 GHz




Plot 15. AMPS Downlink High CH Conducted Emissions 30 MHz – 10 GHz




Plot 16. AMPS UpLink Low CH Conducted Emissions 30 MHz - 10 GHz




Plot 17. AMPS Uplink Mid CH Conducted Emissions 30 MHz - 10 GHz




Plot 18. AMPS Uplink High CH Conducted Emissions 30 MHz - 10 GHz




Plot 19. CDMA Downlink Low CH Conducted Emissions 30 MHz - 10 GHz




Plot 20. CDMA Downlink Mid CH Conducted Emissions 30 MHz - 10 GHz




Plot 21. CDMA Downlink High CH Conducted Emissions 30 MHz - 10 GHz




Plot 22. CDMA UpLink Low CH Conducted Emissions 30 MHz - 10 GHz




Plot 23. CDMA Uplink Mid CH Conducted Emissions 30 MHz – 10 GHz




Plot 24. CDMA Uplink High CH Conducted Emissions 30 MHz – 10 GHz




Plot 25. TDMA Downlink Low CH Conducted Emissions 30 MHz – 10 GHz




Plot 26. TDMA Downlink Mid CH Conducted Emissions 30 MHz - 10 GHz



Plot 27. TDMA Downlink High CH Conducted Emissions 30 MHz - 10 GHz




Plot 28. TDMA UpLink Low CH Conducted Emissions 30 MHz – 10 GHz




Plot 29. TDMA Uplink Mid CH Conducted Emissions 30 MHz - 10 GHz




Plot 30. TDMA Uplink High CH Conducted Emissions 30 MHz – 10 GHz




Plot 31. AMPS Down Link Low End Intermodulation




Plot 32. AMPS Down Link High End Intermodulation




Plot 33. AMPS Uplink Low End Intermodulation




Plot 34. AMPS Uplink High End Intermodulation




Plot 35. CDMA Down Link Low End Intermodulation




Plot 36. CDMA Down Link High End Intermodulation




Plot 37. CDMA Uplink Low End Intermodulation




Plot 38. CDMA Uplink High End Intermodulation




Plot 39. TDMA Down Link Low End Intermodulation

Plot 41. TDMA Uplink Low End Intermodulation




Plot 42. TDMA Uplink High End Intermodulation



A. Certification Information

The following is extracted from Title 47 of the Code of Federal Regulations, Part 2, Subpart I — Marketing of Radio frequency devices:

§ 2.801 Radio-frequency device defined.

As used in this part, a radio-frequency device is any device which in its operation is capable of Emitting radio-frequency energy by radiation, conduction, or other means. Radio- frequency devices include, but are not limited to:

- (a) The various types of radio communication transmitting devices described throughout this chapter.
- (b) The incidental, unintentional and intentional radiators defined in Part 15 of this chapter.
- (c) The industrial, scientific, and medical equipment described in Part 18 of this chapter.
- (d) Any part or component thereof which in use emits radio-frequency energy by radiation, conduction, or other means.

§ 2.803 Marketing of radio frequency devices prior to equipment authorization.

- (a) Except as provided elsewhere in this chapter, no person shall sell or lease, or offer for sale or lease (including advertising for sale or lease), or import, ship or distribute for the purpose of selling or leasing or offering for sale or lease, any radio frequency device unless:
 - (1) In the case of a device subject to certification, such device has been authorized by the Commission in accordance with the rules in this chapter and is properly identified and labeled as required by §2.925 and other relevant sections in this chapter; or
 - (2) In the case of a device that is not required to have a grant of equipment authorization issued by the Commission, but which must comply with the specified technical standards prior to use, such device also complies with all applicable administrative (including verification of the equipment or authorization under a Declaration of Conformity, where required), technical, labeling and identification requirements specified in this chapter.
- (d) Notwithstanding the provisions of paragraph (a) of this section, the offer for sale solely to business, commercial, industrial, scientific or medical users (but not an offer for sale to other parties or to end users located in a residential environment) of a radio frequency device that is in the conceptual, developmental, design or preproduction stage is permitted prior to equipment authorization or, for devices not subject to the equipment authorization requirements, prior to a determination of compliance with the applicable technical requirements provided that the prospective buyer is advised in writing at the time of the offer for sale that the equipment is subject to the FCC rules and that the equipment will comply with the appropriate rules before delivery to the buyer or to centers of distribution.



- (e)(1) Notwithstanding the provisions of paragraph (a) of this section, prior to equipment authorization or determination of compliance with the applicable technical requirements any radio frequency device may be operated, but not marketed, for the following purposes and under the following conditions:
 - (i) Compliance testing;
 - (ii) Demonstrations at a trade show provided the notice contained in paragraph (c) of this section is displayed in a conspicuous location on, or immediately adjacent to, the device;
 - (iii) Demonstrations at an exhibition conducted at a business, commercial, industrial, scientific or medical location, but excluding locations in a residential environment, provided the notice contained in paragraphs (c) or (d) of this section, as appropriate, is displayed in a conspicuous location on, or immediately adjacent to, the device;
 - (iv) Evaluation of product performance and determination of customer acceptability, provided such operation takes place at the manufacturer's facilities during developmental, design or pre-production states; or
 - (v) Evaluation of product performance and determination of customer acceptability where customer acceptability of a radio frequency device cannot be determined at the manufacturer's facilities because of size or unique capability of the device, provided the device is operated at a business, commercial, industrial, scientific or medical user's site, but not at a residential site, during the development, design or pre-production stages.
- (e)(2) For the purpose of paragraphs (e)(1)(iv) and (e)(1)(v) of this section, the term *manufacturer's facilities* includes the facilities of the party responsible for compliance with the regulations and the manufacturer's premises, as well as the facilities of other entities working under the authorization of the responsible party in connection with the development and manufacture, but not the marketing, of the equipment.
- (f) For radio frequency devices subject to verification and sold solely to business, commercial, industrial, scientific and medical users (excluding products sold to other parties or for operation in a residential environment), parties responsible for verification of the devices shall have the option of ensuring compliance with the applicable technical specifications of this chapter at each end user's location after installation, provided that the purchase or lease agreement includes a proviso that such a determination of compliance be made and is the responsibility of the party responsible for verification of the equipment.

The following is extracted from Title 47 of the Code of Federal Regulations, Part 2, Subpart J — Equipment Authorization Procedures:

§ 2.901 Basis and Purpose

- (a) In order to carry out its responsibilities under the Communications Act and the various treaties and international regulations, and in order to promote efficient use of the radio spectrum, the Commission has developed technical standards for radio frequency equipment and parts or components thereof. The technical standards applicable to individual types of equipment are found in that part of the rules governing the service wherein the equipment is to be operated. In addition to the technical standards provided, the rules governing the service may require that such equipment be verified by the manufacturer or importer, be authorized under a Declaration of Conformity, or receive an equipment authorization from the Commission by one of the following procedures: certification or registration.
- (b) The following sections describe the verification procedure, the procedure for a Declaration of Conformity, and the procedures to be followed in obtaining certification from the Commission and the conditions attendant to such a grant.

§ 2.907 Certification.

(a) Certification is an equipment authorization issued by the Commission, based on representation and test data submitted by the applicant.

(b) Certification attaches to all units subsequently marketed by the grantee which are identical (see Section 2.908) to the sample tested except for permissive changes or other variations authorized by the Commission pursuant to Section 2.1043.

¹ In this case, the equipment is subject to the rules of Part 15. More specifically, the equipment falls under Subpart B (of Part 15), which deals with unintentional radiators.

§ 2.948 Description of measurement facilities.

- (a) Each party making measurements of equipment that is subject to an equipment authorization under Part 15 or Part 18 of this chapter, regardless of whether the measurements are filed with the Commission or kept on file by the party responsible for compliance of equipment marketed within the U.S. or its possessions, shall compile a description of the measurement facilities employed.
 - (1) If the measured equipment is subject to the verification procedure, the description of the measurement facilities shall be retained by the party responsible for verification of the equipment.
 - (i) If the equipment is verified through measurements performed by an independent laboratory, it is acceptable for the party responsible for verification of the equipment to rely upon the description of the measurement facilities retained by or placed on file with the Commission by that laboratory. In this situation, the party responsible for the verification of the equipment is not required to retain a duplicate copy of the description of the measurement facilities.
 - (ii) If the equipment is verified based on measurements performed at the installation site of the equipment, no specific site calibration data is required. It is acceptable to retain the description of the measurement facilities at the site at which the measurements were performed.
 - (2) If the equipment is to be authorized by the Commission under the certification procedure, the description of the measurement facilities shall be filed with the Commission's Laboratory in Columbia, Maryland. The data describing the measurement facilities need only be filed once but must be updated as changes are made to the measurement facilities or as otherwise described in this section. At least every three years, the organization responsible for filing the data with the Commission shall certify that the data on file is current.

Label and User's Manual Information

The following is extracted from Title 47 of the Code of Federal Regulations, Part 15, Subpart A — General:

§ 15.19 Labeling requirements.

- (a) In addition to the requirements in Part 2 of this chapter, a device subject to certification or verification shall be labeled as follows:
 - (1) Receivers associated with the operation of a licensed radio service, e.g., FM broadcast under Part 73 of this chapter, land mobile operation under Part 90, etc., shall bear the following statement in a conspicuous location on the device:
 - This device complies with Part 15 of the FCC Rules. Operation is subject to the condition that this device does not cause harmful interference.
 - (2) A stand-alone cable input selector switch, shall bear the following statement in a conspicuous location on the device:
 - This device is verified to comply with Part 15 of the FCC Rules for use with cable television service.
 - (3) All other devices shall bear the following statement in a conspicuous location on the device:
 - This device complies with Part 15 of the FCC Rules. Operation is subject to the following two conditions: (1) This device may not cause harmful interference, and (2) this device must accept any interference received, including interference that may cause undesired operation.
 - (4) Where a device is constructed in two or more sections connected by wires and marketed together, the statement specified under paragraph (a) of this section is required to be affixed only to the main control unit.
 - (5) When the device is so small or for such use that it is not practicable to place the statement specified under paragraph (a) of this section on it, the information required by this paragraph shall be placed in a prominent location in the instruction manual or pamphlet supplied to the user or, alternatively, shall be placed on the container in which the device is marketed. However, the FCC identifier or the unique identifier, as appropriate, must be displayed on the device.

§ 15.21 Information to user.

The users manual or instruction manual for an intentional or unintentional radiator shall caution the user that changes or modifications not expressly approved by the party responsible for compliance could void the user's authority to operate the equipment.



Verification & User's Manual Information

The following is extracted from Title 47 of the Code of Federal Regulations, Part 15, Subpart B — Unintentional Radiators:

§ 15.105 Information to the user.

(a) For a Class B digital device or peripheral, the instructions furnished the user shall include the following or similar statement, placed in a prominent location in the text of the manual:

Note: This equipment has been tested and found to comply with the limits for a Class B digital device, pursuant to Part 15 of the FCC Rules. These limits are designed to provide reasonable protection against harmful interference when the equipment is operated in a residential environment. This equipment generates, uses, and can radiate radio frequency energy and, if not installed and used in accordance with the instruction manual, may cause harmful interference to radio communications. However, there is no guarantee that interference will not occur in a particular installation. If this equipment does cause harmful interference to radio or television reception, which can be determined by turning the equipment off and on, the user is encouraged to try to correct the interference by one or more of the following measures:

- Reorient or relocate the receiving antenna.
- Increase the separation between the equipment and receiver.
- Connect the equipment into an outlet on a circuit different from that to which the receiver is connected.
- Consult the dealer or an experienced radio/TV technician for help.
