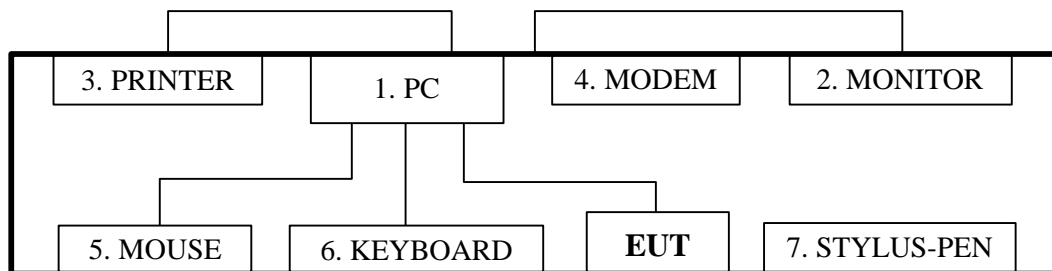

2. PC runs a test program to enable all functions.
3. PC sends "H" messages to modem.
4. PC sends "H" messages to printer, and the printer prints them on paper.
5. Repeat steps 3-5.

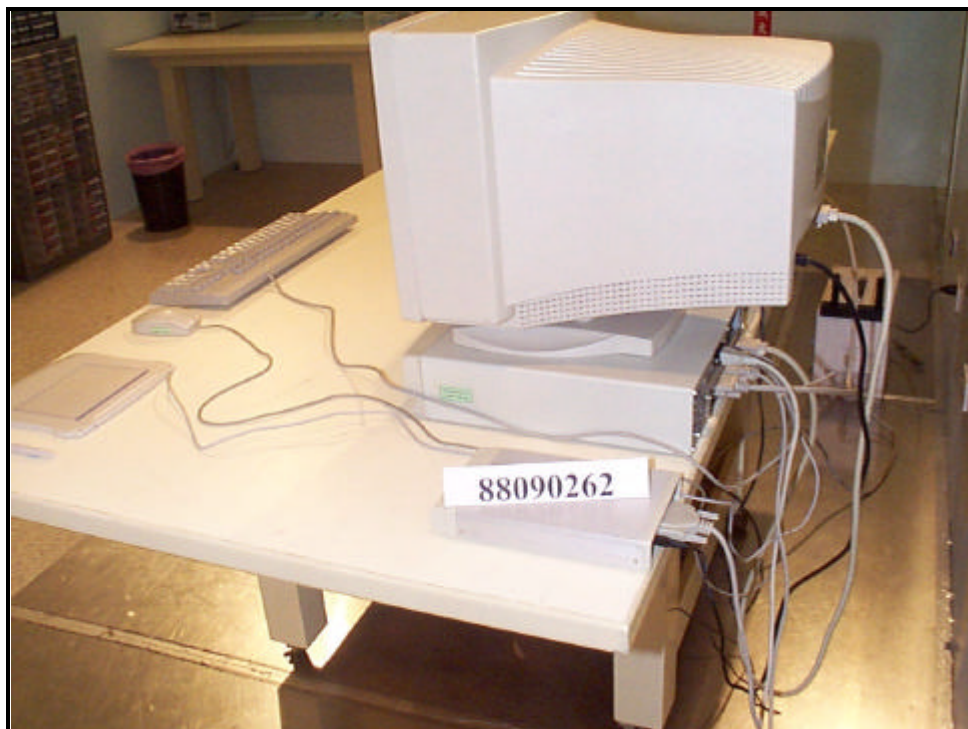
