# EXHIBIT 1 GENERAL DESCRIPTION

#### 1.0 **General Description**

#### 1.1 Product Description

The Equipment Under Test (EUT) is a dongle unit of Wireless Instant Messenger (900MHz Transceiver) operating at 906-915MHz. The receiver operating frequency at 906-915MHz. The EUT is powered by 5Vdc from USB port of computer. During normal use, the dongle unit transmit/receive message to the corresponding transceiver (Handheld Unit). The dongle unit will be received the message through USB cable transfer to the computer by applicable software.

Antenna Type: External, Integral

For electronic filing, the brief circuit description is saved with filename: descri.pdf.

#### 1.2 Related Submittal(s) Grants

This is an application for certification of a transmitter portion of 900MHz Transceiver and Computer Peripheral. The receiver portion of this transceiver was subjected to FCC Part 15 Verification Procedure.

The handheld unit, associated with this EUT, has FCC ID: NS634727-1-900 and has been filed at the same time.

#### 1.3 Test Methodology

Both AC mains line-conducted and radiated emission measurements were performed according to the procedures in ANSI C63.4 (2003). All measurements were performed in Open Area Test Sites. Preliminary scans were performed in the Open Area Test Sites only to determine worst case modes. For each scan, the procedure for maximizing emissions in Appendices D and E were followed. All Radiated tests were performed at an antenna to EUT distance of 3 meters, unless stated otherwise in the "Justification Section" of this Application.

## 1.4 Test Facility

The open area test site and conducted measurement facility used to collect the emission data is located at Garment Centre, 576 Castle Peak Road, Kowloon, Hong Kong. This test facility and site measurement data have been fully placed on file with the FCC.

# EXHIBIT 2 SYSTEM TEST CONFIGURATION

#### 2.0 **System Test Configuration**

#### 2.1 Justification

The system was configured for testing in a typical fashion (as a customer would normally use it), and in the confines as outlined in ANSI C63.4 (2003).

The EUT was powered from 5Vdc USB port of computer.

For maximizing emissions, the EUT was rotated through 360°, the antenna height was varied from 1 meter to 4 meters above the ground plane, and the antenna polarization was changed. This step by step procedure for maximizing emissions led to the data reported in Exhibit 3.0.

The unit was placed in the rear of the turntable.

The equipment under test (EUT) was configured for testing in a typical fashion (as a customer would normally use it). The EUT was placed on turntable, which enabled the engineer to maximize emissions through its placement in the three orthogonal axes. For simplicity of testing, the unit is under manufacturer test mode to transmit continuously.

The frequency range from 9kHz to 9.2GHz was searched for spurious emissions from the device. Only those emissions reported were detected. All other emissions were at least 20 dB below the applicable limits.

#### 2.2 EUT Exercising Software

There was no special software to exercise the device. The unit transmits the typical signal is under manufacturer test mode to transmit continuously.

#### 2.3 Special Accessories

There are no special accessories necessary for compliance of this product.

#### 2.4 Equipment Modification

Any modifications installed previous to testing by Manley Toys Limited will be incorporated in each production model sold/leased in the United States.

No modifications were installed by Intertek Testing Services Hong Kong Ltd.

#### 2.5 Measurement Uncertainty

When determining the test conclusion, the Measurement Uncertainty of test has been considered.

# EXHIBIT 3 EMISSION RESULTS

## 3.0 **Emission Results**

Data is included worst case configuration (the configuration which resulted in the highest emission levels). A sample calculation, configuration photographs and data tables of the emissions are included.

#### 3.1 Field Strength Calculation

The field strength is calculated by adding the reading on the Spectrum Analyzer to the factors associated with preamplifiers (if any), antennas, cables, pulse desensitization and average factors (when specified limit is in average and measurements are made with peak detectors). A sample calculation is included below.

$$FS = RA + AF + CF - AG + PD + AV$$

where  $FS = Field Strength in dB\mu V/m$ 

RA = Receiver Amplitude (including preamplifier) in dBµV

CF = Cable Attenuation Factor in dB

AF = Antenna Factor in dB

AG = Amplifier Gain in dB

PD = Pulse Desensitization in dB

AV = Average Factor in -dB

In the radiated emission table which follows, the reading shown on the data table may reflect the preamplifier gain. An example of the calculations, where the reading does not reflect the preamplifier gain, follows:

$$FS = RA + AF + CF - AG + PD + AV$$

Assume a receiver reading of 62.0 dBµV is obtained. The antenna factor of 7.4 dB and cable factor of 1.6 dB is added. The amplifier gain of 29 dB is subtracted. The pulse desensitization factor of the spectrum analyzer was 0 dB, and the resultant average factor was -10 dB. The net field strength for comparison to the appropriate emission limit is 32 dBµV/m. This value in dBµV/m was converted to its corresponding level in  $\mu$ V/m.

 $RA = 62.0 dB\mu V$ 

AF = 7.4 dB

CF = 1.6 dB

 $AG = 29.0 \, dB$ 

PD = 0 dB

AV = -10 dB

$$FS = 62 + 7.4 + 1.6 - 29 + 0 + (-10) = 32 dB\mu V/m$$

Level in  $\mu$ V/m = Common Antilogarithm [(32 dB $\mu$ V/m)/20] = 39.8  $\mu$ V/m

## 8.0 <u>Miscellaneous Information</u>

This miscellaneous information includes details of the measured bandwidth, the test procedure and calculation of factors such as pulse desensitization and averaging factor.

#### 8.1 Bandedge Plot

For electronic filing, the plot shows the fundamental emission when modulated is saved with filename: be.pdf. From the plot, the field strength of any emissions appearing between the band edges and up to 10 kHz above and below the band edges are attenuated at least 50dB below the level of the unmodulated carrier. It fulfil the requirement of 15.249(d).

Bandedge compliance is determined by applying marker-delta method, i.e (Bandedge Plot A).

Resultant field strength= Fundamental emissions - delta from the plot

 $= 82.0 dB\mu V/m - 41.46 dB$ 

=40.64dB $\mu$ V/m

The resultant field strength meets the general radiated emission limit in section 15.209, which does not exceed 46dBµV/m.

## 8.2 Discussion of Pulse Desensitization

The determination of pulse desensitivity was made in accordance with Hewlett Packard Application Note 150-2, *Spectrum Analysis ... Pulsed RF.* 

#### 8.3 Emissions Test Procedures

The following is a description of the test procedure used by Intertek Testing Services in the measurements of transmitters operating under Part 15, Subpart C rules.

The test set-up and procedures described below are designed to meet the requirements of ANSI C63.4 - 2003.

The transmitting equipment under test (EUT) is placed on a wooden turntable which is four feet in diameter and approximately one meter in height above the ground plane. During the radiated emissions test, the turntable is rotated and any cables leaving the EUT are manipulated to find the configuration resulting in maximum emissions. The EUT is adjusted through all three orthogonal axes to obtain maximum emission levels. The antenna height and polarization are varied during the testing to search for maximum signal levels. The height of the antenna is varied from one to four meters.

Detector function for radiated emissions is in peak mode. Average readings, when required, are taken by measuring the duty cycle of the equipment under test and subtracting the corresponding amount in dB from the measured peak readings. A detailed description for the calculation of the average factor can be found in Exhibit 8.3.

The frequency range scanned is from the lowest radio frequency signal generated in the device which is greater than 9 kHz to the tenth harmonic of the highest fundamental frequency or 40 GHz, whichever is lower. For line conducted emissions, the range scanned is 150 kHz to 30 MHz.

#### 8.3 Emissions Test Procedures (cont'd)

The EUT is warmed up for 15 minutes prior to the test.

AC power to the unit is varied from 85% to 115% nominal and variation in the fundamental emission field strength is recorded. If battery powered, a new, fully charged battery is used.

Conducted measurements are made as described in ANSI C63.4 - 2003.

The IF bandwidth used for measurement of radiated signal strength was 100 kHz or greater when frequency is below 1000 MHz. Where pulsed transmissions of short enough pulse duration warrant, a greater bandwidth is selected according to the recommendations of Hewlett Packard Application Note 150-2. A discussion of whether pulse desensitivity is applicable to this unit is included in this report (See Exhibit 8.2). Above 1000 MHz, a resolution bandwidth of 1 MHz is used.

Transmitter measurements are normally conducted at a measurement distance of three meters. However, to assure low enough noise floor in the forbidden bands and above 1 GHz, signals are acquired at a distance of one meter or less. All measurements are extrapolated to three meters using inverse scaling, unless otherwise reported. Measurements taken at a closer distance are so marked.
