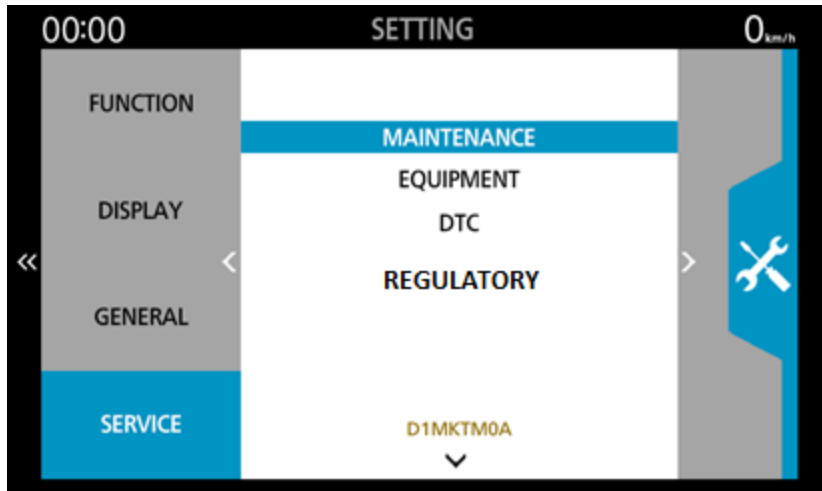
- 1) IGN ON
