


- 2.1 FOB KEY
- -.LF : Find and recognize FOB inside the vehicle or near the door handle through LF search
- -.IMMO: Determining the existence of a short-range FOB through IMMO communication when LF search is not recognized

-.RKE: Receiving RKE signal from a long distance outside the vehicle through RF communication



- 2.2 Immobilizer & Knob SW
- -.FOB KEY has TP for manual start through emergency authentication.
- -.Knob SW is a button to control engine START.
- -. It has a TP coil to take action in emergency situations.
