	Performed aggregate both leakage E-field and H-field at surrounding the device from all simultaneous transmitting coils.

Maximum E-field and H-field measurements were tested 10cm and 20cm from each side of the EUT. Along the side of the EUT to center of E-field probe and H-field probe were positioned at the location to search maximum field strength.


