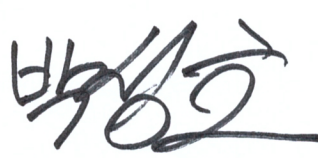
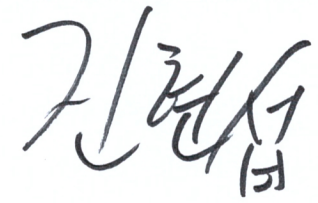

6. Antenna requirement

6.1. Regulation

According to §15.203, an intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device. The use of a permanently attached antenna or of an antenna that uses a unique coupling to the intentional radiator shall be considered sufficient to comply with the provisions of this Section. The manufacturer may design the unit so that a broken antenna can be replaced by the user, but the use of a standard antenna jack or electrical connector is prohibited.

7. Field strength of Fundamental

7.1. Regulation

According to § 15.109(a), Except as provided elsewhere in this Subpart, the emissions from an intentional radiator shall not exceed the field strength levels specified in the following table: 83

Where F is the frequency in MHz, the formulas for calculating the maximum permitted fundamental field strengths are as follows: for the band 130-174 MHz, $\mu\text{V}/\text{m}$ at 3 meters = $56.81818(F) - 6136.3636$; for the band 260-470 MHz, $\mu\text{V}/\text{m}$ at 3 meters = $41.6667(F) - 7083.3333$. The maximum permitted unwanted emission level is 20 dB below the maximum permitted fundamental level.

7.2. Test procedure

The method of measurement used to test this Unlicensed Wireless device is ANSI C63.10-2013.

- The EUT was placed on the top of a rotating table 0.8 meters above the ground at a 3 meter anechoic chamber test site. The table was rotated 360 degrees to determine the position of the highest radiation.
- During performing radiated emission below 1 GHz, the EUT was set 3 meters away from the interference receiving antenna, which was mounted on the top of a variable-height antenna tower. During performing radiated emission above 1 GHz, the EUT was set 3 meter away from the interference-receiving antenna.
- The antenna is a broadband antenna, and its height is varied from one meter to four meters above the ground to determine the maximum value of the field strength. Both horizontal and vertical polarizations of the antenna are set to make the measurement.
- For each suspected emission, the EUT was arranged to its worst case and then the antenna was tuned to heights from 1 meter to 4 meters and the table was turned from 0 degrees to 360 degrees to find the maximum reading.
- The test-receiver system was set to Peak Detect Function and Specified Bandwidth with Maximum Hold Mode.
- If the emission level of the EUT in peak mode was 10 dB lower than the limit specified, then testing could be stopped and the peak values of the EUT would be reported. Otherwise the emissions that did not have 10 dB margin would be re-tested one by one using peak, quasi-peak or average method as specified and then reported in a data sheet.
- It tested x,y and z – 3 axis each, mentioned only worst case data at this report. by measuring peak result and applying DCCF.

8.2. Test procedure

The method of measurement used to test this Unlicensed Wireless device is ANSI C63.10-2013.

- a. The EUT was placed on the top of a rotating table 0.8 meters above the ground at a 3 meter anechoic chamber test site. The table was rotated 360 degrees to determine the position of the highest radiation.
- b. During performing radiated emission below 1 GHz, the EUT was set 3 meters away from the interference receiving antenna, which was mounted on the top of a variable-height antenna tower. During performing radiated emission above 1 GHz, the EUT was set 3 meter away from the interference-receiving antenna.
- c. The antenna is a broadband antenna, and its height is varied from one meter to four meters above the ground to determine the maximum value of the field strength. Both horizontal and vertical polarizations of the antenna are set to make the measurement.
- d. For each suspected emission, the EUT was arranged to its worst case and then the antenna was tuned to heights from 1 meter to 4 meters and the table was turned from 0 degrees to 360 degrees to find the maximum reading.
- e. The test-receiver system was set to Peak Detect Function and Specified Bandwidth with Maximum Hold Mode.
- f. If the emission level of the EUT in peak mode was 10 dB lower than the limit specified, then testing could be stopped and the peak values of the EUT would be reported. Otherwise the emissions that did not have 10 dB margin would be re-tested one by one using peak, quasi-peak or average method as specified and then reported in a data sheet.
- g. It tested x,y and z – 3 axis each, mentioned only worst case data at this report.

Note

1. The resolution bandwidth and video bandwidth of test receiver/spectrum analyzer is 120 kHz for Peak detection (PK) and Quasi-peak detection (QP) at frequency below 1 GHz.
2. The resolution bandwidth and video bandwidth of test receiver/spectrum analyzer is 1 MHz for Peak detection and frequency above 1 GHz.
3. The resolution bandwidth of test receiver/spectrum analyzer is 1 MHz and the video bandwidth is 1/T for Average detection (AV) at frequency above 1 GHz. (where T = pulse width)
4. The radiated restricted band edge and Spurious radiated emissions average measurements use a duty cycle correction factor (DCCF).

9.3.Test procedures

Radiated emissions from the EUT were measured according to the dictates of ANSI C63.4:2003. In case of the air temperature of the test site is out of the range is 10 to 40°C before the testing proceeds the warm-up time of EUT maintain adequately.

The frequency spectrum from 30 MHz Below was investigated. Emission levels are not reported much lower than the limits by over 30 dB. All reading values are peak values.

The amplitude of spurious emissions from intentional radiators and emissions from unintentional radiators which are attenuated more than 20 dB below the permissible value need not be reported unless specifically required elsewhere in this part.

10. Bandwidth measurement

10.1. Regulation

The bandwidth of the emission shall be no wider than 0.25 % of the center frequency for devices operating above 70 MHz and below 900 MHz. Bandwidth is determined at the point 20 dB down from the modulated carrier.

10.2. Test procedure

The method of measurement used to test this Unlicensed Wireless device is ANSI C63.10-2013.

1. The transmitter output is connected to the spectrum analyzer.
2. The bandwidth of the fundamental frequency was measured with the spectrum analyzer using RBW= 2 kHz, VBW= 2 kHz and Span= 200 kHz.
3. The bandwidth of fundamental frequency was measured and recorded.

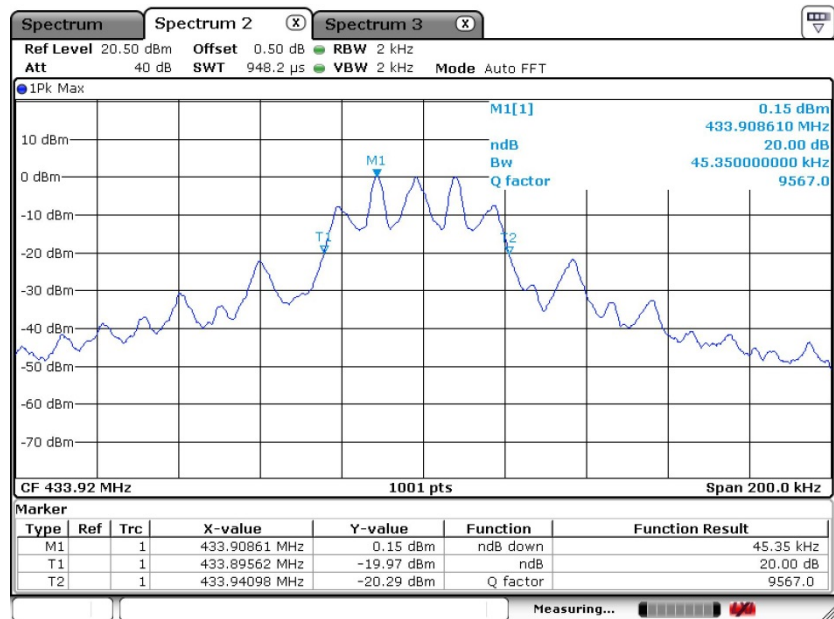

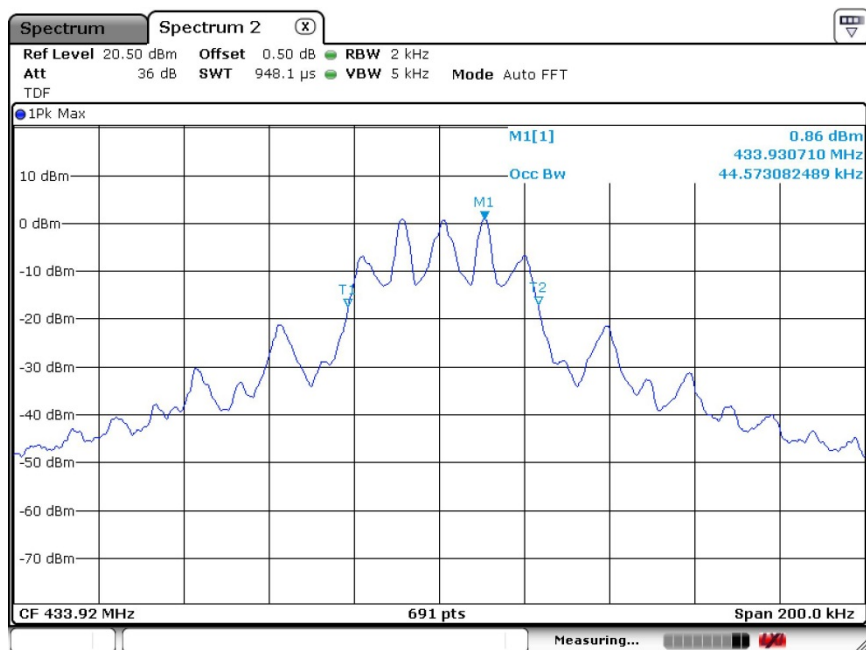

A manually operated transmitter shall employ a switch that will automatically deactivate the transmitter within not more than 5 seconds of being released.

11.2. Test procedure

The method of measurement used to test this Unlicensed Wireless device is ANSI C63.10-2013.

1. The transmitter output is connected to the spectrum analyzer.
2. The bandwidth of the fundamental frequency was measured with the spectrum analyzer using RBW= 3 MHz, VBW= 3 MHz, Span=0 Hz.
3. The bandwidth of fundamental frequency was measured and recorded.
