




#### 9kHz - 30MHz



### 30MHz - 1GHz





The system was configured to non-hopping mode, testing with the Single Channel.

Non-hopping mode: The system was configured to operate at a signal channel transmitting. The test software allows the configuration and operation at the worst-case duty and the highest transmit power.

The transmitter rate 1Mbps and 2Mbps mode are tested, only the worst case transmitter rate data mode is recorded in the report.



### 9 Technical Requirement

#### 9.1 Conducted Emission

#### **Test Method**

- 1. The EUT was placed 0.4 meter from the conducting wall of the shielding room was kept at least 80 centimeters from any other grounded conducting surface.
- 2. Connect EUT to the power mains through a line impedance stabilization network (LISN).
- 3. All the support units are connecting to the other LISN.
- 4. The LISN provides 50 ohm coupling impedance for the measuring instrument.
- 5. Both sides of AC line were checked for maximum conducted interference.
- 6. The frequency range from 150 kHz to 30 MHz was searched.
- 7. Set the test-receiver system to Peak Detect Function and specified bandwidth (IF Bandwidth = 9kHz) with Maximum Hold Mode. Then measurement is also conducted by Average Detector and Quasi-Peak Detector Function respectively.





### 9.2 20 dB Bandwidth

#### **Test Method**

- 1. The RF output of EUT was connected to the spectrum analyzer. The path loss was compensated to the results for each measurement.
- 2. Set to the maximum power setting, the instrument center frequency is set to the nominal EUT channel center frequency enable the EUT transmit continuously.
- Use the following spectrum analyzer settings:
   RBW=100KHz, VBW≥3RBW, Sweep = auto, Detector function = peak, Trace = max hold
- 4. Use the automatic bandwidth measurement capability of an instrument, use the X dB bandwidth mode with X set to 20 dB.
- 5. Allow the trace to stabilize, record the 6 dB Bandwidth value.



### Test Method of 99% Bandwidth

- 1. Set center frequency to the nominal EUT channel center frequency
- Set span = 1.5 times to 5.0 times the OBW. Set RBW = 1 % to 5 % of the OBW Set VBW ≥ 3 RBW Trace mode = max hold. Sweep = auto couple. Allow the trace to stabilize.
- 3. Use the 99 % power bandwidth function of the instrument.
- 4. Record the results in the test report.



### 9.4 Radiated Emissions

#### **Test Method**

- 1. The EUT was place on a turn table which is 1.5m above ground plane for above 1GHz and 0.8m above ground for below 1GHz at 3 meter chamber room for test. The table was rotated 360 degrees to determine the position of the highest radiation.
- 2. The EUT was set 3 meters away from the interference receiving antenna, which was mounted on the top of a variable height antenna tower.
- 3. The height of antenna is varied from one meter to four meters above the ground to determine the maximum value of the field strength. Both horizontal and vertical polarizations of the antenna are set to make the measurement.
- 4. For each suspected emission, the EUT was arranged to its worst case and then the antenna was tuned to heights from 1 meter to 4 meters and the rotatable table was turned from 0 degrees to 360 degrees to find the maximum reading.
- 5. Use the following spectrum analyzer settings According to C63.10:

Procedure for Unwanted Emissions Measurements Below 1000 MHz Span = wide enough to capture the peak level of the in-band emission and all spurious RBW = 100 KHz to 120KHz, VBW≥RBW for peak measurement, Sweep = auto, Detector function = peak, Trace = max hold.

For Peak unwanted emissions Above 1GHz:

Span = wide enough to capture the peak level of the in-band emission and all spurious RBW = 1MHz, VBW≥RBW for peak measurement, Sweep = auto, Detector function = peak, Trace = max hold.

Procedures for average unwanted emissions measurements above 1000 MHz

- a) RBW = 1MHz.
- b) VBW \  $[3 \times RBW]$ .
- c) Detector = RMS (power averaging), if [span / (# of points in sweep)] \ RBW / 2. Satisfying this condition can require increasing the number of points in the sweep or reducing the span. If the condition is not satisfied, then the detector mode shall be set to peak.
- d) Averaging type = power (i.e., rms) (As an alternative, the detector and averaging type may be set for linear voltage averaging. Some instruments require linear display mode to use linear voltage averaging. Log or dB averaging shall not be used.)
- e) Sweep time = auto.
- f) Perform a trace average of at least 100 traces if the transmission is continuous. If the transmission is not continuous, then the number of traces shall be increased by a factor of 1 / D, where D is the duty cycle. For example, with 50% duty cycle, at least 200 traces shall be averaged. (If a specific emission is demonstrated to be continuous—i.e., 100% duty cycle—then rather than turning ON and OFF with the transmit cycle, at least 100 traces shall be averaged.)
- g) If tests are performed with the EUT transmitting at a duty cycle less than 98%, then a correction factor shall be added to the measurement results prior to comparing with the emission limit, to compute the emission level that would have been measured had the test been performed at 100% duty cycle. The correction factor is computed as follows:



- 1) If power averaging (rms) mode was used in the preceding step e), then the correction factor is [10 log (1 / D)], where D is the duty cycle. For example, if the transmit duty cycle was 50%, then 3 dB shall be added to the measured emission levels.
- 2) If linear voltage averaging mode was used in the preceding step e), then the correction factor is [20 log (1 / D)], where D is the duty cycle. For example, if the transmit duty cycle was 50%, then 6 dB shall be added to the measured emission levels.
- 3) If a specific emission is demonstrated to be continuous (100% duty cycle) rather than turning ON and OFF with the transmit cycle, then no duty cycle correction is required for that emission(AV) at frequency above 1GHz.

#### Limit

According to §15.249 (a) & RSS-210 B.10, the field strength of emissions from intentional radiators operated within these frequency bands shall comply with the following:

According to §15.249 (c) & RSS-GEN 8.9, Field strength limits are specified at 3 meters distance. According to §15.249 (d) & RSS-GEN, Emissions radiated outside of the specified frequency bands, except for harmonics, shall be attenuated by at least 50 dB below the level of the fundamental or to the general radiated emission limits in §15.209 & RSS-GEN 8.9, whichever is the lesser attenuation.

According to §15.205 Unwanted emissions falling into restricted bands in §15.205 (a) & RSS-GEN 8.10 shall comply with the limits specified in §15.209 & RSS-GEN 8.9.


### Spurious radiated emissions for transmitter
