# **Product Description for Equipment under Test (EUT)**

The SWAGTEK's product, model number: LOGIC F1 (FCC ID: O55184616) in this report is a 1.77 inch Flip Feature Phone, which was measured approximately: 92.3 mm (L) \* 46.5 mm (W) \* 15.8 mm (H), rated with input voltage: DC 3.7 V battery or DC 5.0V from adapter. The highest operational frequency is 260 MHz.

Model LOGIC F1 was selected for fully testing, the detailed information can be referred to the attached declaration which was stated and guaranteed by the applicant.

#### **Test Methodology**

All measurements contained in this report were conducted with ANSI C63.4-2014, American National Standard for Methods of Measurement of Radio-Noise Emissions from Low-Voltage Electrical and Electronic Equipment in the range of 9 kHz to 40 GHz.

All emissions measurement was performed at Bay Area Compliance Laboratories Corp. (Kunshan). The radiated testing was performed at an antenna-to-EUT distance of 3 meters.





The measurement procedure of EUT setup is according with per ANSI C63.4-2014. The related limit was specified in FCC Part 15.107 Class B.

The spacing between the peripherals was 10 cm.

#### **EMI Test Receiver Setup**

The EMI test receiver was set to investigate the spectrum from 150 kHz to 30 MHz.

During the conducted emission test, the EMI test receiver was set with the following configurations:

The Corrected factor is calculated by adding LISN/ISN VDF (Voltage Division Factor), Cable Loss and Transient Limiter Attenuation. The basic equation is as follows:



# AC 120V/60 Hz, Line







#### **EMI Test Receiver Setup**

The system was investigated from 30 MHz to 12.4 GHz.

During the radiated emission test, the EMI test receiver was set with the following configurations:

#### **Test Procedure**

Maximizing procedure was performed on the highest emissions to ensure that the EUT complied with all installation combinations.

All data was recorded in the Quasi-peak detector mode from 30 MHz to 1 GHz and PK and average detector modes for frequencies above 1 GHz.

# **Corrected Amplitude & Margin Calculation**

The Corrected Amplitude is calculated by adding the Antenna Factor and Cable Loss, and subtracting the Amplifier Gain from the Meter Reading. The basic equation is as follows:

Corrected Amplitude = Meter Reading + Antenna Factor + Cable Loss - Amplifier Gain

The "Margin" column of the following data tables indicates the degree of compliance with the applicable limit. For example, a margin of 7 dB means the emission is 7 dB below the limit. The equation for margin calculation is as follows:

Margin = Limit – Corrected Amplitude
