Product Description for Equipment under Test (EUT)

The SWAGTEK's product, model number: LOGIC Z2 (FCC ID: O55201617) or the "EUT" in this report was a LOGIC, which was measured approximately: $11.0 \text{ cm} (L) \times 4.6 \text{ cm} (W) \times 1.2 \text{ cm} (H)$, rated with input voltage: DC 3.7V rechargeable Li-ion battery or DC 5.0V from adapter. The highest operating frequency is 2480MHz.

Notes: This series products model: iSWAG Selfie, UNONU U6 and LOGIC Z2 are identical; they have the identical schematics, only named differently. Model LOGIC Z2 was selected for fully testing, the detailed information can be referred to the declaration which was stated and guaranteed by the applicant.

Objective

Test Methodology

All measurements contained in this report were conducted with ANSI C63.4-2014, American National Standard for Methods of Measurement of Radio-Noise Emissions from Low-Voltage Electrical and Electronic Equipment in the range of 9 kHz to 40 GHz.

All emissions measurement was performed at Bay Area Compliance Laboratories Corp. (Kunshan). The radiated testing was performed at an antenna-to-EUT distance of 3 meters.





The measurement procedure of EUT setup is according with per ANSI C63.4-2014. The related limit was specified in FCC Part 15.107 Class B.

The spacing between the peripherals was 10 cm.

The EMI test receiver was set to investigate the spectrum from 150 kHz to 30 MHz.

Test Procedure

During the conducted emission test, the adaptor of PC was connected to the LISN.

Maximizing procedure was performed on the six (6) highest emissions of the EUT.

All data was recorded in the Quasi-peak and average detection mode.

Corrected Factor & Margin Calculation

The Corrected factor is calculated by adding LISN/ISN VDF (Voltage Division Factor), Cable Loss and Transient Limiter Attenuation. The basic equation is as follows:

Correction Factor = LISN VDF + Cable Loss + Transient Limiter Attenuation









The radiated emission tests were performed in the 3 meters chamber test site, using the setup accordance with the ANSI C63.4-2014. The specification used was the FCC Part 15.109 Class B limits.

The external I/O cables were draped along the test table and formed a bundle 30 to 40 cm long in the middle.

The spacing between the peripherals was 10 cm.

Test Procedure

Maximizing procedure was performed on the highest emissions to ensure that the EUT complied with all installation combinations.

All data was recorded in the Quasi-peak detector mode from 30 MHz to 1 GHz and PK and average detector modes for frequencies above 1 GHz.

Corrected Amplitude & Margin Calculation

The Corrected Amplitude is calculated by adding the Antenna Factor and Cable Loss, and subtracting the Amplifier Gain from the Meter Reading. The basic equation is as follows:

Corrected Amplitude = Meter Reading + Antenna Factor + Cable Loss - Amplifier Gain

The "Margin" column of the following data tables indicates the degree of compliance with the applicable limit. For example, a margin of 7 dB means the emission is 7 dB below the limit. The equation for margin calculation is as follows:

Margin = Limit – Corrected Amplitude
