The EUT has been associated with peripherals pursuant to ANSI C63.4-2003 and ANSI C63.10-2009 and configuration operated in a manner tended to maximize its emission characteristics in a typical application. Frequency range investigated: conduction (150 KHz to 30 MHz), radiation (9 KHz to the 10th harmonic of the highest fundamental frequency or to 40 GHz, whichever is lower). Pre-scanned tests, X, Y, Z in three orthogonal panels to determine the final configuration (Z plane as worst plane) from all possible combinations.
- b. AC power line Conducted Emission was tested under maximum output power.

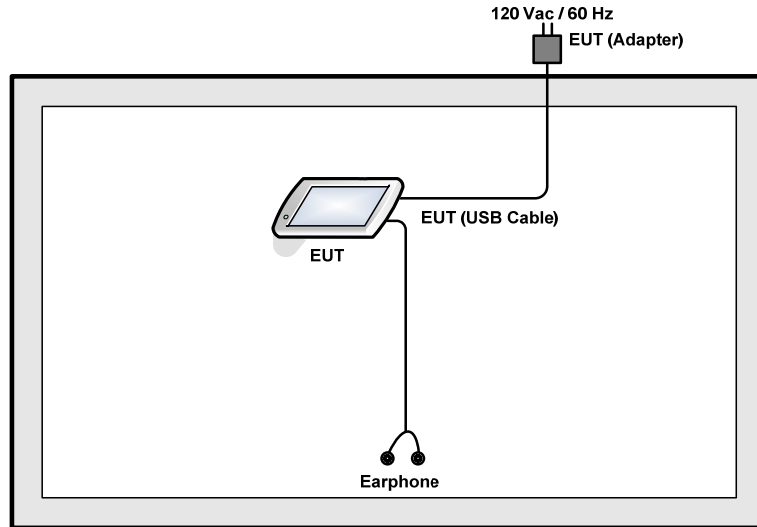

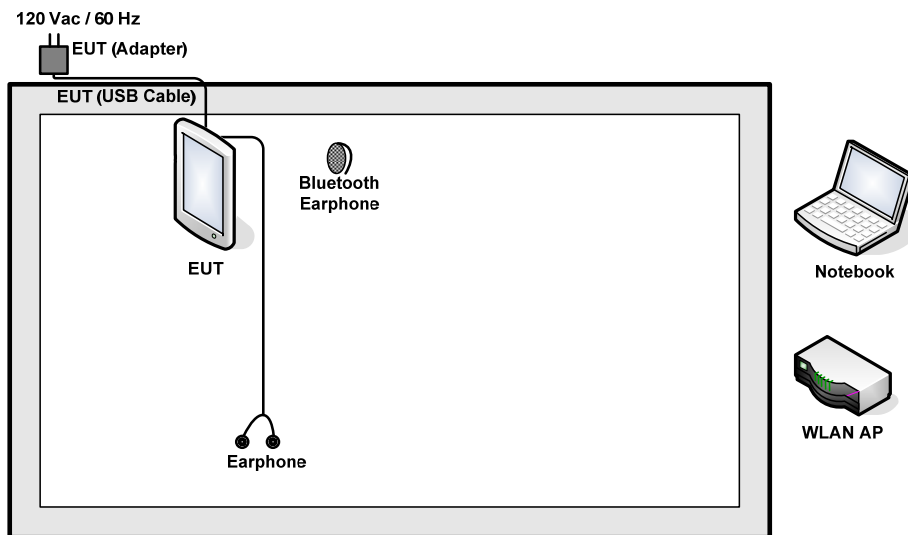


## 2.3 Connection Diagram of Test System

## 2.5 Description of RF Function Operation Test Setup

For Bluetooth function, turn on “Enter Engineer” software on the EUT directly. Then, the EUT will get into the engineering modes to contact with Bluetooth base station for continuous transmitting and receiving signals.



## **2.6 Measurement Results Explanation Example**

**For conducted test items:**

The offset level is set in the spectrum analyzer to compensate the RF cable loss and 10dB attenuator between EUT conducted output port and spectrum analyzer. With the offset compensation, the spectrum analyzer reading level is exactly the EUT RF output level.

The spectrum analyzer offset is derived from RF cable loss and 10dB attenuator factor.

*Offset = RF cable loss + attenuator factor.*

Following table shows an offset computation example with cable loss 5.60 dB.

Example :

$$\begin{aligned} \text{Offset(dB)} &= \text{RF cable loss(dB)} + \text{attenuator factor(dB)} \\ &= 5.60 + 10 = 15.60 \text{ (dB)} \end{aligned}$$

#### 3.1 6dB Bandwidth Measurement

##### 3.1.1 Limit of 6dB Bandwidth

The minimum 6 dB bandwidth shall be at least 500 KHz.

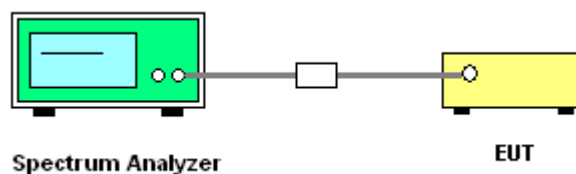

##### 3.1.3 Test Procedures

1. The testing follows FCC KDB Publication No. 558074 D01 DTS Meas. Guidance v02.
2. The RF output of EUT was connected to the spectrum analyzer by RF cable and attenuator. The path loss was compensated to the results for each measurement.
3. Set to the maximum power setting and enable the EUT transmit continuously.
4. Make the measurement with the spectrum analyzer's resolution bandwidth (RBW) = 1-5% of DTS BW, not to exceed 100 KHz. Set the Video bandwidth (VBW) = 3 xRBW. In order to make an accurate measurement. The 6 dB bandwidth must be greater than 500 KHz.
5. Measure and record the results in the test report.

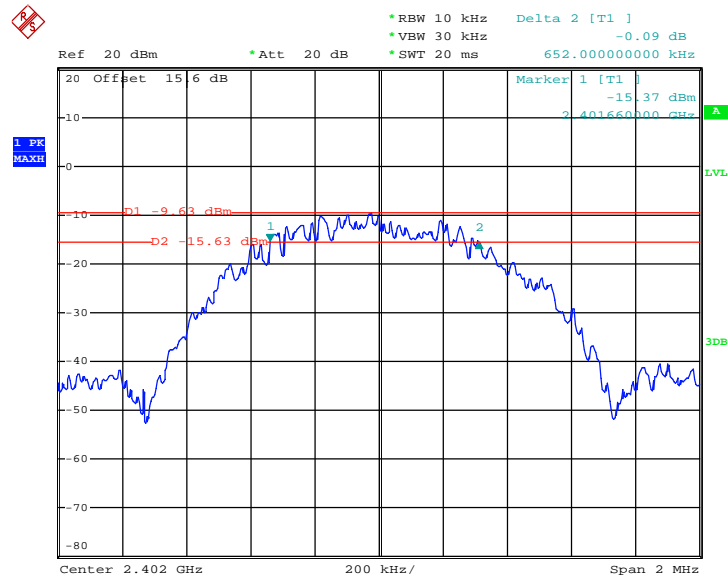

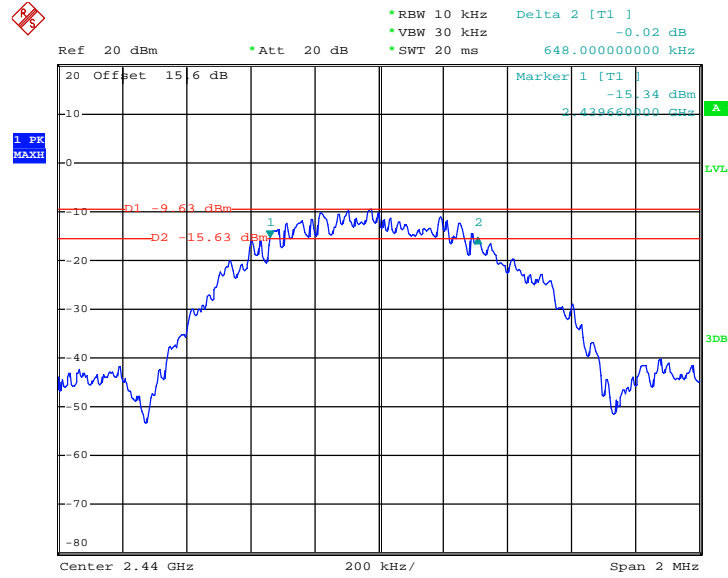
6 dB Bandwidth Plot on Channel 00

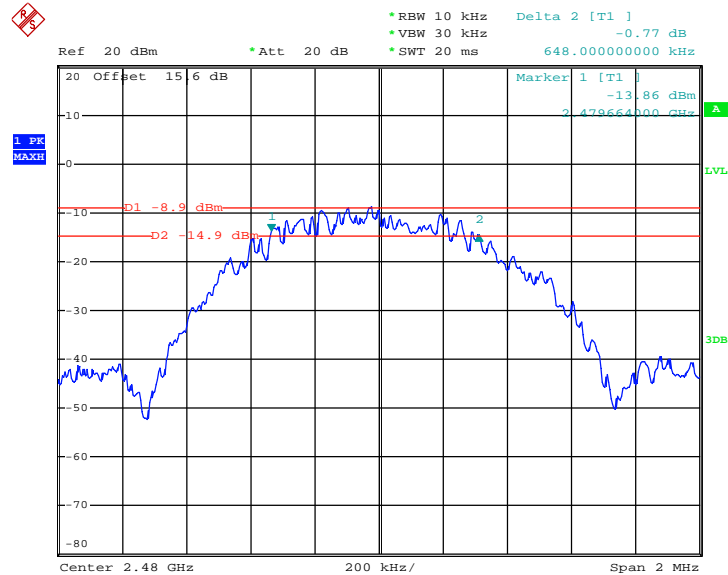


6 dB Bandwidth Plot on Channel 19

## 3.2 Peak Output Power Measurement

### 3.2.1 Limit of Peak Output Power

For systems using digital modulation in the 2400-2483.5MHz, the limit for peak output power is 30dBm. If transmitting antenna of directional gain greater than 6dBi is used, the peak output power from the intentional radiator shall be reduced below the above stated value by the amount in dB that the directional gain of the antenna exceeds 6 dBi. In case of point-to-point operation, the limit has to be reduced by 1dB for every 3dB that the directional gain of the antenna exceeds 6dBi.

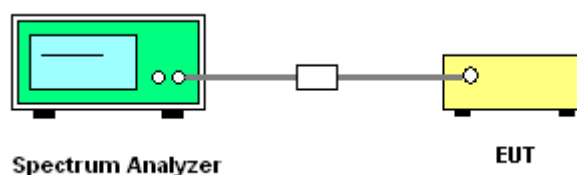

2. The RF output of EUT was connected to the spectrum analyzer by RF cable and attenuator. The path loss was compensated to the results for each measurement.
3. Set to the maximum power setting and enable the EUT transmit continuously.
4. Measure the conducted output power and record the results in the test report.

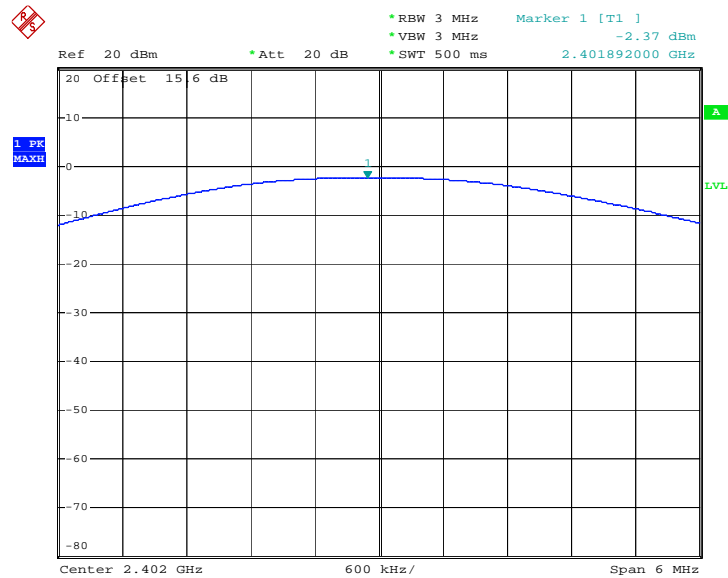

Peak Output Power Plot on Channel 00

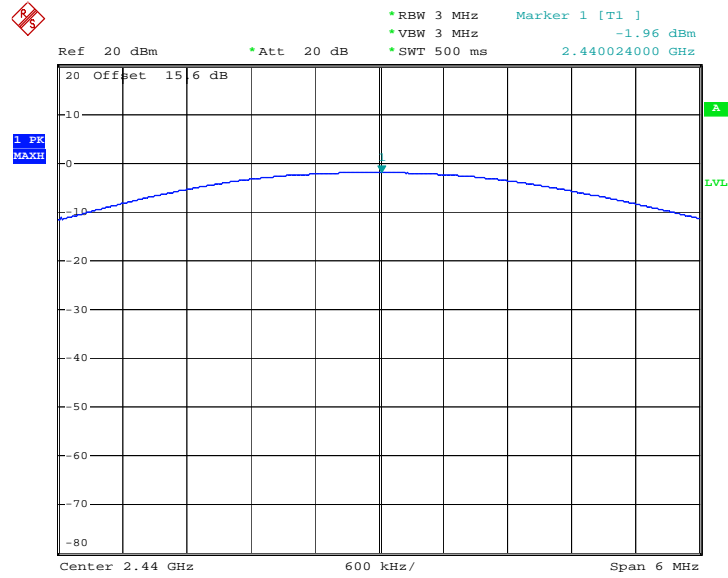

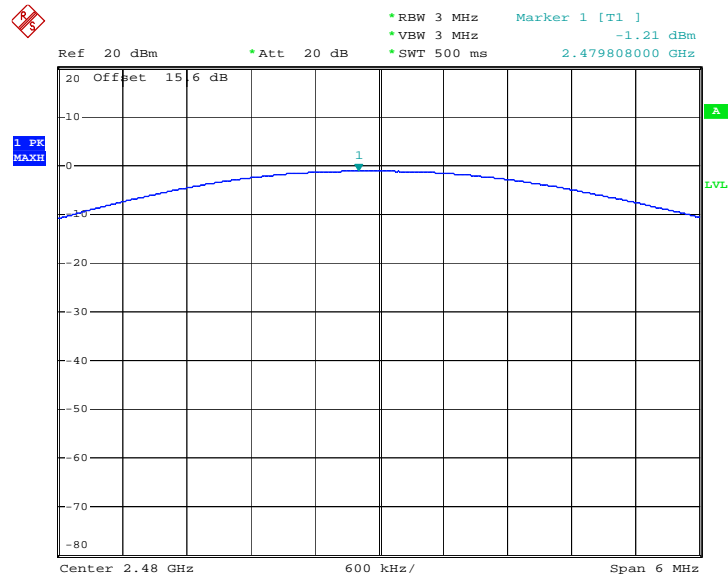


### Peak Output Power Plot on Channel 19

### 3.3 Power Spectral Density Measurement

#### 3.3.1 Limit of Power Spectral Density

The peak power spectral density shall not be greater than 8dBm in any 3KHz band at any time interval of continuous transmission.

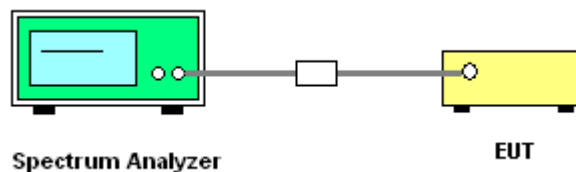

#### 3.3.3 Test Procedures

1. The testing follows Measurement Procedure 9.1 Option 1 of FCC KDB Publication No. 558074 D01 DTS Meas. Guidance v02
2. The RF output of EUT was connected to the spectrum analyzer by RF cable and attenuator. The path loss was compensated to the results for each measurement.
3. Set to the maximum power setting and enable the EUT transmit continuously.
4. Make the measurement with the spectrum analyzer's resolution bandwidth (RBW) = 3 kHz. Video bandwidth VBW = 10 kHz In order to make an accurate measurement, set the span to 1.5 times DTS Channel Bandwidth. (6dB BW)
5. Detector = peak, Sweep time = auto couple, Trace mode = max hold, Allow trace to fully stabilize. Use the peak marker function to determine the maximum power level.
6. Measure and record the results in the test report.
7. The Measured power density (dBm)/ 100KHz is a reference level and used as 20dBc down limit line for Conducted Band Edges and Conducted Spurious Emission.

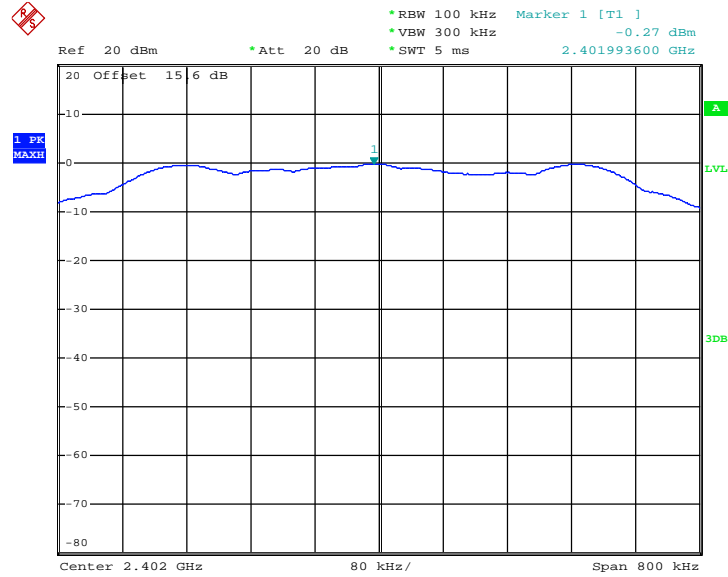

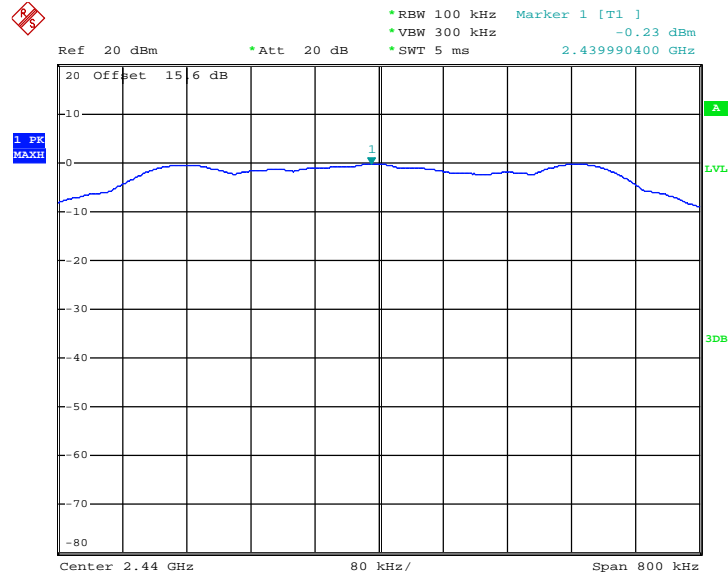
PSD 100kHz Plot on Channel 00

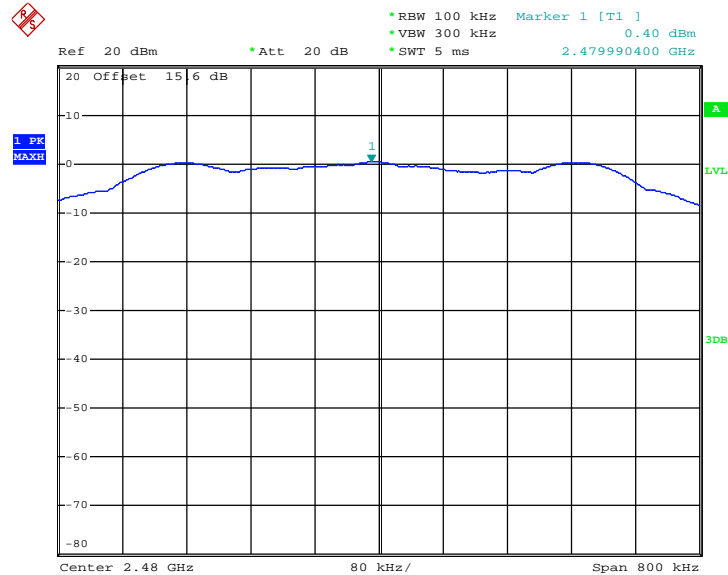


PSD 100kHz Plot on Channel 19

PSD 100kHz Plot on Channel 39

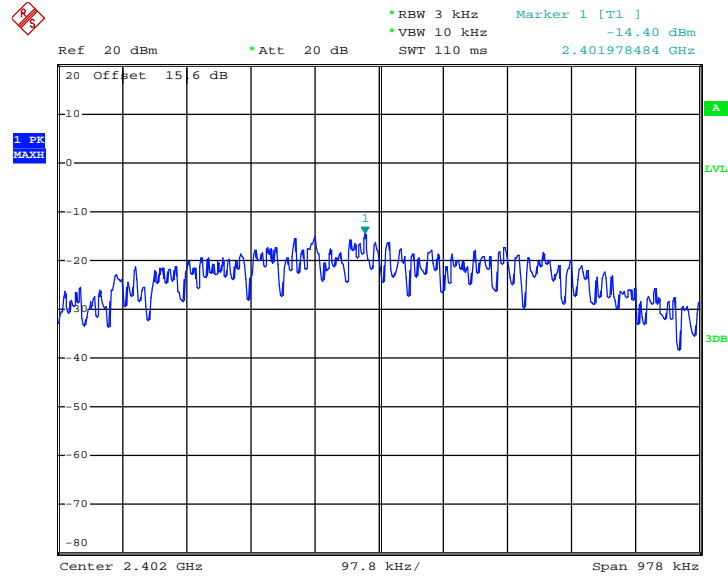

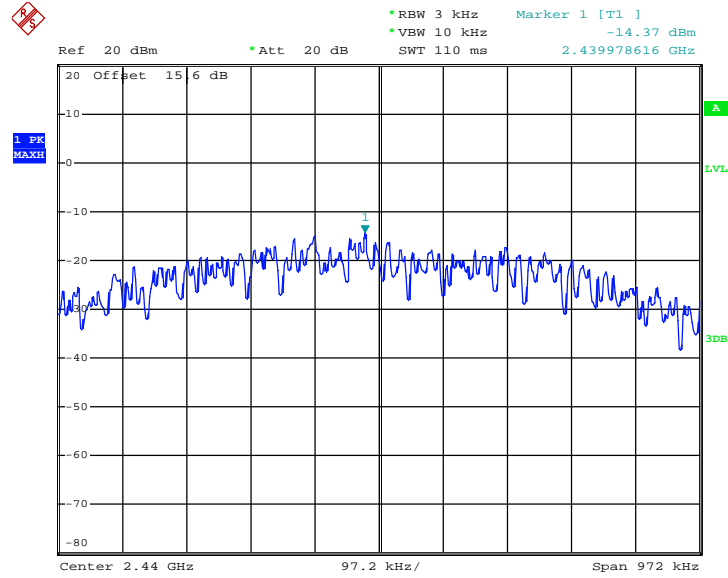
PSD 3kHz Plot on Channel 00

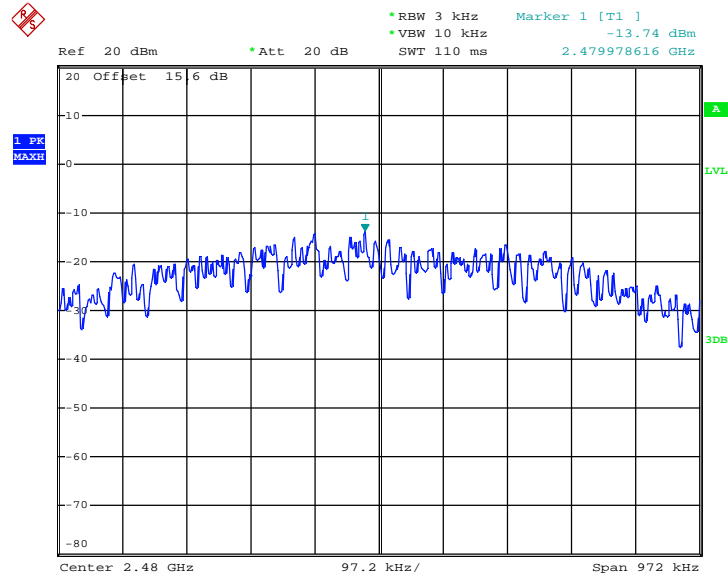


PSD 3kHz Plot on Channel 19

#### 3.4.1 Limit of Conducted Band Edges and Spurious Emission

All harmonics/spurious must be at least 20 dB down from the highest emission level within the authorized band.

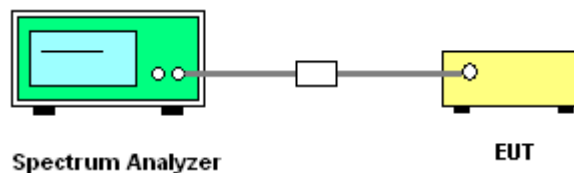

#### 3.4.3 Test Procedure

1. The testing follows FCC KDB Publication No. 558074 D01 DTS Meas. Guidance v02.
2. The RF output of EUT was connected to the spectrum analyzer by RF cable and attenuator. The path loss was compensated to the results for each measurement.
3. Set to the maximum power setting and enable the EUT transmit continuously.
4. Set RBW = 100 KHz, VBW=300 KHz, Peak Detector. Unwanted Emissions measured in any 100 kHz bandwidth outside of the authorized frequency band shall be attenuated by at least 20 dB relative to the maximum in-band peak PSD level in 100 kHz when maximum peak conducted output power procedure is used. If the transmitter complies with the conducted power limits based on the use of RMS averaging over a time interval, the attenuation required under this paragraph shall be 30 dB instead of 20 dB per 15.247(d).
5. Measure and record the results in the test report.
6. The RF fundamental frequency should be excluded against the limit line in the operating frequency band.

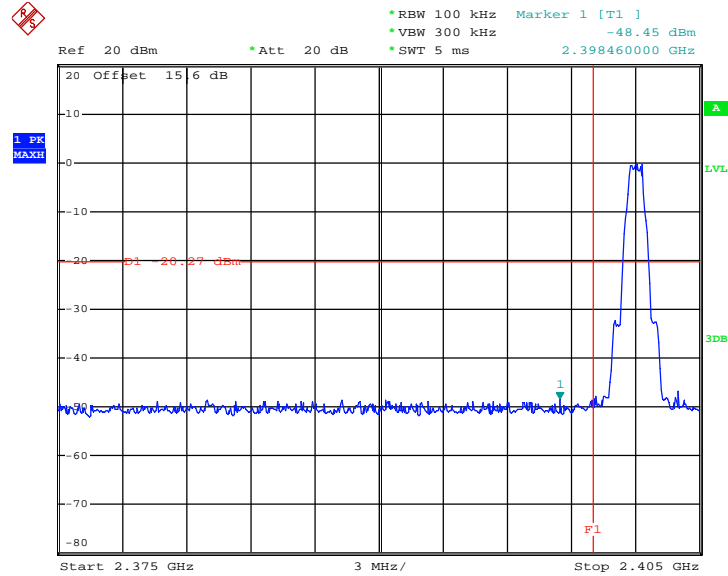

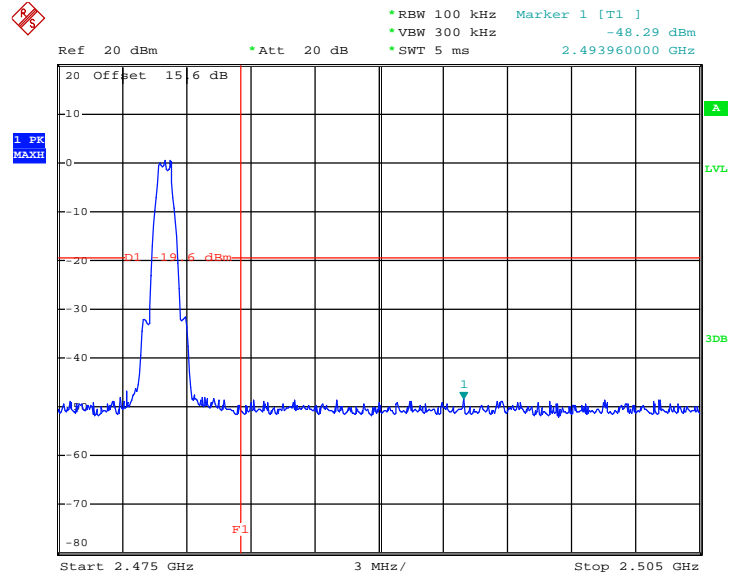
Low Band Edge Plot on Channel 00

High Band Edge Plot on Channel 39



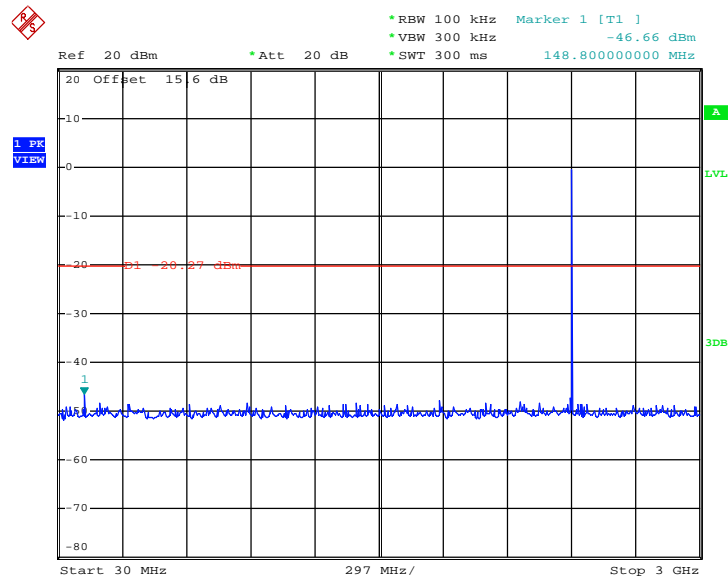

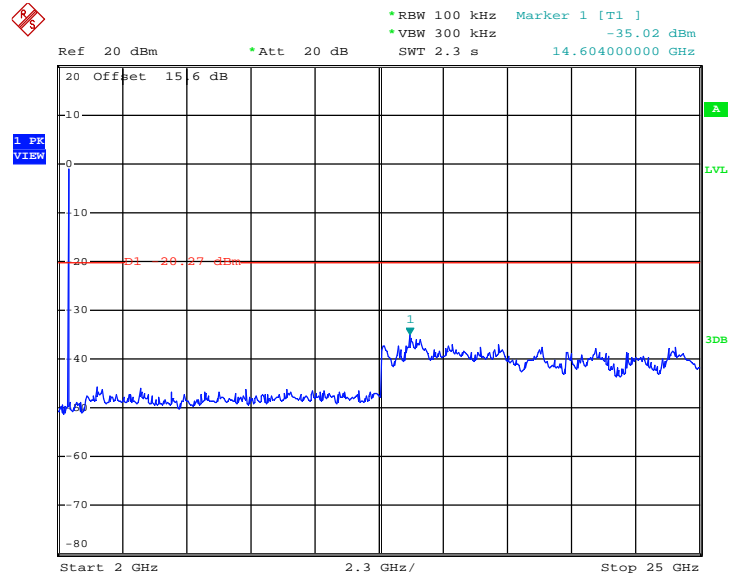
Conducted Spurious Emission Plot on Bluetooth LE

### Conducted Spurious Emission Plot on Bluetooth LE GFSK Channel 00

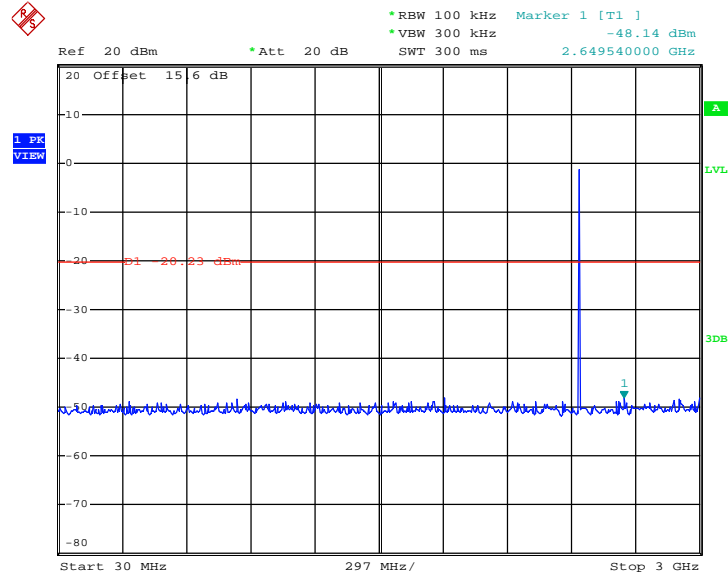

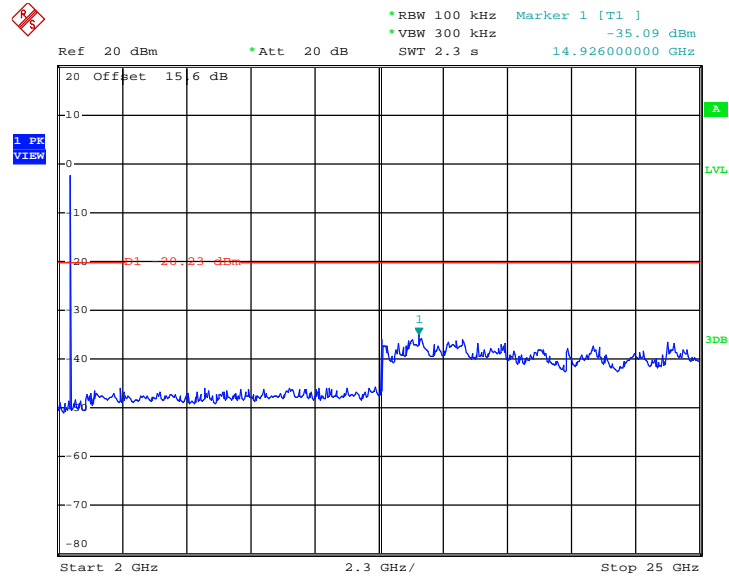
Conducted Spurious Emission Plot on Bluetooth LE

### Conducted Spurious Emission Plot on Bluetooth LE GFSK Channel 19

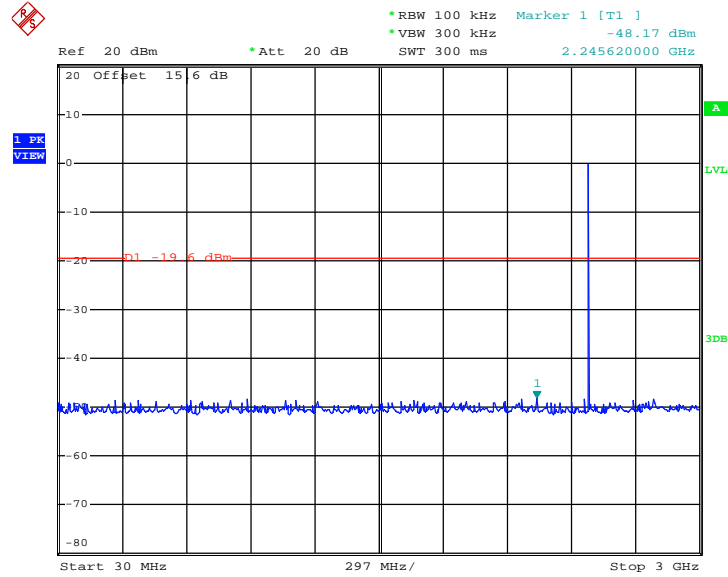

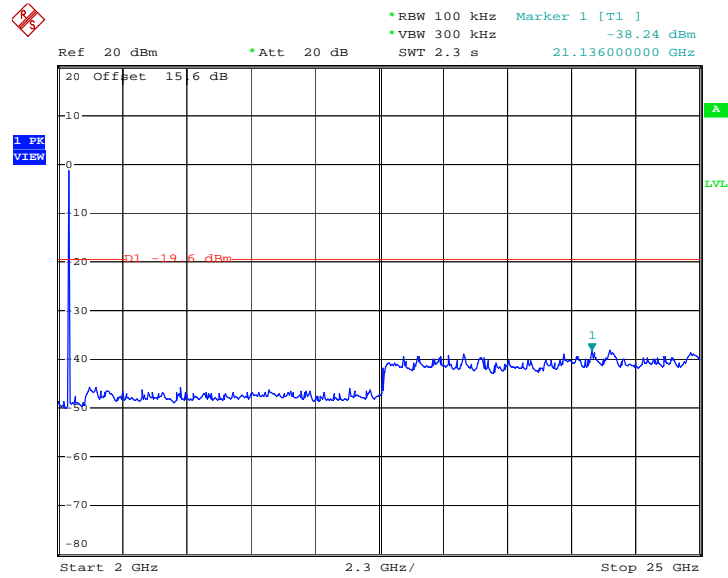
Conducted Spurious Emission Plot on Bluetooth LE

### 3.5 Radiated Band Edges and Spurious Emission Measurement

#### 3.5.1 Limit of Radiated Band Edges and Spurious Emission

In any 100 KHz bandwidth outside the intentional radiator frequency band, all harmonics/spurious must be at least 20 dB below the highest emission level within the authorized band. If the output power of this device was measured by spectrum analyzer, the attenuation under this paragraph shall be 30 dB instead of 20 dB. In addition, radiated emissions which fall in the restricted bands must also comply with the FCC section 15.209 limits as below.

**3.5.3 Test Procedures**

1. The testing follows the guidelines in ANSI C63.10-2009 and ANSI C63.4-2003 test site requirement.
2. The EUT was arranged to its worst case and then tune the antenna tower (from 1 m to 4 m) and turntable (from 0 degree to 360 degrees) to find the maximum reading. A pre-amp and a high pass filter are used for the test in order to get better signal level.
3. The EUT was placed on a turntable with 0.8 meter above ground.
4. The EUT was set 3 meters from the interference receiving antenna, which was mounted on the top of a variable height antenna tower.
5. Corrected Reading: Antenna Factor + Cable Loss + Read Level - Preamp Factor = Level
6. For measurement below 1GHz, If the emission level of the EUT measured by the peak detector is 3 dB lower than the applicable limit, the peak emission level will be reported. Otherwise, the emission measurement will be repeated using the quasi-peak detector and reported.
7. Use the following spectrum analyzer settings:
  - (1) Span shall wide enough to fully capture the emission being measured;
  - (2) Set RBW=100 KHz for  $f < 1$  GHz;  $VBW \geq RBW$ ; Sweep = auto; Detector function = peak; Trace = max hold;
  - (3) Set RBW = 1 MHz, VBW= 3MHz for  $f \geq 1$  GHz for peak measurement.
 

For average measurement:

    - $VBW = 10$  Hz, when duty cycle is no less than 98 percent.
    - $VBW \geq 1/T$ , when duty cycle is less than 98 percent where T is the minimum transmission duration over which the transmitter is on and is transmitting at its maximum power control level for the tested mode of operation.

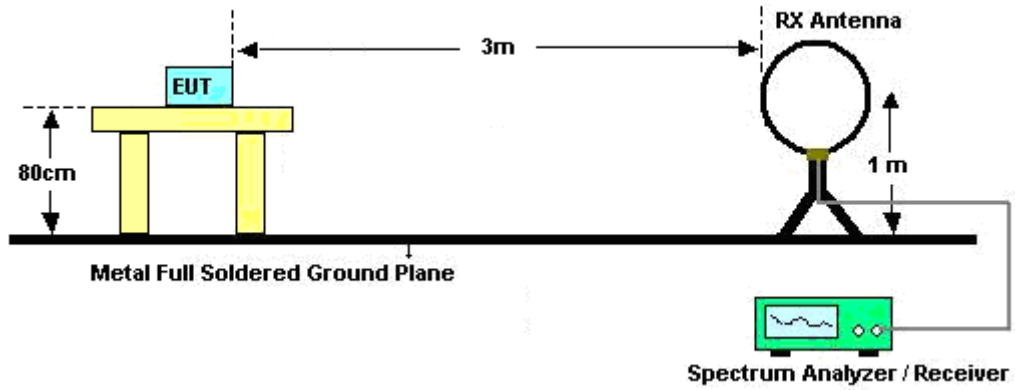

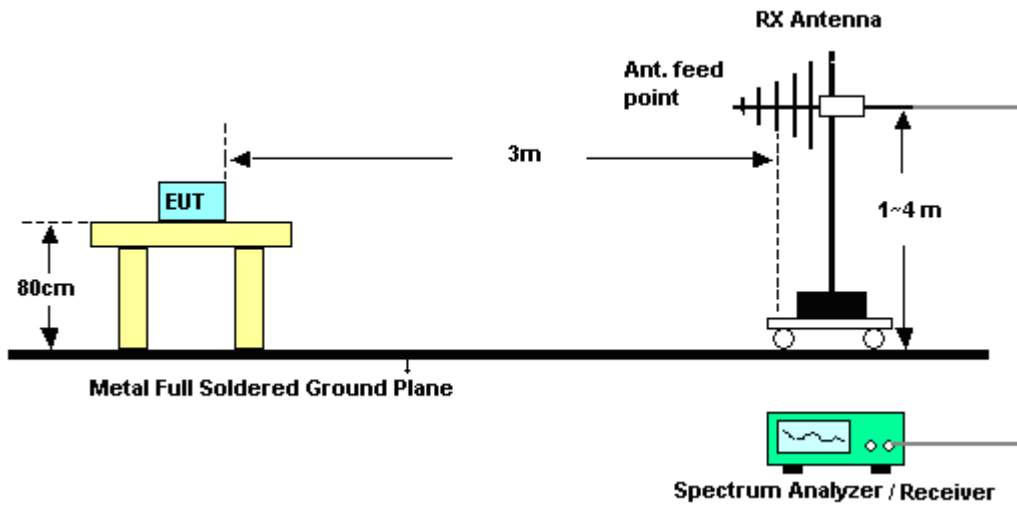
- (1) Set RBW = 1 MHz, VBW = 3 MHz, peak detector.  
Repeat the measurement with an average detector, use RBW = 1MHz  
VBW = 10 Hz, when duty cycle is no less than 98 percent.  
VBW  $\geq 1/T$ , when duty cycle is less than 98 percent
- (2) Set span = 10MHz, that encompasses both the peak of the fundamental emission and the band-edge emission under investigation. Set RBW = 100KHz, 1% of the total span. Set VBW = 100KHz  $\geq$  RBW.
- (3) Subtract the delta measured in step (2) from the field strengths measured in step (1).  
The resultant field strengths (peak/average) are then used to determine band-edge compliance as required by Section 15.205.

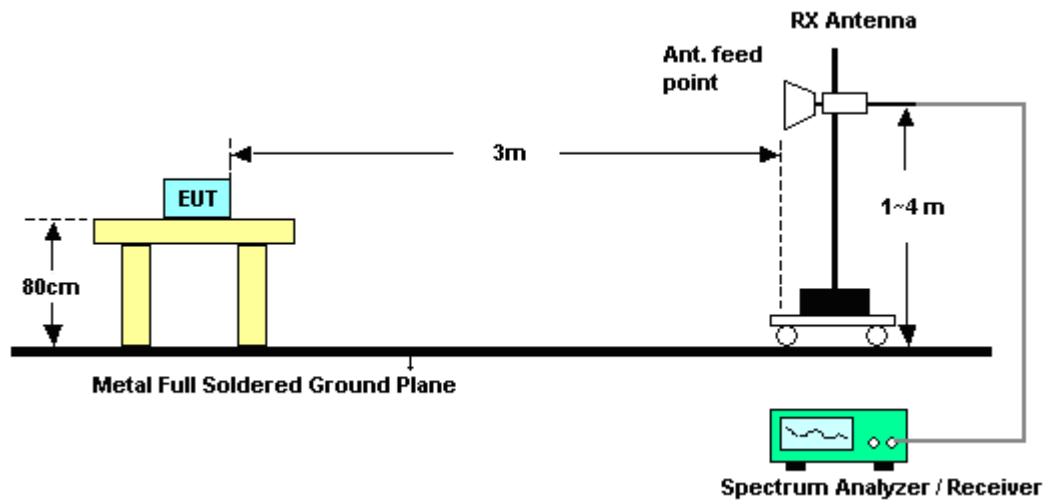
For radiated emissions below 30MHz

#### 3.6.3 Test Procedures

1. The testing follows the guidelines in ANSI C63.10-2009 and ANSI C63.4-2003 test site requirement.
2. The EUT was placed 0.4 meter from the conducting wall of the shielding room was kept at least 80 centimeters from any other grounded conducting surface.
3. Connect EUT to the power mains through a line impedance stabilization network (LISN).
4. All the support units are connecting to the other LISN.
5. The LISN provides 50 ohm coupling impedance for the measuring instrument.
6. The FCC states that a 50 ohm, 50 microhenry LISN should be used.
7. Both sides of AC line were checked for maximum conducted interference.
8. The frequency range from 150 kHz to 30 MHz was searched.
9. Set the test-receiver system to Peak Detect Function and specified bandwidth with Maximum Hold Mode.



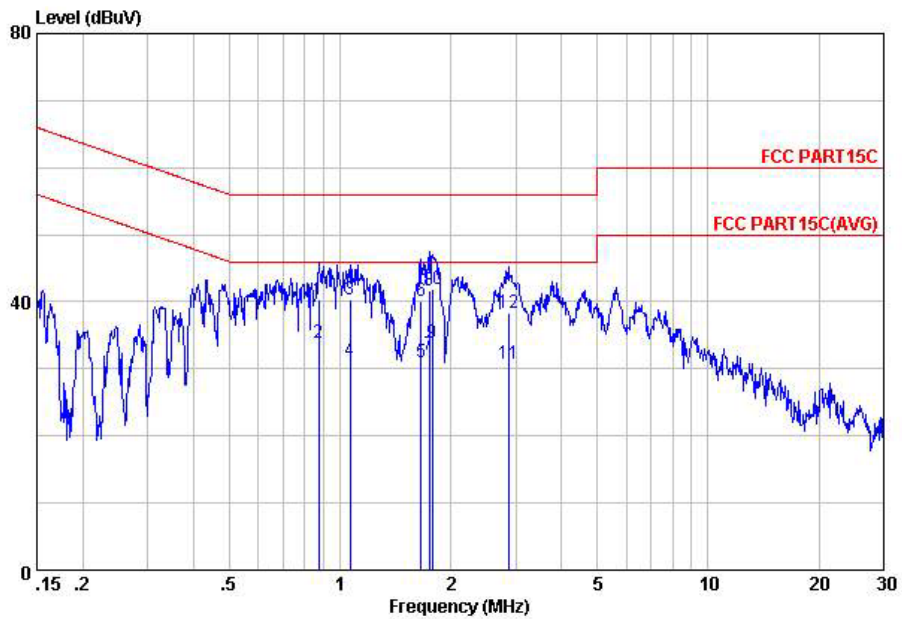

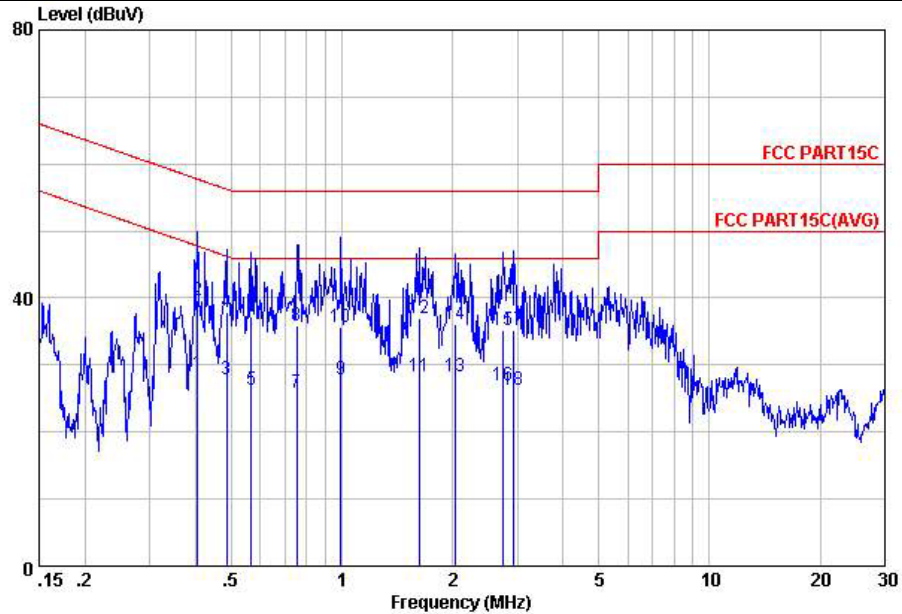

## **3.7 Antenna Requirements**

### **3.7.1 Standard Applicable**

If directional gain of transmitting antennas is greater than 6dBi, the power shall be reduced by the same level in dB comparing to gain minus 6dBi. The use of a permanently attached antenna or of an antenna that uses a unique coupling to the intentional radiator shall be considered sufficient to comply with the FCC rule.
