Band25-20MHz-QPSK-26140-1RB#0-Range2:0.15~30MHz

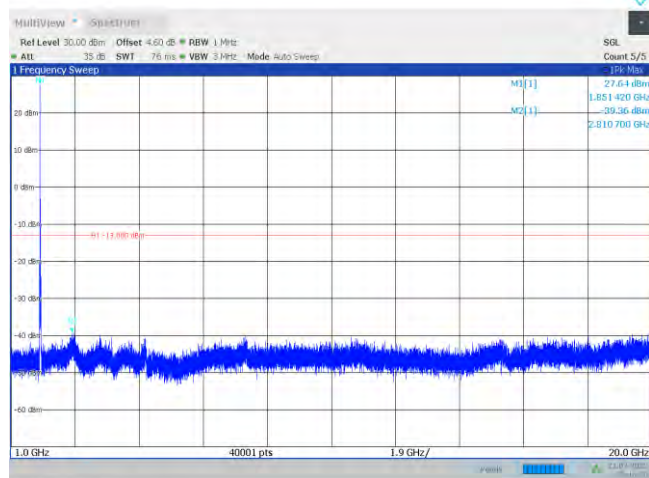


Band25-20MHz-QPSK-26140-1RB#0-Range3:30~1000MHz
