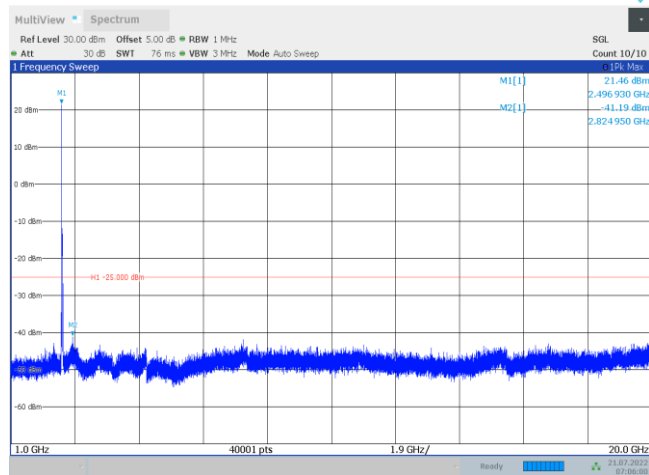


Band41-20MHz-QPSK-39750-1RB#0-Range3:30~1000MHz
