Data Traffic Plot

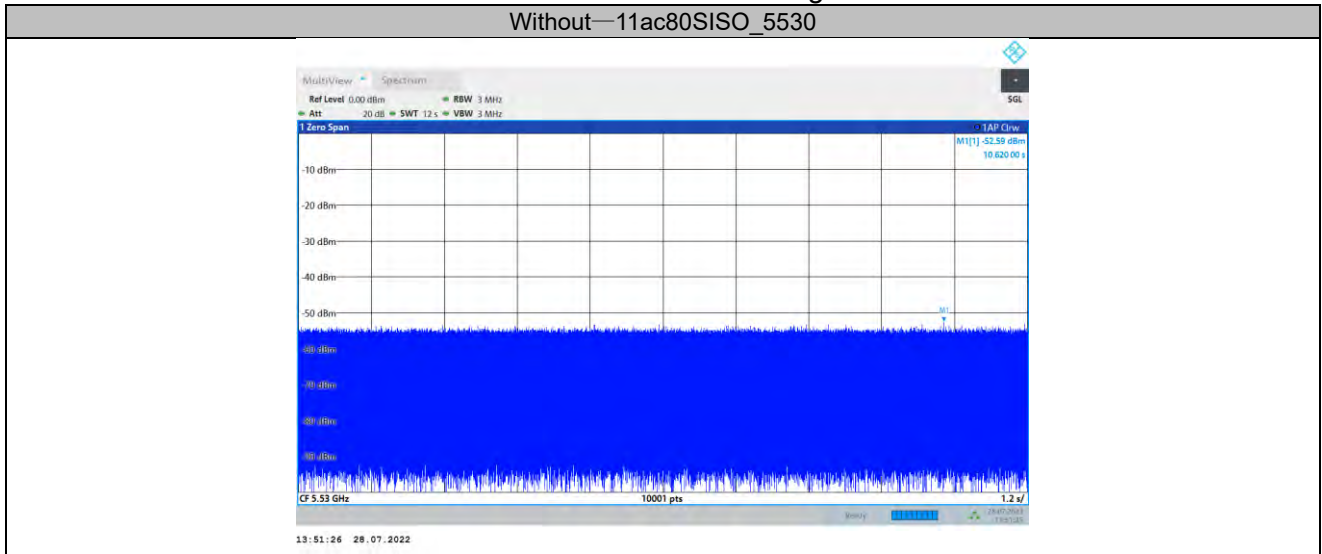
