Friis Formula

Friis transmission formula: Pd = (Pout*G)/(4* Pi * R 2)

Where

Pd = power density in mW/cm2

Pout = output power to antenna in mW

G = gain of antenna in linear scale

Pi = 3.1416

R = distance between observation point and center of the radiator in cm

Pd id the limit of MPE, 1 mW/cm2. If we know the maximum gain of the antenna and the total power input to the antenna, through the calculation, we will know the distance r where the MPE limit is reached.

Software provided by client enabled the EUT to transmit data at lowest, middle and highest channel individually.

Both of the WLAN and Bluetooth can transmit simultaneously, the formula of the calculated the MPE is:

CPD1/ LPD1+ CPD2/ LPD2+.....etc.<1

CPD=Calculation power density

LPD= Limit of power density

Therefore, the worst-case situation is 0.0139/1+0.0022/1=0.0161, which is less than "1", this confirmed that the device comply with MPE limit.
