

Installation

Assure the receiver has been installed well.

Connect the receiver to your PC by plugging in the receiver's USB connector into the USB port of your PC.

- Load batteries..
- Insert the Keyboard Driver CD into CD-ROM or DVD drive.
- Double click "setup.exe"
- The onscreen setup will guide you through the rest of process.
- Install Keyboard
 - 1. Press the button on the top of the receiver, then press the reset button on the back of keyboard
 - 2. If the keyboard could not work, please repeat item 1 again.
- Install Mouse
 - 1. Press the button on the top of the receiver, then press the reset button on the back of Mouse
 - 2. If the Mouse could not work, please repeat item 1 again.

First Use / RF Connection

- 1. Turn off the power of your computer.
- 2. Remove the existing keyboard and mouse connector
- 3. Plug the RF receiver connectors into corresponding ports of your computer
- 4. Install AA batteries into the keyboard and mouse
- 5. Press the button on the top of the receiver, then press the button on the back of keyboard.
- 6. Press the button on the top of the receiver, then press the button on the back of mouse.
