9.1 FRIIS FORMULA

Friis transmission formula : $Pd = (Pout*G)/(4*pi*r^2)$

Where

 $Pd = power density in mW/cm^2$

Pout = output power to antenna in mW

G = gain of antenna in linear scale

Pi = 3.1416

R = distance between observation point and center of the radiator in cm

Pd id the limit of MPE, 1 mW/cm2. If we know the maximum gain of the antenna and the total power input to the antenna, through the calculation, we will know the distance r where the MPE limit is reached.

9.3.1 ANTENNA GAIN

Antenna Gain: The maximum Gain measured in fully anechoic chamber is 2dBi linear scale.

Note: PORT B is the worse case so we didn't report the PORT A data The distance r (4th column) calculated from the Friis transmission formula is far shorter than 20cm separation requirement. So, RF exposure limit warning or SAR test are not required.
