The reasons for this request are the followings.

- § 0.459 (b)(3) The document and associated material being submitted is of the strictest confidence as it pertains to Wavetrend's intellectual property and competitive positioning in the active RFID market worldwide. Whilst FCC certification is required for this product and its sales into FCC regulated environments, this information in the hands of our competitors, their advisors or other associated parties without a current non disclosure agreement would potentially have a negative impact on our business commercially and financially.
- § 0.459 (b)(4) The documentation, diagrams, schematics and photos' provided for the purpose of FCC certification, are internal trade secrets of Wavetrend, and the direct result of several man years of development. Hence, our request to keep them strictly confidential.
- § 0.459 (b)(5) It is our firm belief that the disclosure of the information contained in the above documentation and supporting material would enable our competition to develop a clone/copy of our products with our trade secrets and hence jeopardise our go to market strategy and competitive positioning.
- § 0.459 (b)(6) All of our current customers, partners, alliances and contract manufactures have signed NDA's, and knowledge transfer agreements that outlive any contractual period agreed to in the NDA. They have confirmed that the knowledge, documentation and other supporting materials are the sole rights and IP of Wavetrend.
- § 0.459 (b)(7) None of the above documents are openly available without strict agreement being signed by an authorised individual. To date only our contract manufacturers have had the details that are also contained here.
- § 0.459 (b)(8) Justification of the period is 3 years.
- § 0.459 (b)(9) None.
