
Dear Application Examiner:

3Com Corporation is submitting this application for the certification of the 3Com SL-1020 wireless USB Device. It operates in the 2400 – 24835 MHz band, with a peak output power of 1.48 mW. The SL-1020 is a wireless transceiver that connects via an USB interface to a PC or laptop computer. This device provides data and voice exchange capabilities with other standard protocol enabled devices. The SL-1020 enables wireless communications with Palms, Palm-PC's, Mobile Phones, LAN Access Points, PSTN Access Points, Cordless Headsets, and other Standard protocol enabled PC's. The SL-1020 transmitter was connected to the PC through a 6 foot cable and a direct connect USB adapter. An 18 inch cable may also be provided.

The technical report and exhibits demonstrate compliance with FCC rules 47 CFR 15.24. To facilitate the review process an index of exhibits has been provided within this same file.


In accordance with § 0.459 of CFR 47, 3Com Corporation requests confidentiality for the following items:
