1. GENERAL INFORMATION

1.2 Characteristics of Device:

Remote controller transmitter.

1.3 Test Methodology

Radiated testing were performed according to the procedures in chapter 13 of ANSI C63.4. The equipment under test was operated continuously in its normal operating mode for the purpose of the measurements.

The receiving antenna was varied from 1 to 4 meters and the wooden turntable was rotated through 360 degrees to obtain the highest reading on the field strength meter or on the display of the spectrum analyzer. And also, each emission was to be maximized by changing the orientation of the equipment under test.

1.4 Test Facility

The semi-anechoic chamber and conducted measurement facility used to collect the radiated and conducted data are located inside the Building at No.8, Lane 29, Wen-ming Road, Lo-shan Tsun, Kweishan Hsiang, Taoyuan, Taiwan, R.O.C.

This site has been accreditation as a FCC filing site.

2. DEFINITION AND LIMITS

2.1 Definition

Intentional radiator:

A device that intentionally generates and emits radio frequency energy by radiation or induction.

2.2 Restricted Bands of Operation

Only spurious emissions are permitted in any of the frequency bands listed below:

2.3 Limitation

(1) Conducted Emission Limits:

For an intentional radiator which is designed to be connected to the public utility (AC) power line, the conducted limit is the following:

(2) Radiated Emission Limits:

According to 15.231 ,Periodic operation in the band 40.66-40.70 MHz and above 70 MHz, the field strength of emissions from intentional radiators operated under this section shall not exceed the following:

According to 15.235, the field strength of emissions from intentional radiators operated under these frequency bands shall not exceed the following:

Field strength limits are at the distance of 3 meters, emissions radiated outside of the specified bands, shall be according to the general radiated limits in 15.209,as following table:

As shown in 15.35(b), for frequencies above 1000MHz, the field strength limits are based on average detector, however, the peak field strength of any emission shall not exceed the maximum permitted average limits, specified above by more than 20 dB under any condition of modulation.

(3) Limit of transmission time

- a) A manually operated shall employ a switch that will automatically deactivate the within not more than 5 seconds of being released.
- b) A activated automatically shall cease transmission within 5 seconds after activation.

2.4 Labeling Requirement

The device shall bear the following statement in a conspicuous location on the device:

This device complies with part 15 of the FCC Rules. Operation is subject to the following two conditions: (1) This device may not cause harmful interference, and (2) this device must accept any interference received, including interference that may cause undesired operation.

2.5 User Information

The users manual or instruction manual for an intentional or unintentional radiator shall caution the user that changes or modifications not expressly approved by the party responsible for compliance could void the user's authority to operate the equipment.

3. RADIATED EMISSION MEASUREMENT

3.1 Applicable Standard

For periodic operation intentional radiator, the radiated emission shall comply with §5.231(b).

3.2 Measurement Procedure

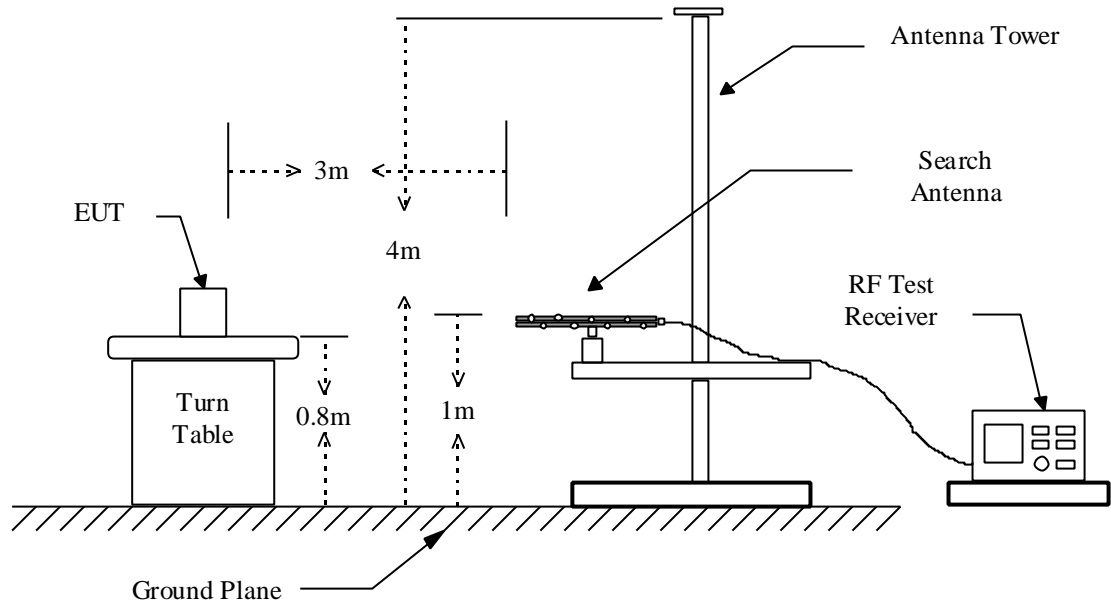
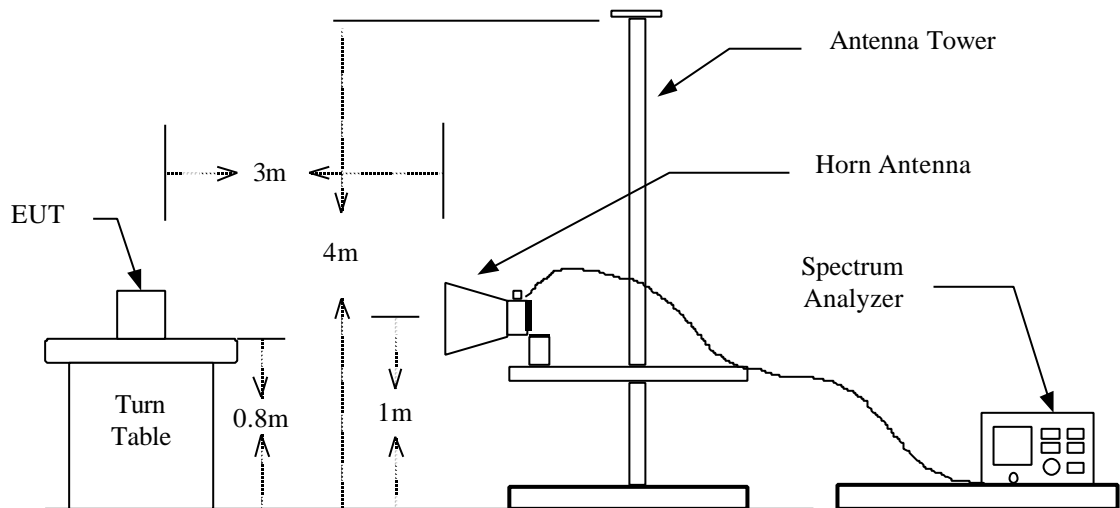


Figure 2: Frequencies measured above 1 GHz configuration

1. Setup the configuration per figure 1 and 2 for frequencies measured below and above 1 GHz respectively. Turn on EUT and make sure that it is in normal function.
2. For emission frequencies measured below 1 GHz, a pre-scan is performed in a semi-anechoic chamber to determine the accurate frequencies of higher emissions and then each selected frequency is precisely measured. As the same purpose, for emission measured above 1 GHz, a pre-scan also be performed with a 1 meter measuring distance before final test.
3. For emission measured below and above 1 GHz, set the spectrum analyzer on a 100 kHz and 1 MHz resolution bandwidth respectively for each frequency measured in step 2.
4. The search antenna is to be raised and lowered over a range from 1 to 4 meters in horizontally polarized orientation. Position the highness when the highest value is indicated on spectrum analyzer, then change the orientation of EUT on test table over a range from 0° to 360° with a speed as slow as possible, and keep the azimuth that highest emission is indicated on the spectrum analyzer. Vary the antenna position again and record the highest value as a final reading. A RF test receiver is also used to confirm emissions measured.
5. Repeat step 4 until all frequencies need to be measured were complete.
6. Repeat step 5 with search antenna in vertical polarized orientations.
7. Check the three frequencies of highest emission with varying the placement of cables (if any) associated with EUT to obtain the worse case and record the result.

Figure 1: Frequencies measured below 1 GHz configuration

Note:

1. "----" means the noise is too low to be measured.
2. Peak Result = Peak Reading + Correct Factor
3. AVG Result = Peak Result + Duty Factor
4. If the measured frequencies fall in the restricted frequency band, the limit employed is § 5.209 general requirement when frequencies are below or equal to 1 GHz. And the measuring instrument is set to quasi peak detector function, no duty factor applied.
5. "*" means the frequency is in the restricted bands.
6. The EUT is a hand-held product. In order to get the worse data, X, Y, Z direction were adjusted during the data.

3.4 Field Strength Calculation

(a) Field Strength:

The field strength is calculated by adding the Antenna Factor and Cable Factor, and subtracting the Amplifier Gain (if any) from the measured reading. The basic equation with a sample calculation is as follows:

$$\text{RESULT} = \text{READING} + \text{CORR. FACTOR}$$

where CORR. FACTOR = Antenna FACTOR + Cable FACTOR

Assume a receiver reading of 62.4 dB μ V is obtained. The Antenna Factor of 14.1 and a Cable Factor of 3.4 is added. The total of field strength is 79.9 dB μ V/m.

$$\text{RESULT} = 62.4 + 14.1 + 3.4 = 79.9 \text{ dB } \mu \text{ V/m}$$

$$\text{Level in } \mu \text{ V/m} = \text{Common Antilogarithm}[(79.9 \text{ dB } \mu \text{ V/m})/20] = 9885.5 \text{ } \mu \text{ V/m}$$

(b) Duty Factor:

$$20\log \frac{0.333 \times 17 + 0.833 \times 12}{47.33} = -9.6 \text{ dB}$$

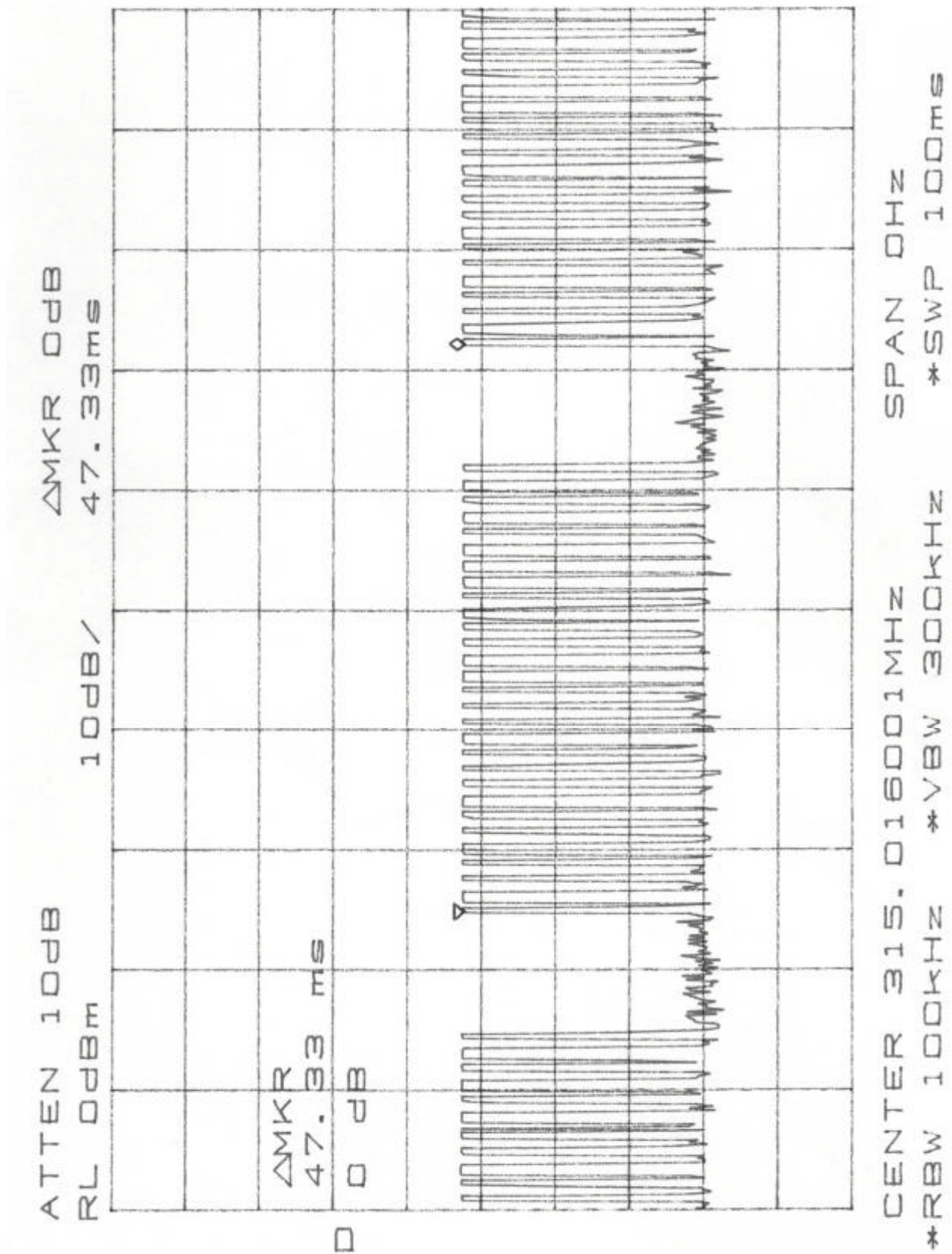

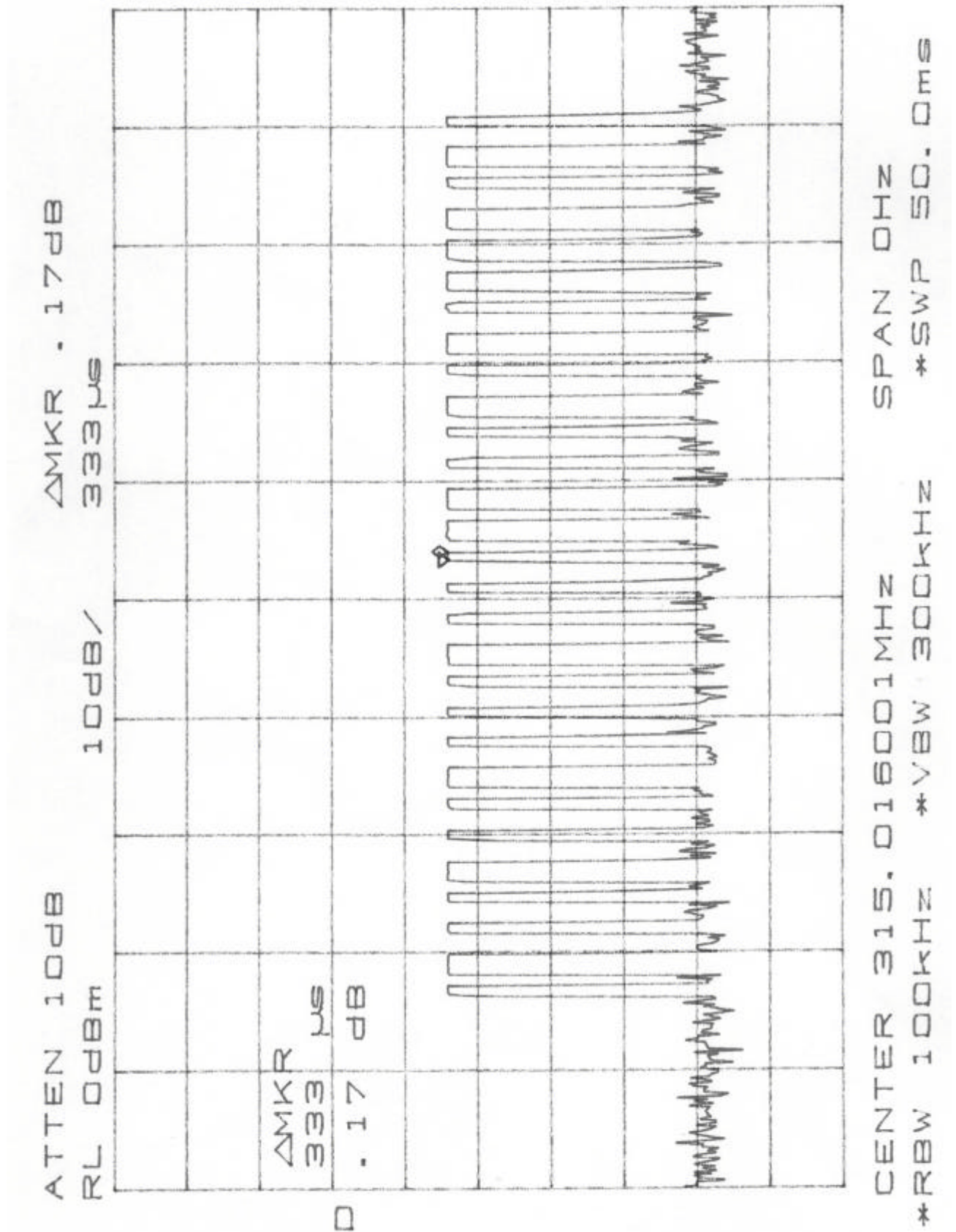

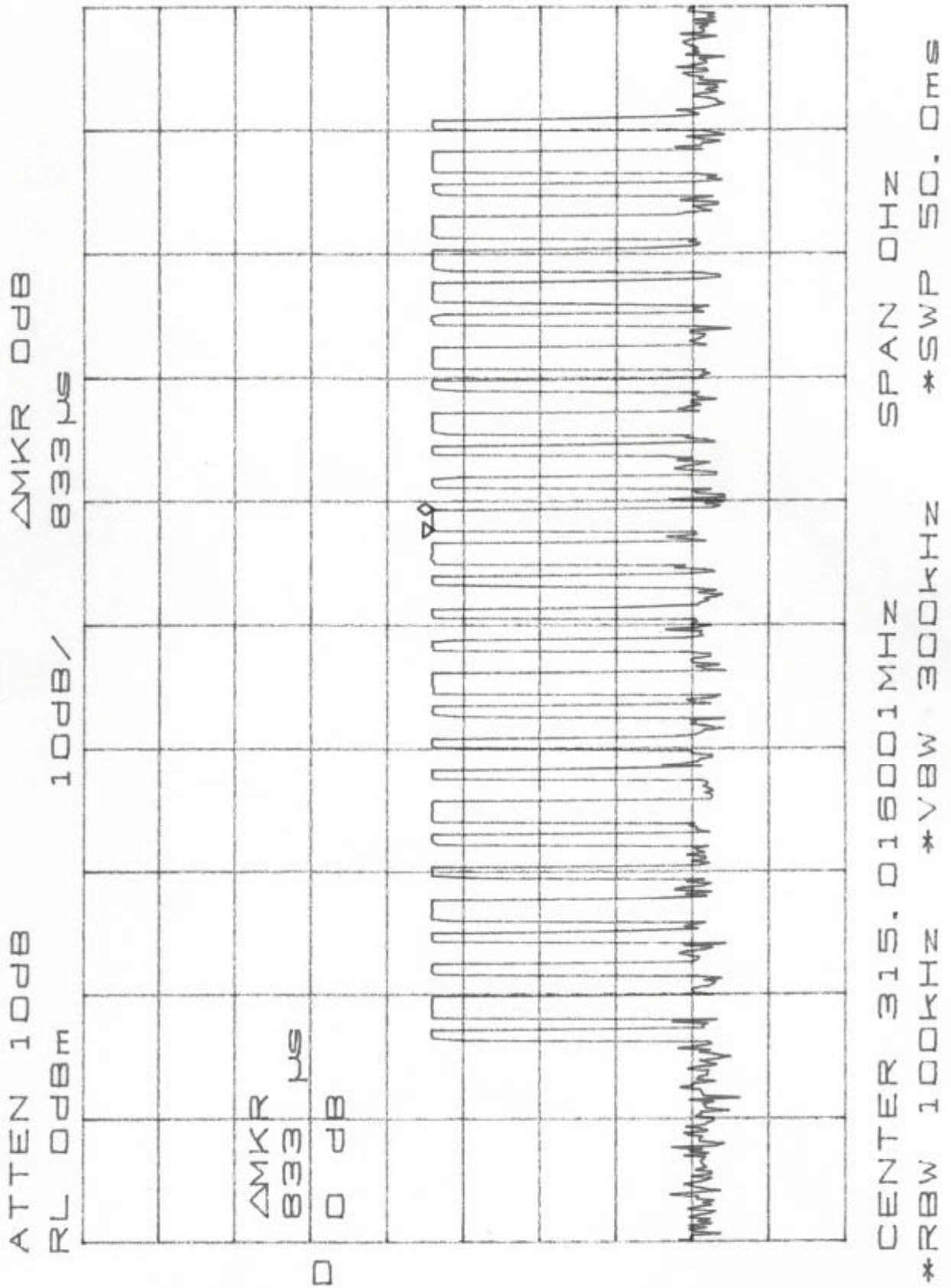
Plotted graph 1 of Duty Factor

4.1 Applicable Standard Plot Graphic of Bandwidth

Per FCC rule §5.231(c), the permitted emission bandwidth is no wider than 0.25% of the center frequency for devices operating above 70 MHz and below 900 MHz.

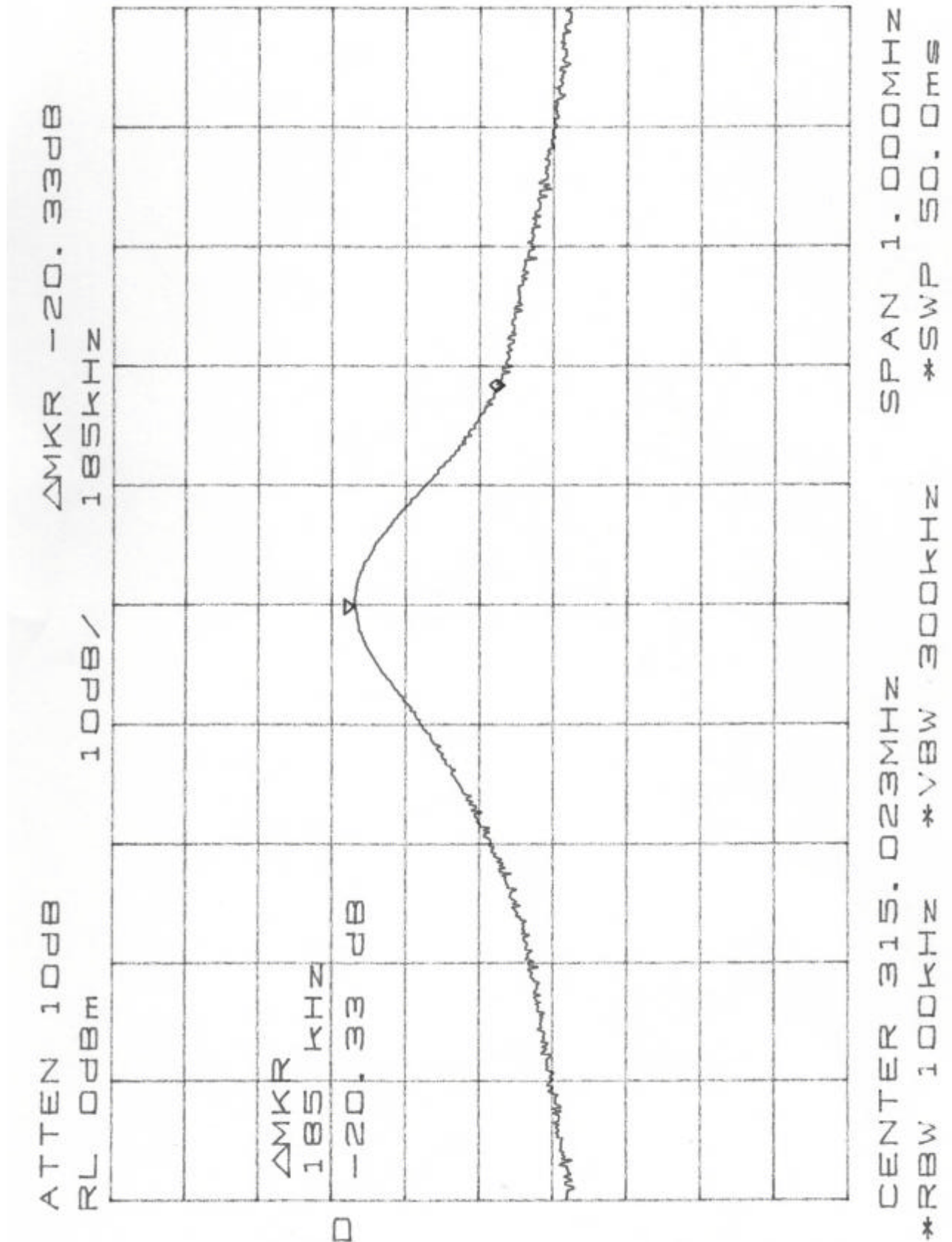

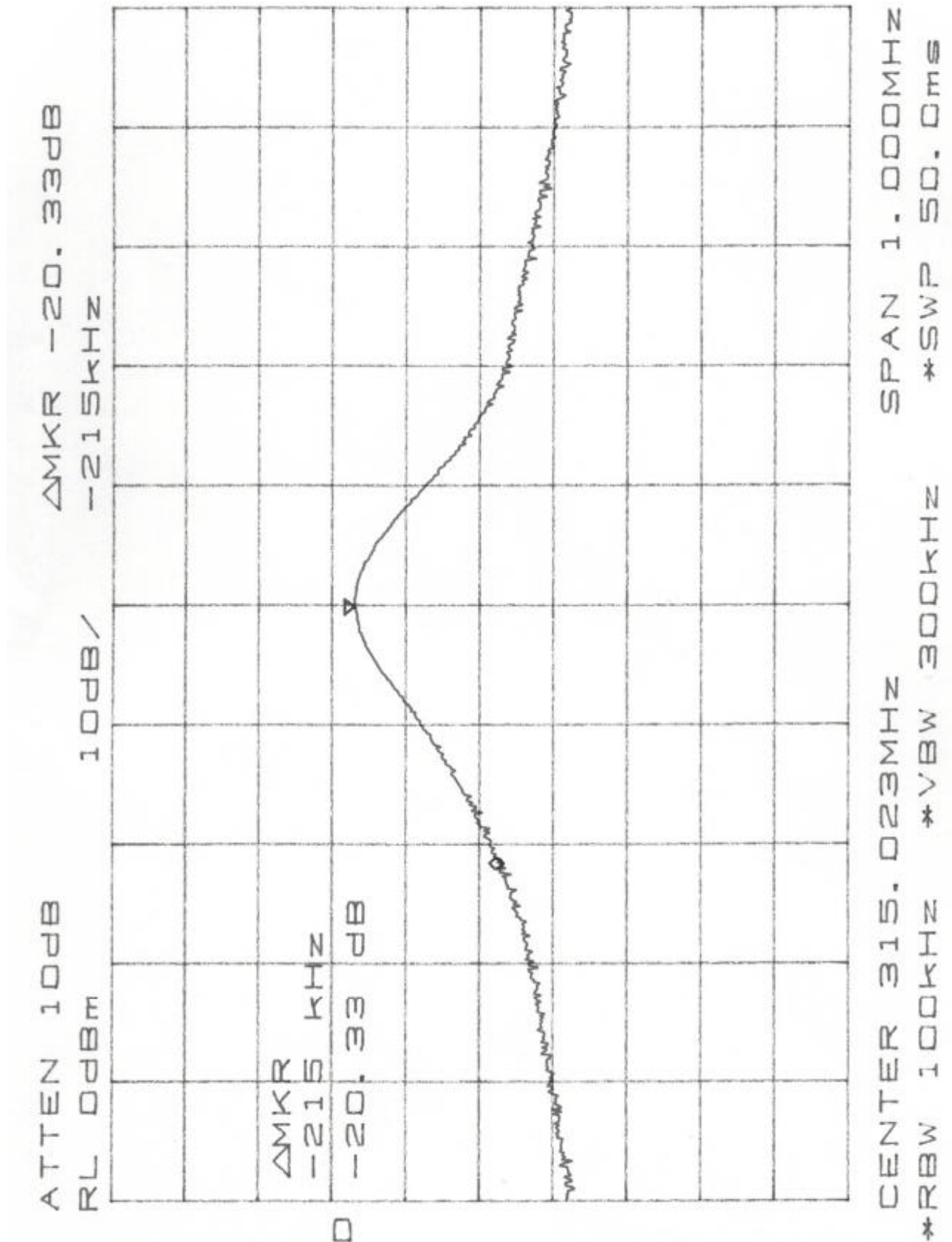
(b) Test Result = $185+215 = 400 \text{ kHz}$

5. CONDUCTED EMISSION MEASUREMENT

5.1 Applicable Standard

This EUT is excused from investigation of conducted emission, for it is powered by battery only. According to §5.207 (d), measurements to demonstrate compliance with the conducted limits are not required for devices which only employ battery power for operation and which do not operate from the AC power lines or contain provisions for operation while connected to the AC power lines.

6. LIMIT OF TRANSMISSION TIME

6.1 Applicable Standard

According to 15.231(a)(1), a manually operated transmitter shall employ a switch that will automatically deactivate the transmitter within not more than 5 seconds of being released.

6.2 Active Time

This transmitter is operated by manual and active time is less than 1 second after being released.
