




EUT – Port Front View


Uncover - Front View




EUT PCBA 1- Front View


EUT PCBA 1- Rear View








Conducted Emissions Setup Front View

Radiated Emissions Setup Below 1GHz Front View




**Block Configuration Diagram for Conducted Emissions**
