For emissions testing, throughout this test report, "Pass" indicates that the results for the sample as tested were below the specified limit (refer also to Section 2, Measurement Uncertainty).

Where relevant, the apparatus was only assessed using the monitoring methods and susceptibility criteria defined in this report.

All testing with the exception of testing at the Open Area Test Site was performed under the following environmental conditions:





#### 20dB Bandwidth





## Emissions Mask - Tnom, Vnom





## Emissions Mask - Tnom, Vmin












## Radiated H-field scan

**Support Equipment (SE)** is any additional equipment required to exercise the EUT in the applicable operating mode. Where relevant SE is divided into two categories:

SE in test environment: The SE is positioned in the test environment and is not isolated from the EUT (e.g. on the table top during REFE testing).

SE isolated from the EUT: The SE is isolated via filtering from the EUT. (e.g. equipment placed externally to the ALSR during REFE testing).

**EUT configuration** refers to the internal set-up of the EUT. It may include for example:

- Positioning of cards in a chassis
- Setting of any internal switches
- Circuit board jumper settings
- Alternative internal power supplies

Where no change in EUT configuration is **possible**, the configuration is described as "single possible configuration".

**EUT arrangement** refers to the termination of EUT ports / connection of support equipment, and where relevant, the relative positioning of samples (EUT and SE) in the test environment.

For further details of the test procedures and general test set ups used during testing please refer to the related document "EMC Test Methods - An Overview", which can be supplied by TRaC Global upon request.


