## 1 Test Methodology

In this document, we evaluate the RF Exposure to human body due the intentional transmission from the transmitter (EUT). The limit for Maximum Permissible Exposure (MPE) specified in FCC 1.1310 is followed. Through the Friis transmission formula and the maximum gain of the antenna, we can calculate the distance, away from the product, where the limit of MPE is reached.

Although the Friis transmission formula is a far field assumption, the calculated result of that is an over-prediction for near field power density. We will take that as the worst case to specify the safety range.

### 1.1 RF Exposure Limit

According to FCC 1.1310 table 1: The criteria listed in the following table shall be used to evaluate the environmental impact of human exposure to radio-frequency (RF) radiation as specified in 1.1307(b).

## 1.2 EUT Operating Condition

As instructed by the manufacturer, the EUT's power setting was set to 4 dBm on the low, middle and high frequencies/channels.

### 1.2.1 Classification

EUT is a mobile device. The antenna of the product, under normal use condition, is at least 20cm away from the body of the user and accessible to the end user. Warning statement to the user for keeping at least 20cm or more separation distance with the antenna should be included in user's manual.

### 1.3.2 Calculating the Power Density at 20cm

#### Calculating the Power Density (Pd) at 20cm

Using the Friss transmission formula to solve for Power Density (Pd):

$$Pd = (P_{out} * G) / (4 * \pi * R^2)$$

$$P_{out} = 2.81 \text{ mW}$$

$$G = 1.58 \text{ Numerical Value}$$

$$\pi \approx 3.1416$$

$$R = 20 \text{ cm}$$

The highest EIRP ( $P_{out} * G$ ) power measured power is 6.49 dBi or 4.46 mW.

$$Pd = 4.46 / 5024$$

$$Pd = 0.0009 \text{ mW/cm}^2 \text{ or } Pd = 0.009 \text{ W/m}^2$$

The device **COMPLIES** with mobile device requirements of Power density limit of 1.0mW/ cm<sup>2</sup> at 20cm.

### 1.3.3 Sample Calculation

The Friss transmission formula:  $Pd = (P_{out} * G) / (4 * \pi * R^2)$

Where;

$Pd$  = Power density in mW/cm<sup>2</sup>

$P_{out}$  = Output power to antenna in mW

$G$  = Gain of antenna in linear scale

$\pi \approx 3.1416$

$R$  = Distance between observation point and center of the radiator in cm
