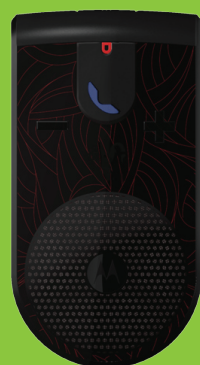

## BEFORE YOU BEGIN

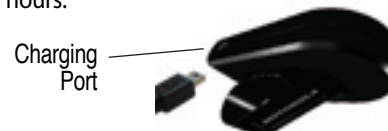
Before using this product, read the Important Safety and Legal Information pamphlet and follow its instructions.

Take a moment before you get started to familiarize yourself with your new T307 Portable Bluetooth Hands-Free Speaker.



## ① CHARGE YOUR HANDS-FREE SPEAKER

Charge your hands-free speaker's battery for 2 hours:



Note: Do not place hands-free speaker with clip installed on visor when charging.

- 1 Plug the Motorola charger into the charging port on the left side of the hands-free speaker.

The indicator light turns steadily red when the battery is charging and the hands-free speaker is turned off. It may take up to 1 minute for the indicator light to turn on. When the hands-free speaker's battery is fully charged (about 2 hours), the indicator light turns steadily blue.

- 2 Disconnect the charger.

Note: Hands-free speaker is functional while charging; however, when charging the hands-free speaker while turned on, the indicator light does not provide charging status.

## ② START BLUETOOTH FEATURE

Your Phone

Your phone's Bluetooth feature is off by default. To use your hands-free speaker, you must turn on the Bluetooth feature in your phone.

For most Motorola phones (at the main menu):

- 1 Press **M(Menu) > Settings > Connection > Bluetooth Link > Setup.**
- 2 Scroll to Power.
- 3 Select Change.
- 4 Scroll to On.
- 5 Press Select to turn on the Bluetooth feature. The Bluetooth feature remains on until you turn the feature off.

Note: These steps are for most Motorola phones. For other phones, see your phone's user's guide.

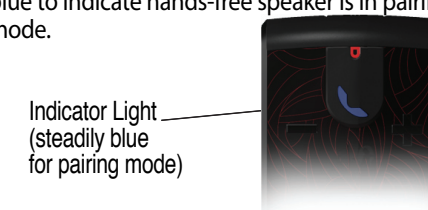
## ③ PAIR

Your Hands-Free Speaker

Before you can use your hands-free speaker, you must pair (link) it with your phone.

Step A - ENSURE HANDS-FREE SPEAKER IS IN PAIRING MODE

To initiate easy pairing, power on hands-free speaker by pressing and holding the Power button until the indicator light becomes steadily lit in purple. Release the button and, after a few moments, the indicator light will be steadily lit in blue to indicate hands-free speaker is in pairing mode.



If the hands-free speaker does not enter pairing mode, see TROUBLESHOOTING for help.

## ③ PAIR CONTINUED

Your Phone

Step B - SET YOUR PHONE TO LOOK FOR YOUR HANDS-FREE SPEAKER

For most Motorola phones:

- 1 On your Motorola phone, press **M(Menu) > Settings > Connection > Bluetooth Link > Handsfree > Look for Devices.**
- The phone lists Bluetooth devices it finds.
- 2 Select Motorola T307.
- 3 Select OK or Yes to pair your hands-free speaker with your phone.
- 4 Enter the passkey: 0000
- 5 Select OK.

When your hands-free speaker successfully pairs with your phone, the indicator light changes to flashing blue with quick purple flashes.

Note: These steps are for most Motorola phones. For other phones, see your phone's user's guide.

## ④ TEST AND USE

Your phone and hands-free speaker are now paired and ready to make and receive calls. To confirm they are operating properly, make a call:

- 1 Install visor clip and place hands-free speaker onto your visor. See "Installing Hands-Free Speaker in Car" on the reverse side of this guide for details.
- 2 On your phone, dial the number you want to call and press the **Send** key.
- 3 If your phone and hands-free speaker are successfully paired, you will hear ringing on the hands-free speaker.

After you have successfully paired your phone and hands-free speaker, you don't need to repeat these steps. For daily use, ensure that your hands-free speaker is turned ON and that your phone's Bluetooth feature is ON.

To save battery power, your hands-free speaker will power down when not connected to your phone for more than 30 minutes.

## TROUBLESHOOTING

My hands-free speaker will not enter pairing mode. Make sure that any devices previously paired with the hands-free speaker are turned off. If the indicator light is flashing in blue, turn off the other device and wait for 10 seconds. The indicator light becomes steadily lit in blue indicating the hands-free speaker is now in pairing mode.

My phone does not find my hands-free speaker. Make sure the indicator light on your hands-free speaker is on and steadily lit in blue when your phone is searching for devices (see step 3).

My hands-free speaker worked with my phone before but now they are not working. Make sure your phone is on and the Bluetooth feature is turned on in your phone (see step 2). If the Bluetooth feature was turned off or was turned on only temporarily, you may need to restart the Bluetooth feature (see step 2) and pair your phone and hands-free speaker again (see step 3).

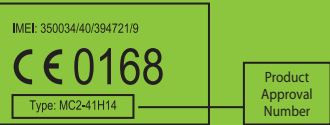

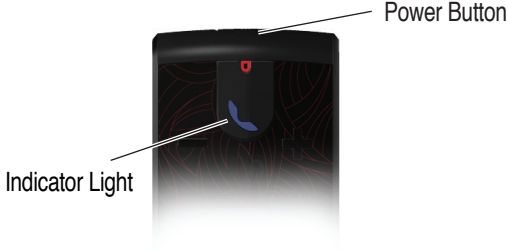
## TURNING HANDS-FREE SPEAKER ON AND OFF

To turn hands-free speaker on, press and hold the Power button until the indicator light turns purple. Then, release the button.

Note: Hands-free speaker may take up to 3 to 4 seconds to turn on.

To turn your hands-free speaker off, press and hold the Power button until the indicator light turns purple and then turns off.

To conserve battery power, your hands-free speaker will turn off when not connected to your phone for more than 30 minutes.



## INSTALLING HANDS-FREE SPEAKER IN YOUR CAR

Follow these steps to install your hands-free speaker in your car:

- 1 Slide the visor clip onto the mounting bracket on the bottom of the hands-free speaker. To do this, place the loop end first onto the hands-free speaker and slide forward as shown below.



## INSTALLING HANDS-FREE SPEAKER IN YOUR CAR

Continued

- 2 Slide the visor clip onto your sun visor.



When installed, the Power button must be facing toward you as shown.

The visor clip is reversible to allow placement of your hands-free speaker on either the front or the back of your car's sun visor.

## ADJUSTING HANDS-FREE SPEAKER VOLUME

You can adjust hands-free speaker volume using the Volume buttons. To adjust volume, tap or press and hold button.



Note: Hands-free speaker volume cannot be adjusted during an incoming call.

## MAKING CALLS

Function	Action
Make a voice dial call	Tap the Call button and speak the name after the tone
End a call	Tap the Call button (if a call is on hold, tap twice to end all calls)
Receive a call	Tap the Call button
Reject a call	Tap either Volume button
Redial last call	Press and hold the Call button until you hear a beep

Note: Your T307 supports both Handsfree and Headset Profiles. Accessing call functions depends upon which profile your phone supports. See your phone's user's guide for more information.

## MAKING CALLS CONTINUED

Function	Action
Answer a second incoming call	Press and hold the Call button (places first call on hold)
Toggle between two active calls	Press and hold the Call button
Mute or unmute a call	Tap both Volume buttons

Note: Some features are phone/network dependent.

Note: When turning on your hands-free speaker during a phone call, audio is transferred automatically to your hands-free speaker (when your hands-free speaker and phone have previously been connected, and your phone supports this feature).

- **Position your wireless phone within easy reach.** Be able to access your wireless phone without removing your eyes from the road. If you receive an incoming call at an inconvenient time, if possible, let your voice mail answer it for you.

- **Let the person you are speaking with know you are driving; if necessary, suspend the call in heavy traffic or hazardous weather conditions.** Rain, sleet, snow, ice, and even heavy traffic can be hazardous.
- **Do not take notes or look up phone numbers while driving.** Jotting down a “to do” list or going through your address book takes attention away from your primary responsibility—driving safely.
- **Dial sensibly and assess the traffic; if possible, place calls when your car is not moving or before pulling into traffic.** If you must make a call while moving, dial only a few numbers, check the road and your mirrors, then continue.

- **Do not engage in stressful or emotional conversations that may be distracting.** Make people you are talking with aware you are driving and suspend conversations that can divert your attention away from the road.
- **Use your wireless phone to call for help.** Dial 9-1-1 or other local emergency number in the case of fire, traffic accident, or medical emergencies.<sup>1</sup>
- **Use your wireless phone to help others in emergencies.** If you see an auto accident, crime in progress, or other serious emergency where lives are in danger, call 9-1-1 or other local emergency number, as you would want others to do for you.<sup>1</sup>

- **Call roadside assistance or a special non-emergency wireless assistance number when necessary.** If you see a broken-down vehicle posing no serious hazard, a broken traffic signal, a minor traffic accident where no one appears injured, or a vehicle you know to be stolen, call roadside assistance or other special non-emergency wireless number.<sup>1</sup>
