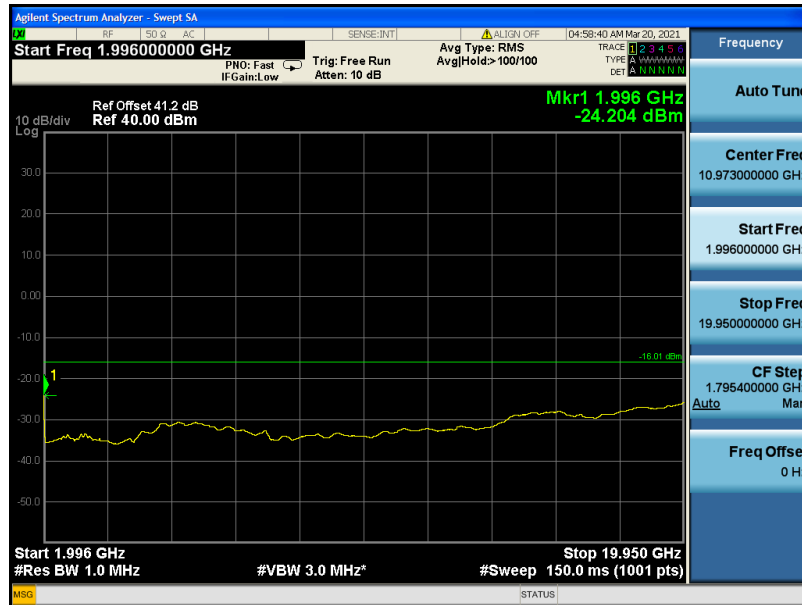


DL_1S_B_AWGN_Pre-AGC_Spurious emission 2

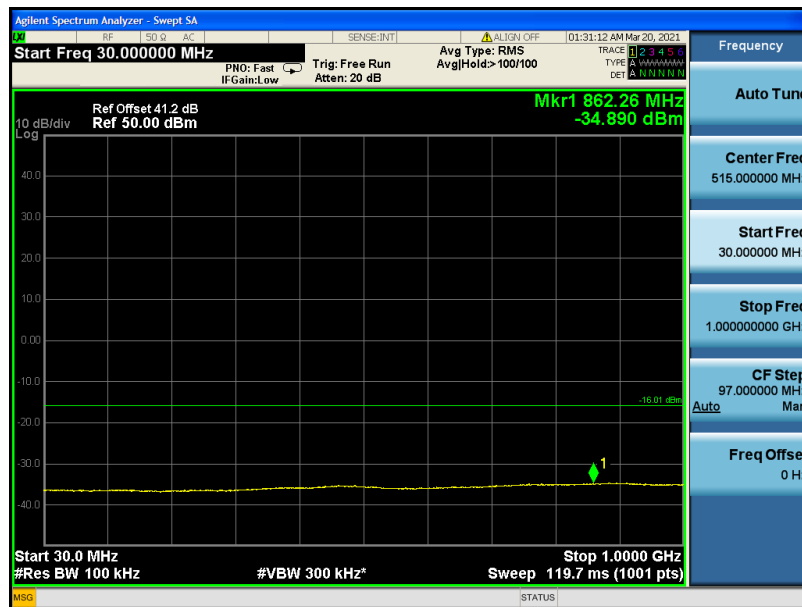
