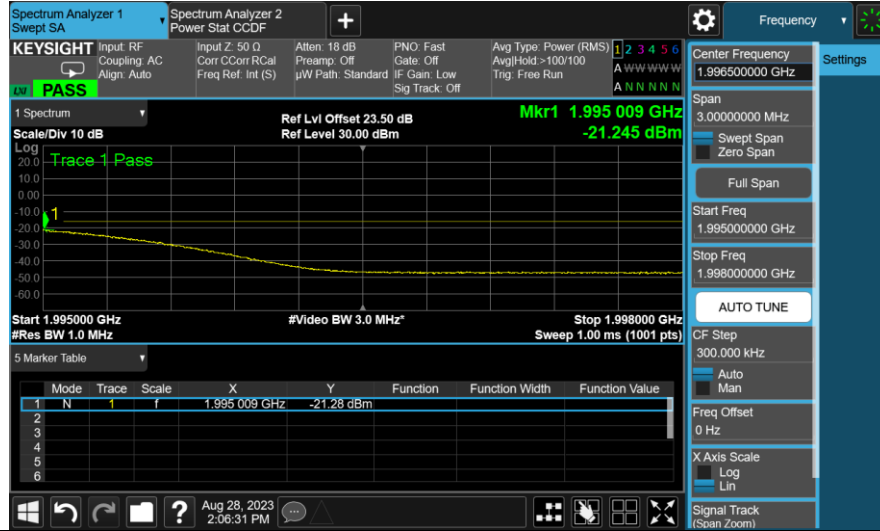


DL_1S_B_AWGN_AGC+3_Out-of-band emission

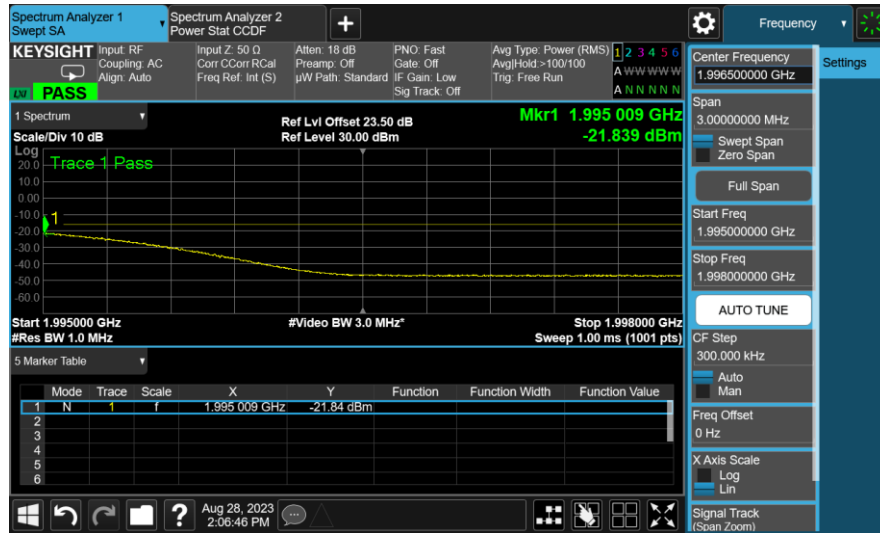

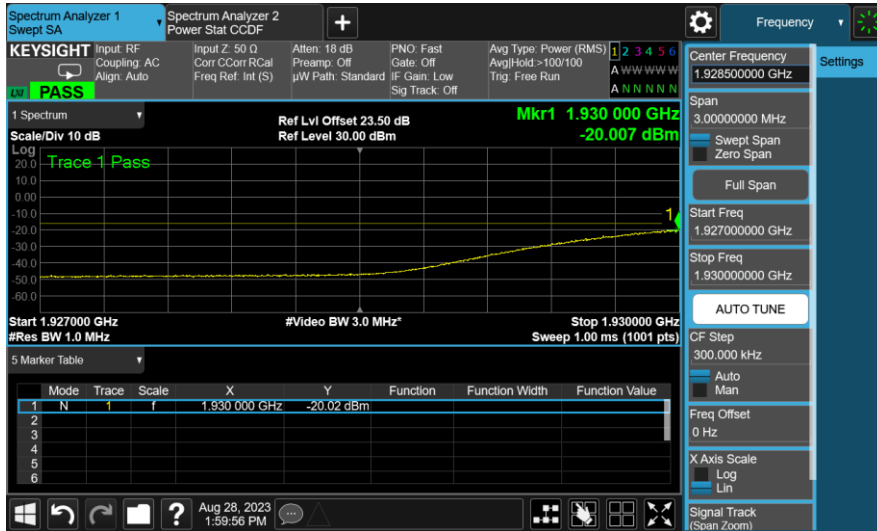


DL_1S_T_AWGN_AGC+3_Out-of-band emission

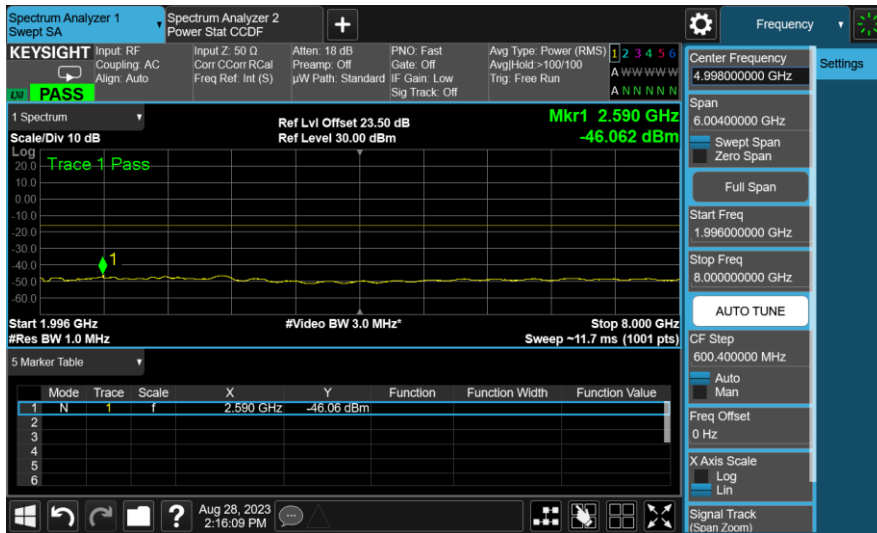


DL_1S_B_AWGN_Pre-AGC_Spurious emission 2

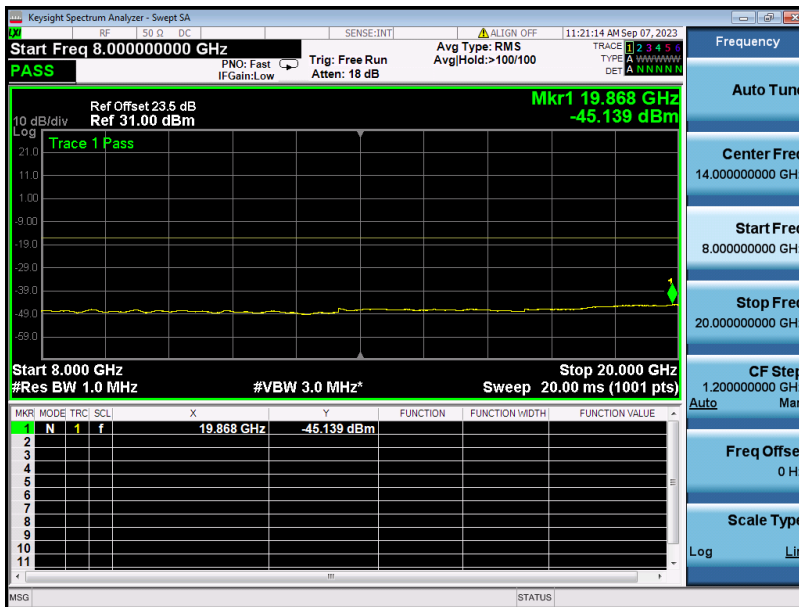
