DL_4.1MHz AWGN_MCH_Output_Pre-AGC



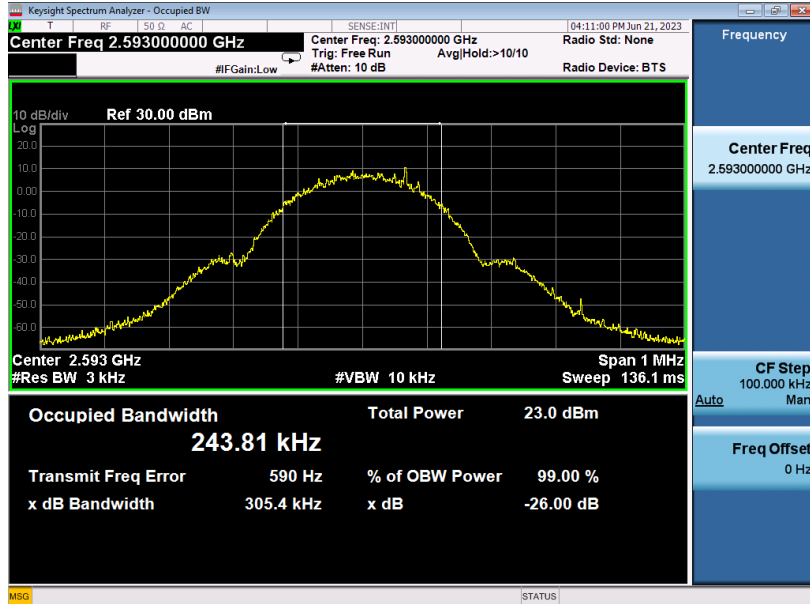
DL_4.1MHz AWGN_MCH_Output_3dB above AGC



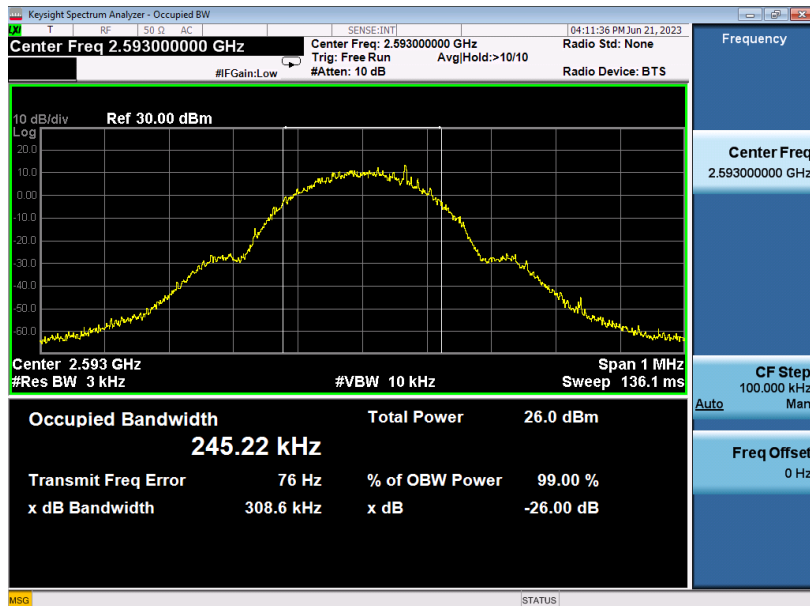

DL_4.1MHz AWGN_HCH_a single test signal_3dB above AGC

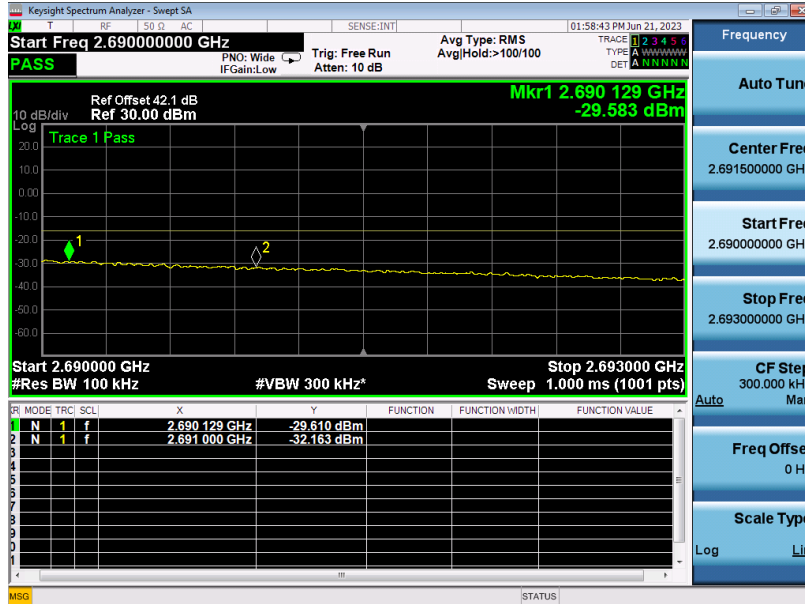

DL_100MHz AWGN_HCH_a single test signal_Pre-AGC



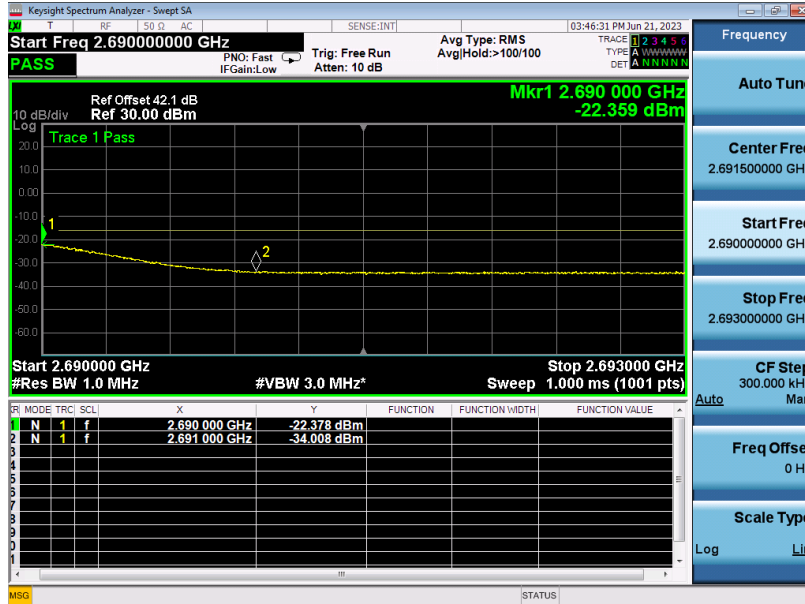
