Friis Formula

Friis transmission formula:  $P_d = (P_{out} \cdot G) / (4 \cdot \pi \cdot R^2)$

Where

$P_d$  = power density in mW/cm<sup>2</sup>

$P_{out}$  = output power to antenna in mW

G = gain of antenna in linear scale

$\pi$  = 3.1416

R = distance between observation point and center of the radiator in cm

$P_d$  is the limit of MPE, 1 mW/cm<sup>2</sup>. If we know the maximum gain of the antenna and the total power input to the antenna, through the calculation, we will know the distance r where the MPE limit is reached.

The distancer (4th column) calculated from the Fries transmission formula is far greater than 31 cm separation requirement.

So the limit of Band 788 - 805MHz=  $788/1500 = 0.5253\text{mW/cm}^2$ ;
