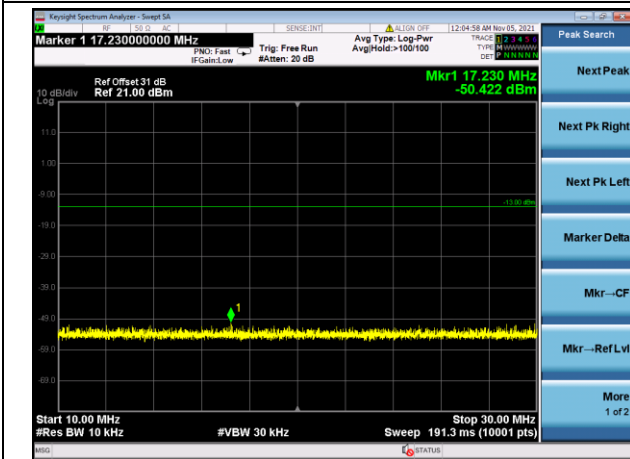
9-150KHz



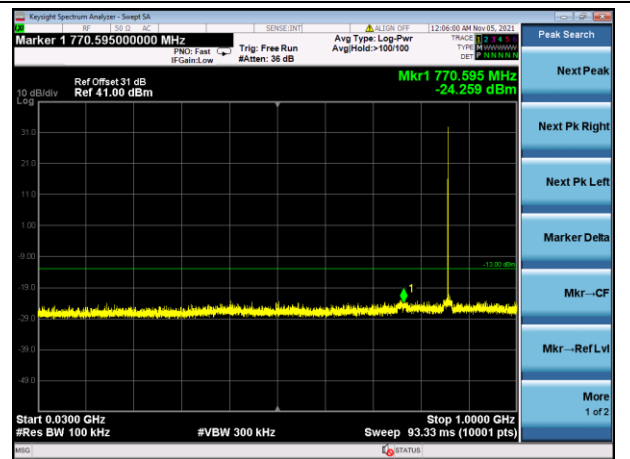
150KHz-10MHz



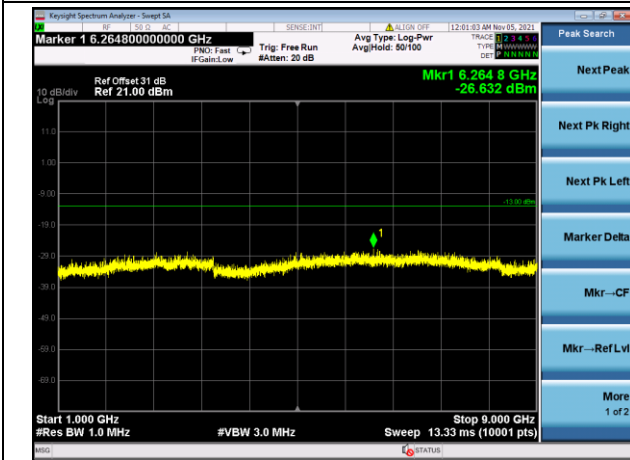
10-30MHz



30-1000MHz



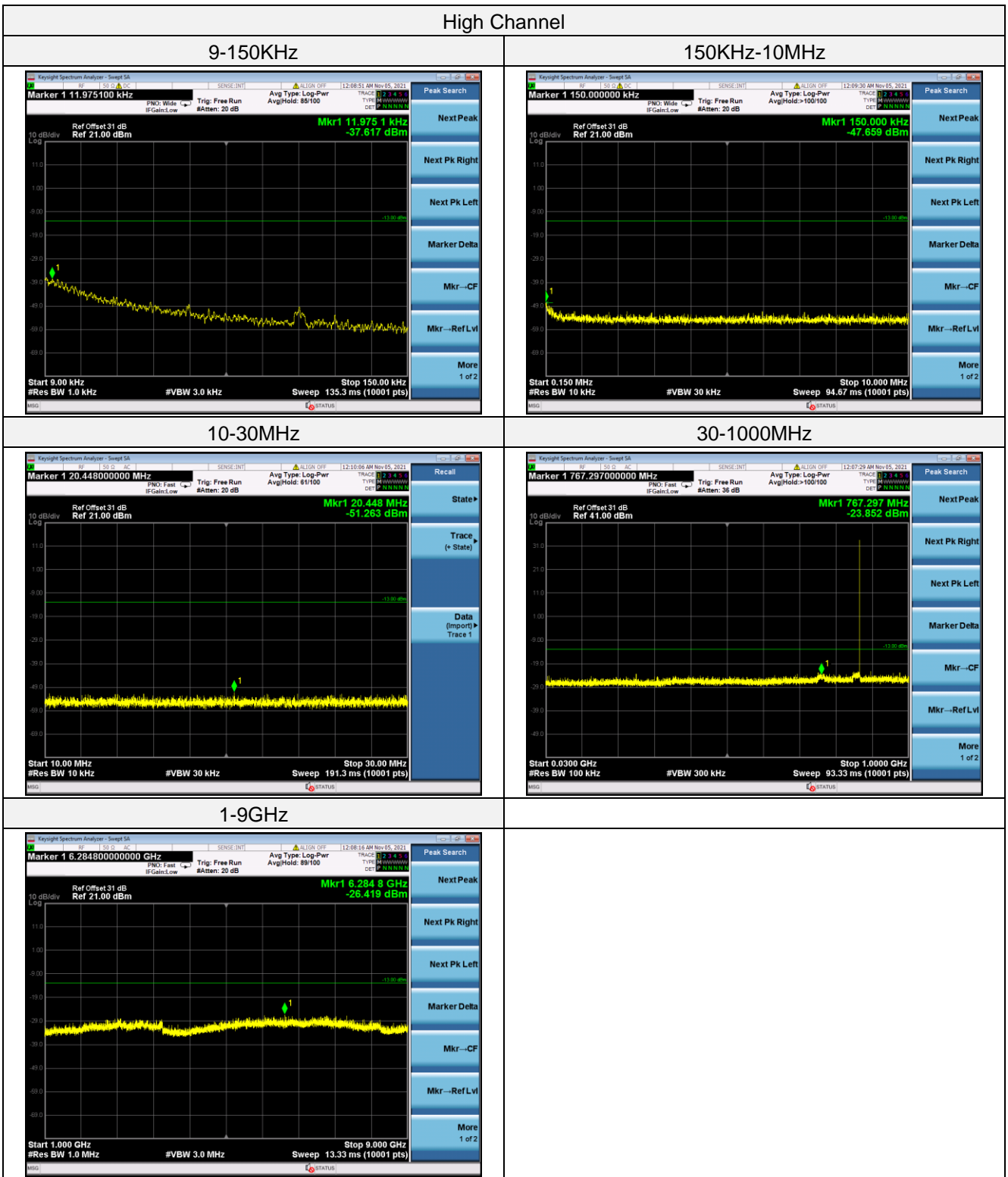
