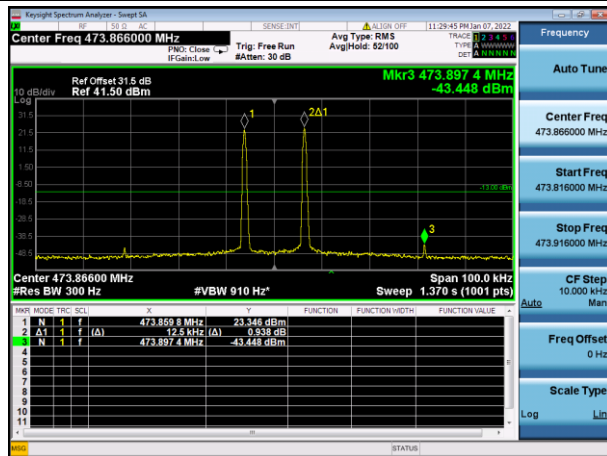

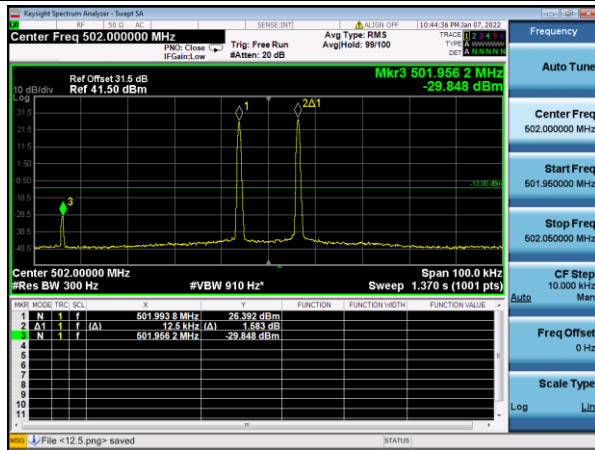


3dB above AGC

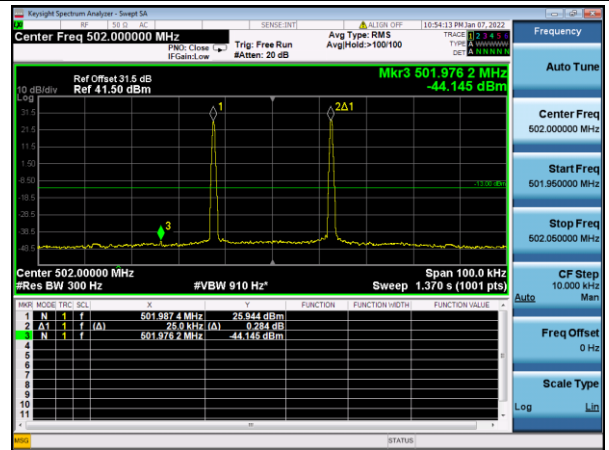
