Friis Formula

Friis transmission formula: $P_d = (P_{out} \cdot G) / (4 \cdot \pi \cdot R^2)$

Where

P_d = power density in mW/cm²

P_{out} = output power to antenna in mW

G = gain of antenna in linear scale

π = 3.1416

R = distance between observation point and center of the radiator in cm

P_d is the limit of MPE, 1 mW/cm². If we know the maximum gain of the antenna and the total power input to the antenna, through the calculation, we will know the distance r where the MPE limit is reached.

The distancer (4th column) calculated from the Fries transmission formula is far greater than 395 cm separation requirement.

So the limit of LTE Band 26 is $859/1500 = 0.5727\text{mW/cm}^2$;

To satisfy RF exposure requirements, a separation distance of 395cm or more should be maintained between this device and persons during device operation. To ensure compliance, operations at closer than this distance is not recommended.
