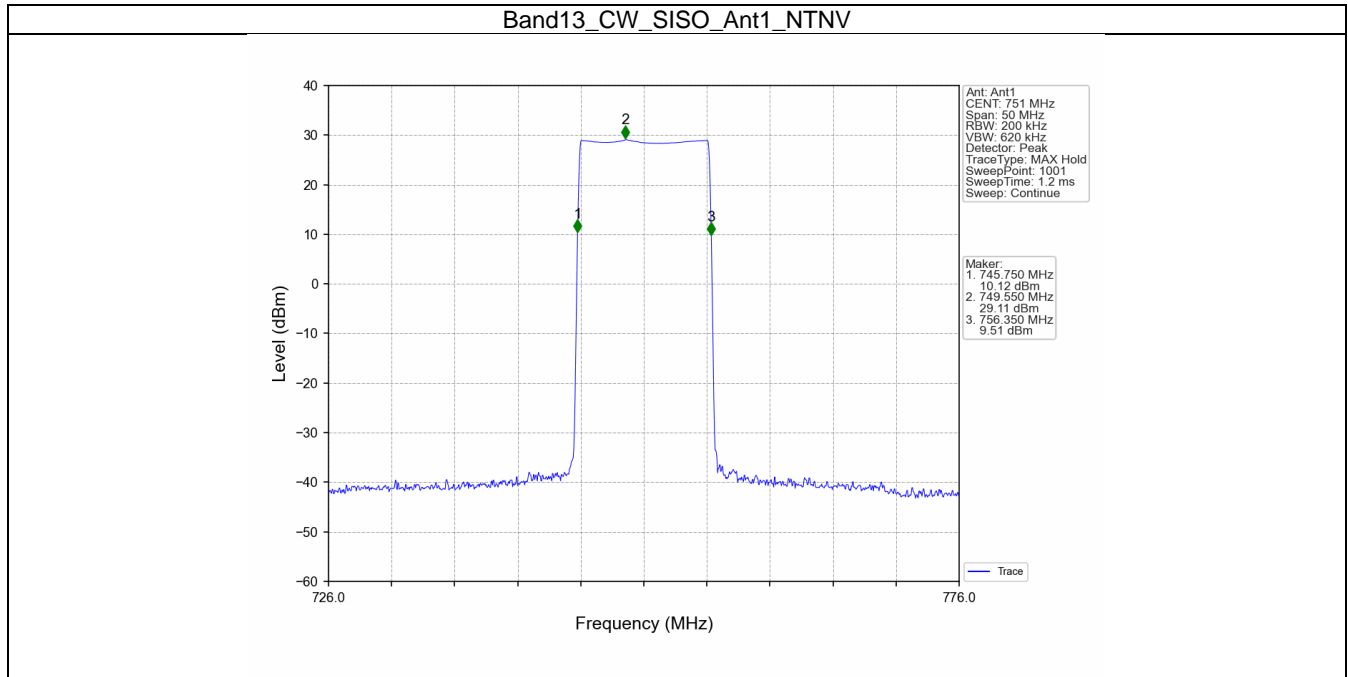

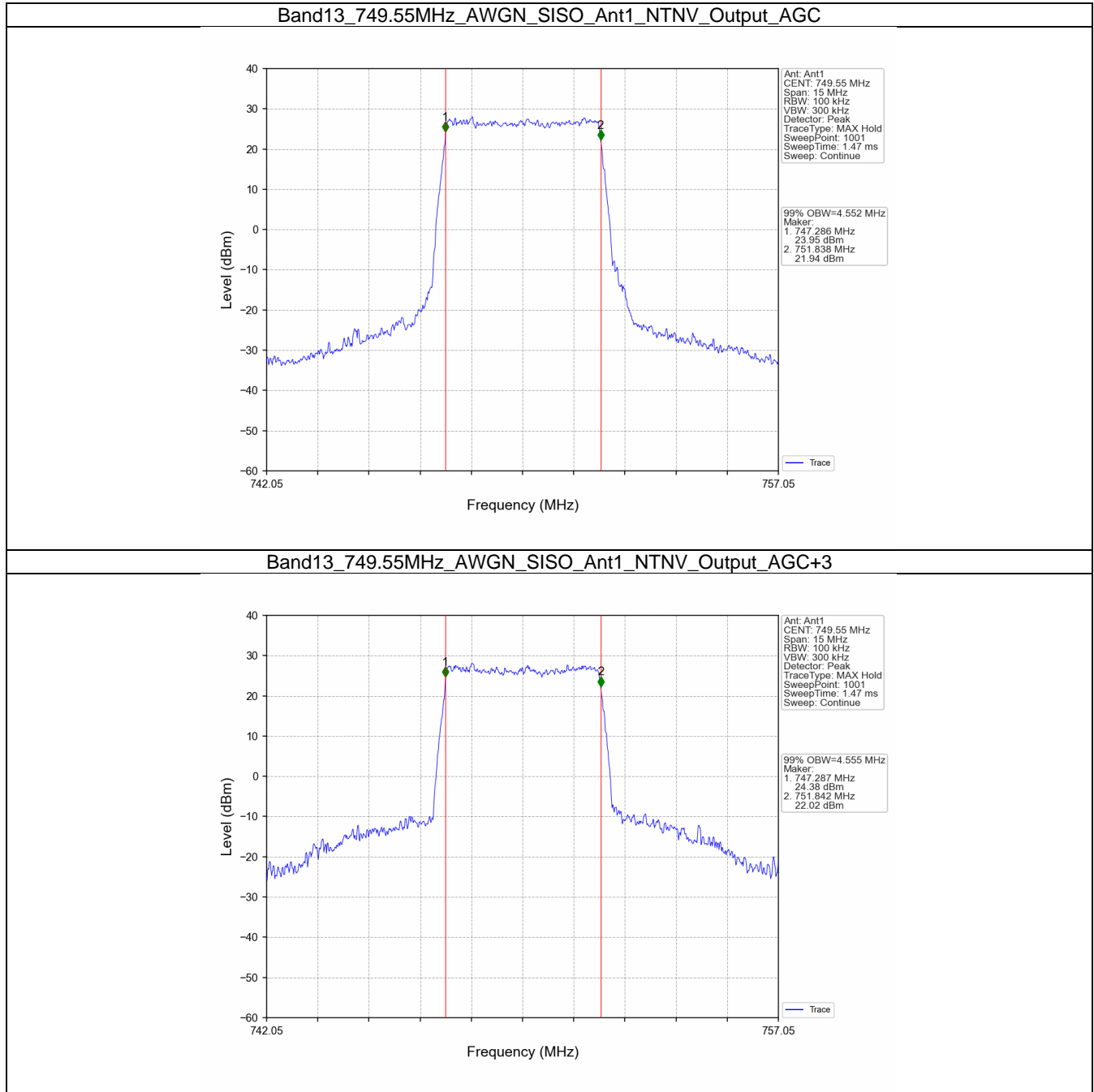

For LTE Band 13



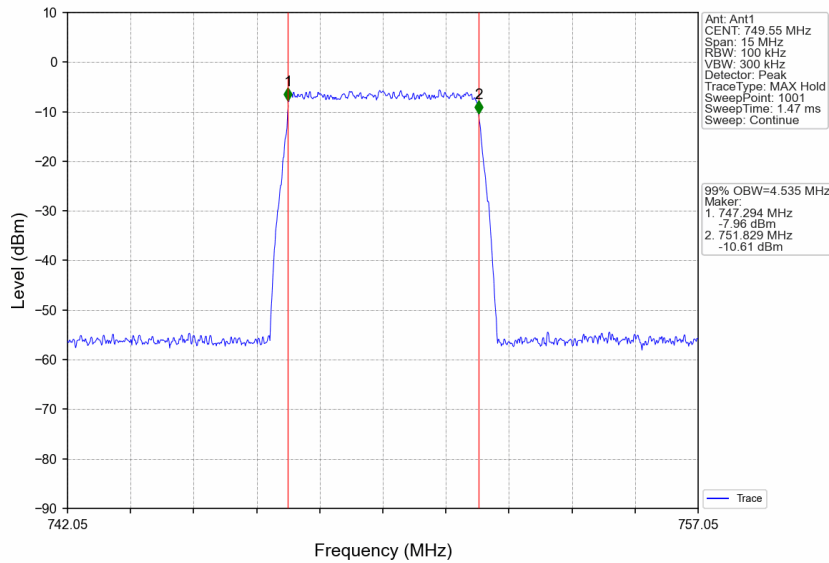
