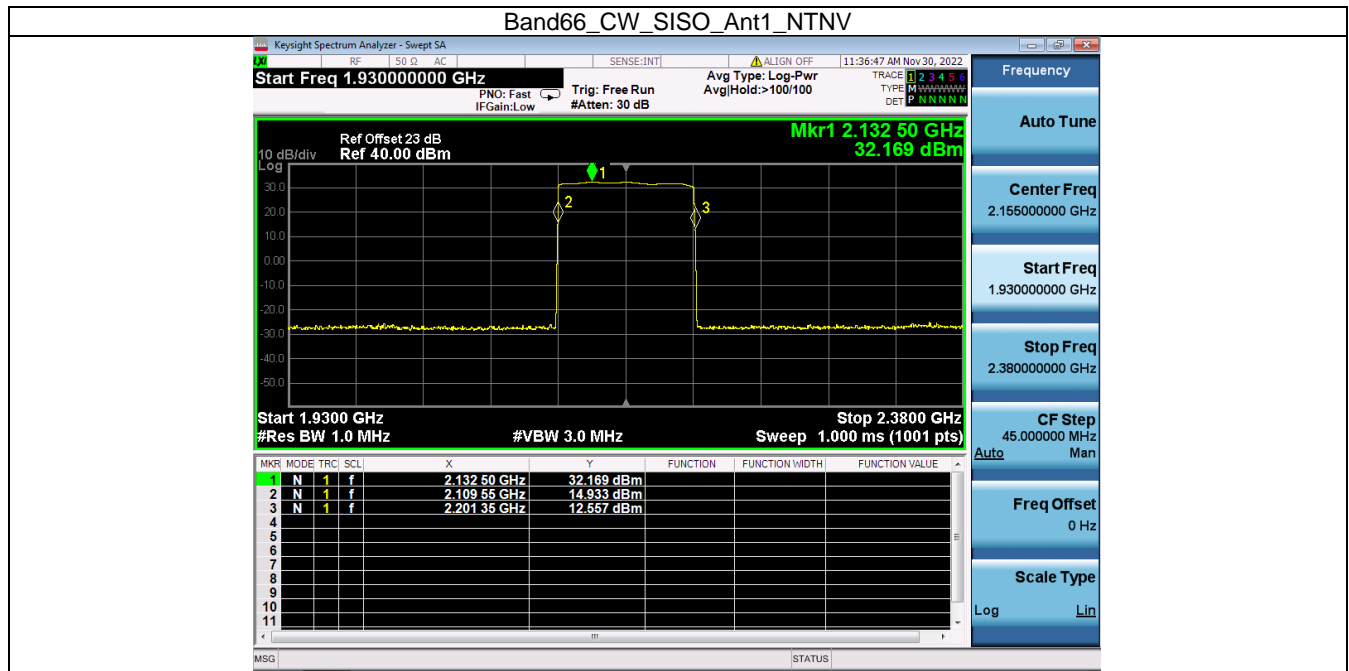

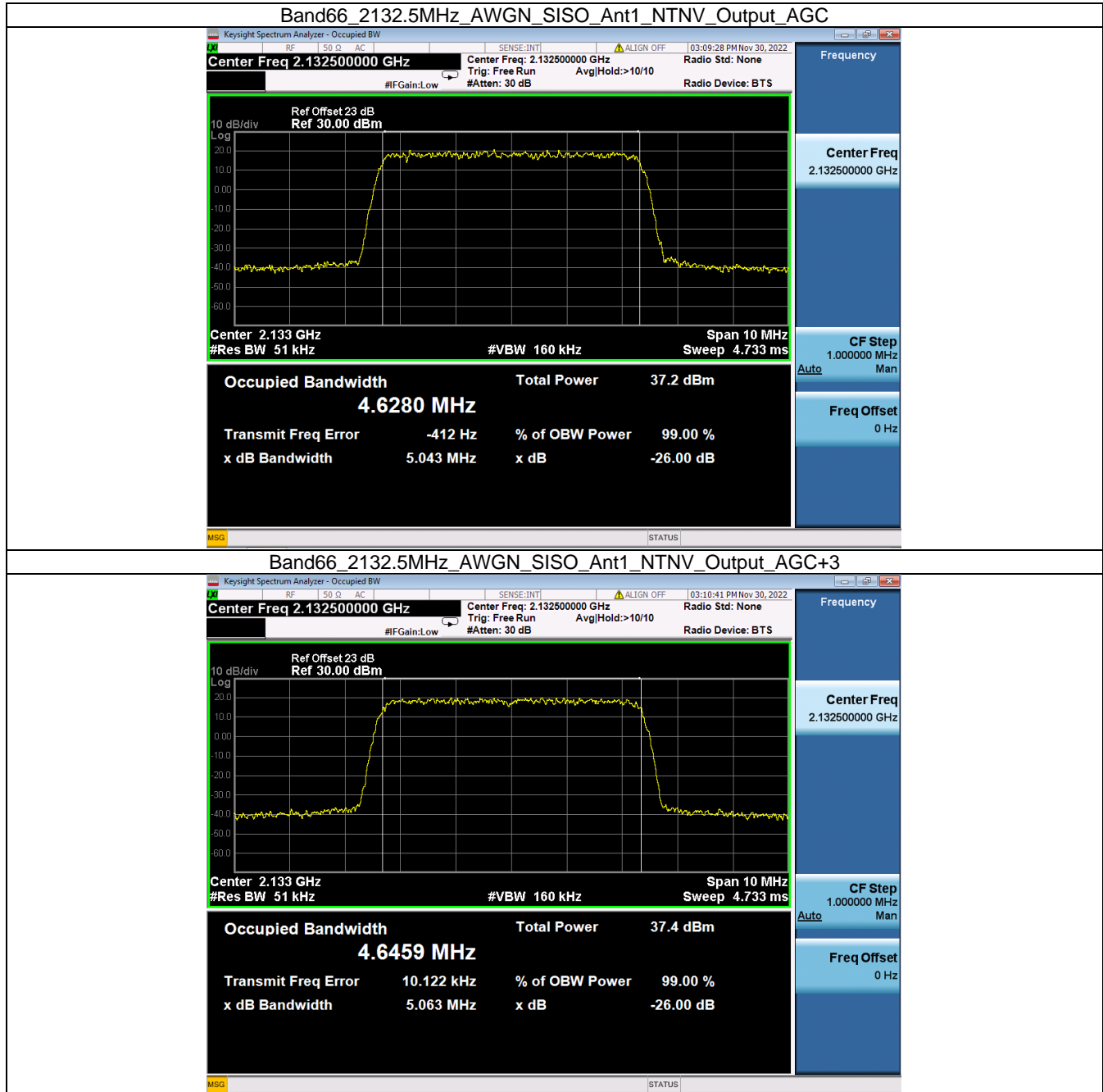

For LTE Band 66



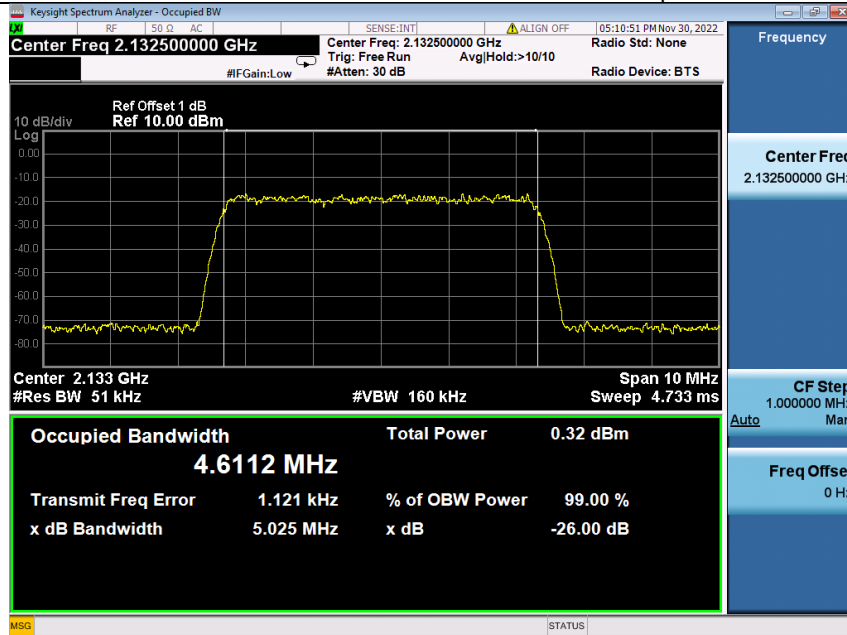
