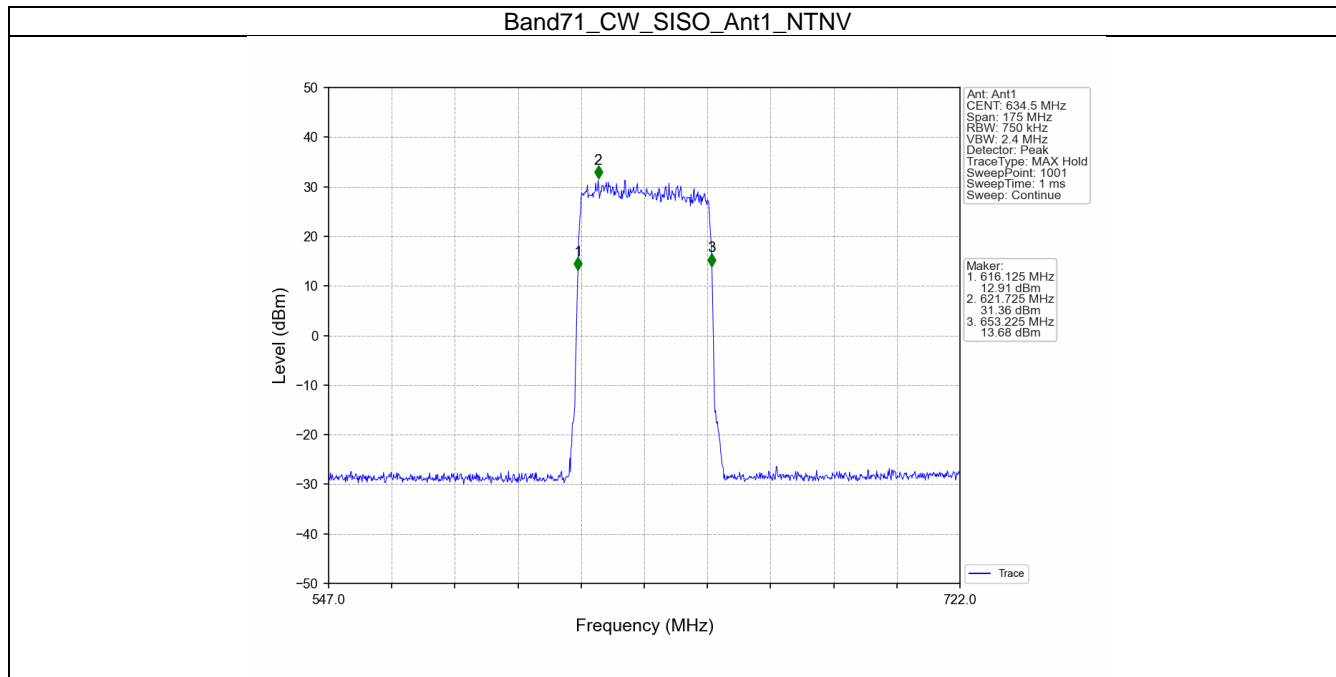

For LTE Band 71



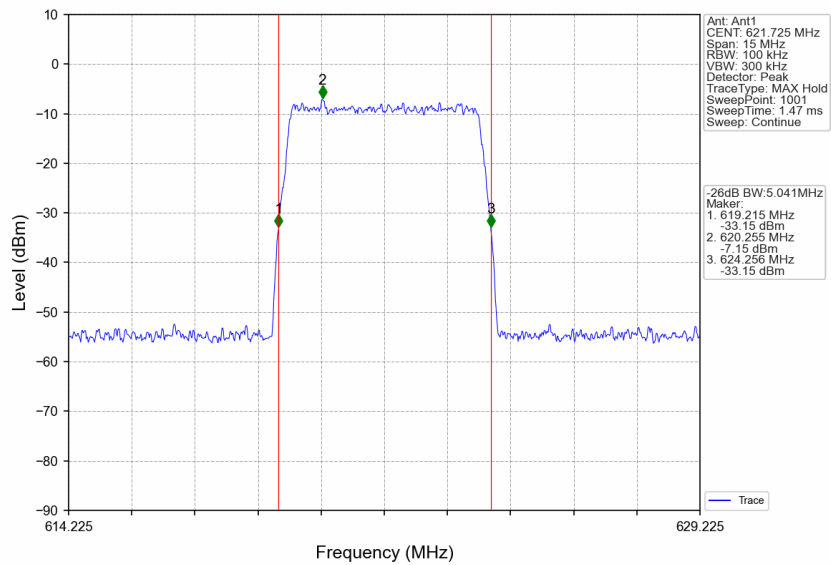
