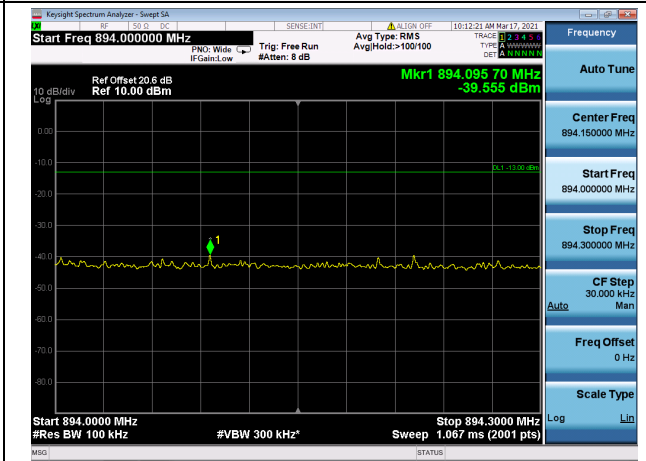
Pre-AGC \_ Up Edge

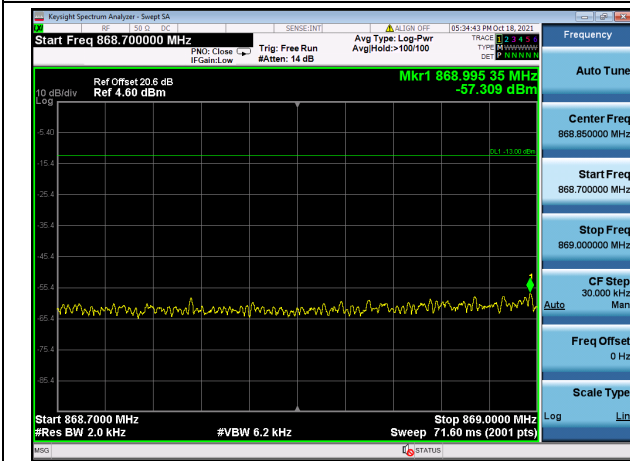

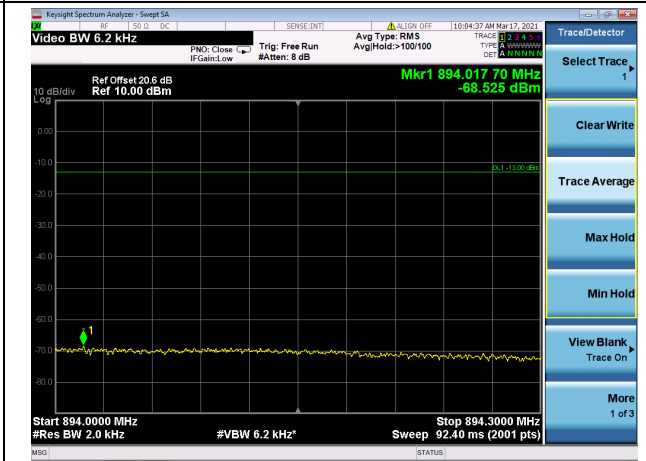
Pre-AGC \_ Up Edge

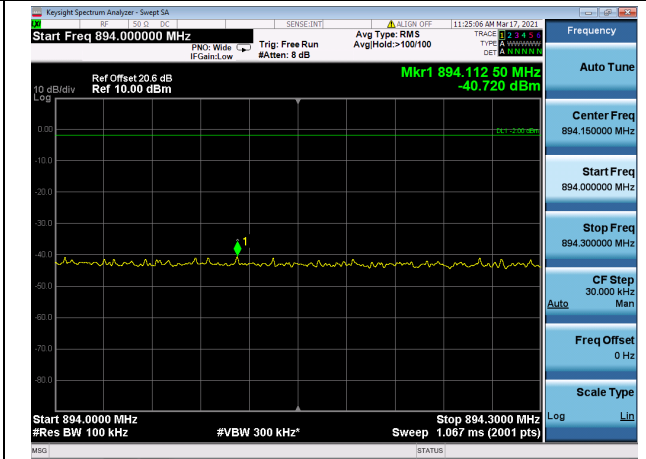
Pre-AGC \_ Up Edge

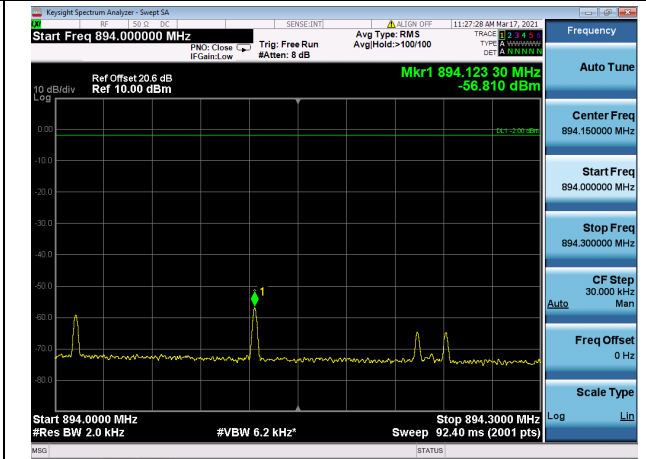
Pre-AGC \_ Up Edge
