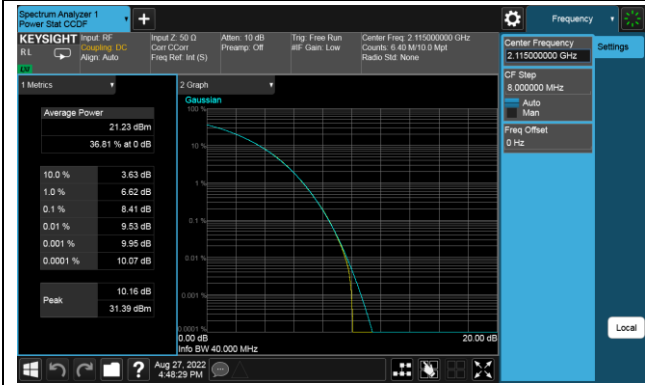

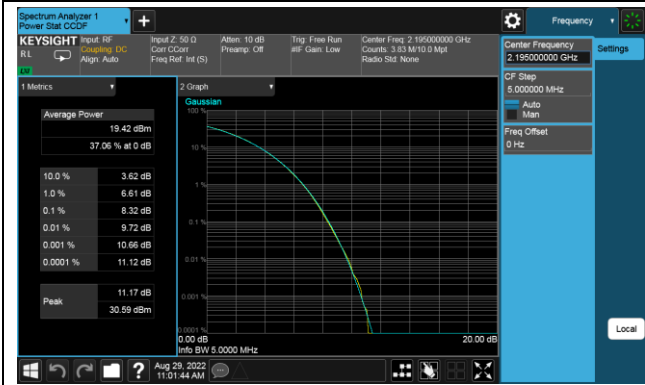
QPSK Low channel

QPSK High channel

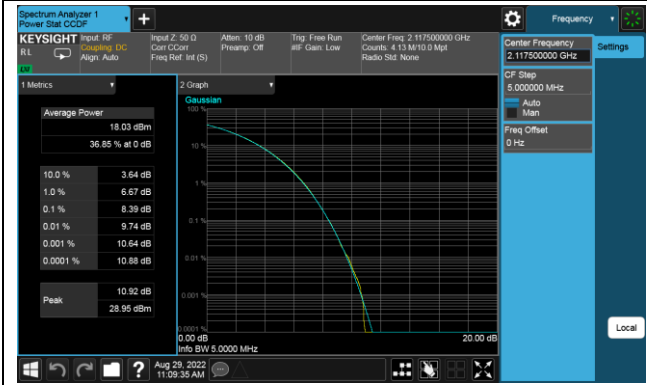

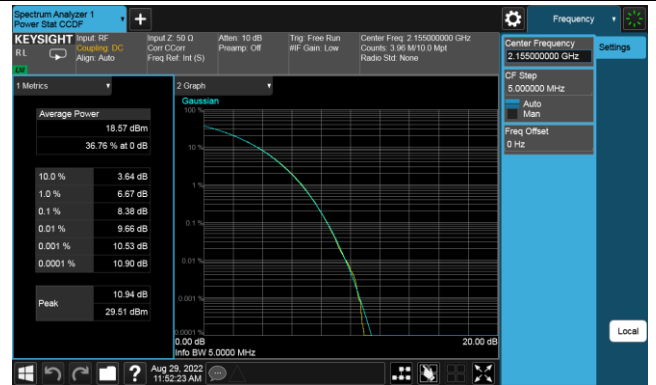

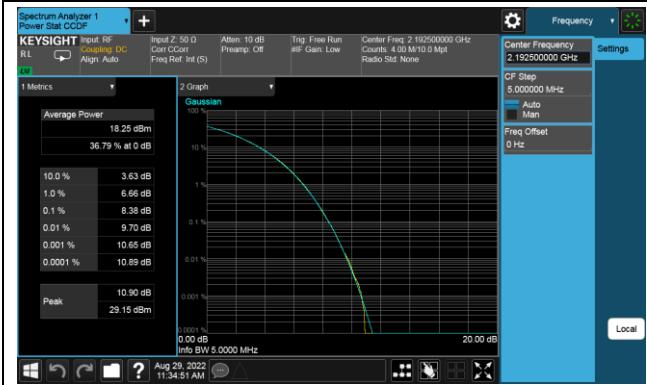
QPSK Low channel

QPSK High channel

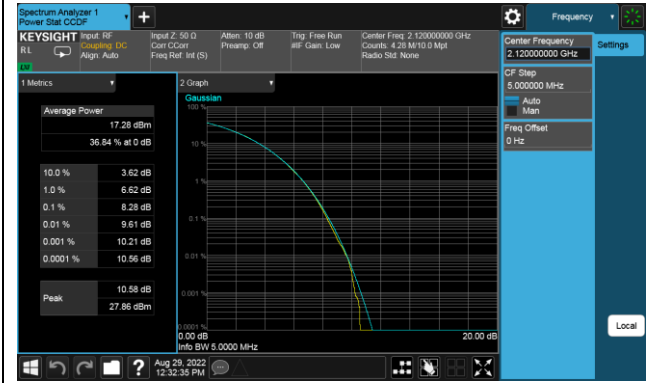

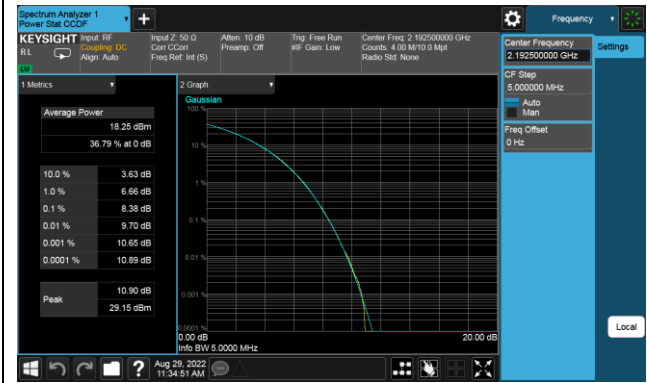
QPSK Low channel

QPSK High channel

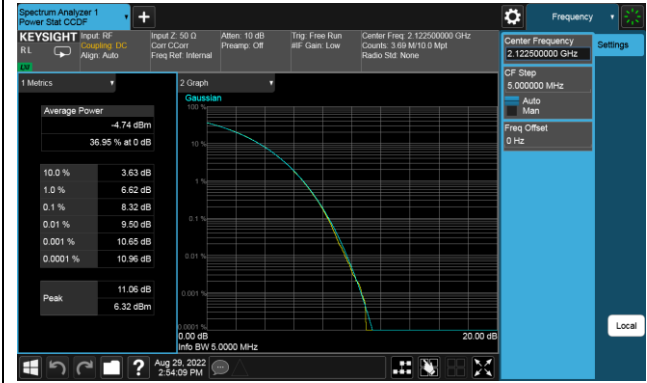

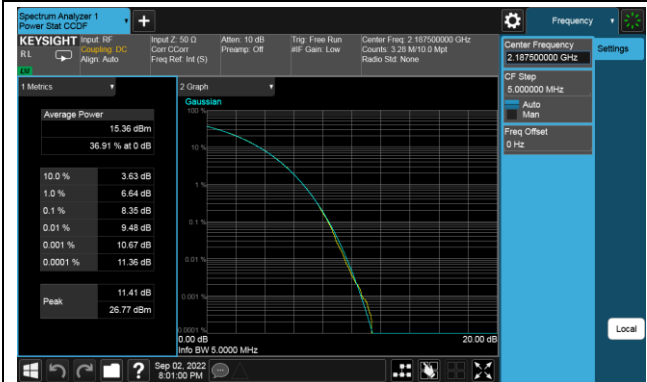
QPSK Low channel



QPSK Middle channel

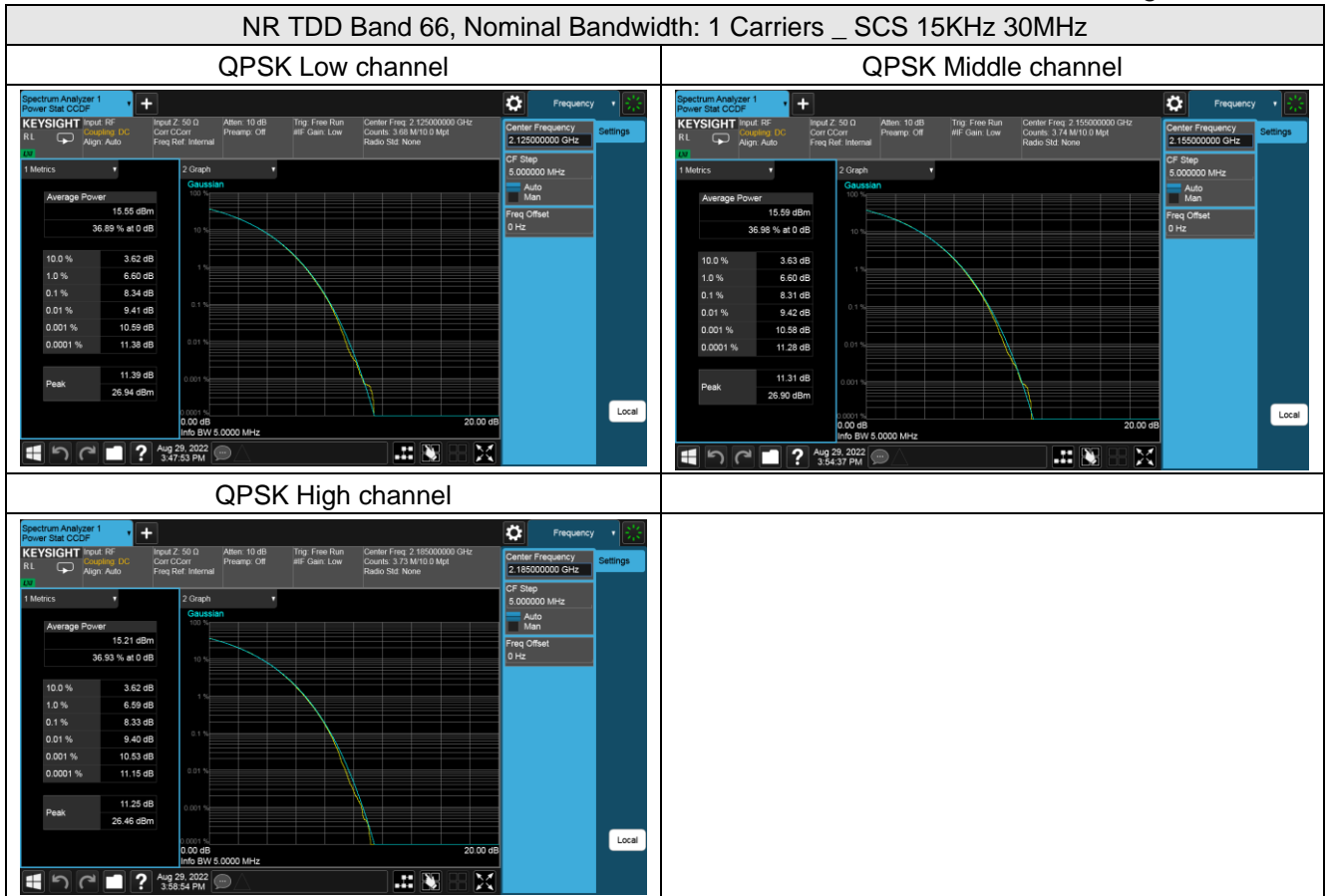

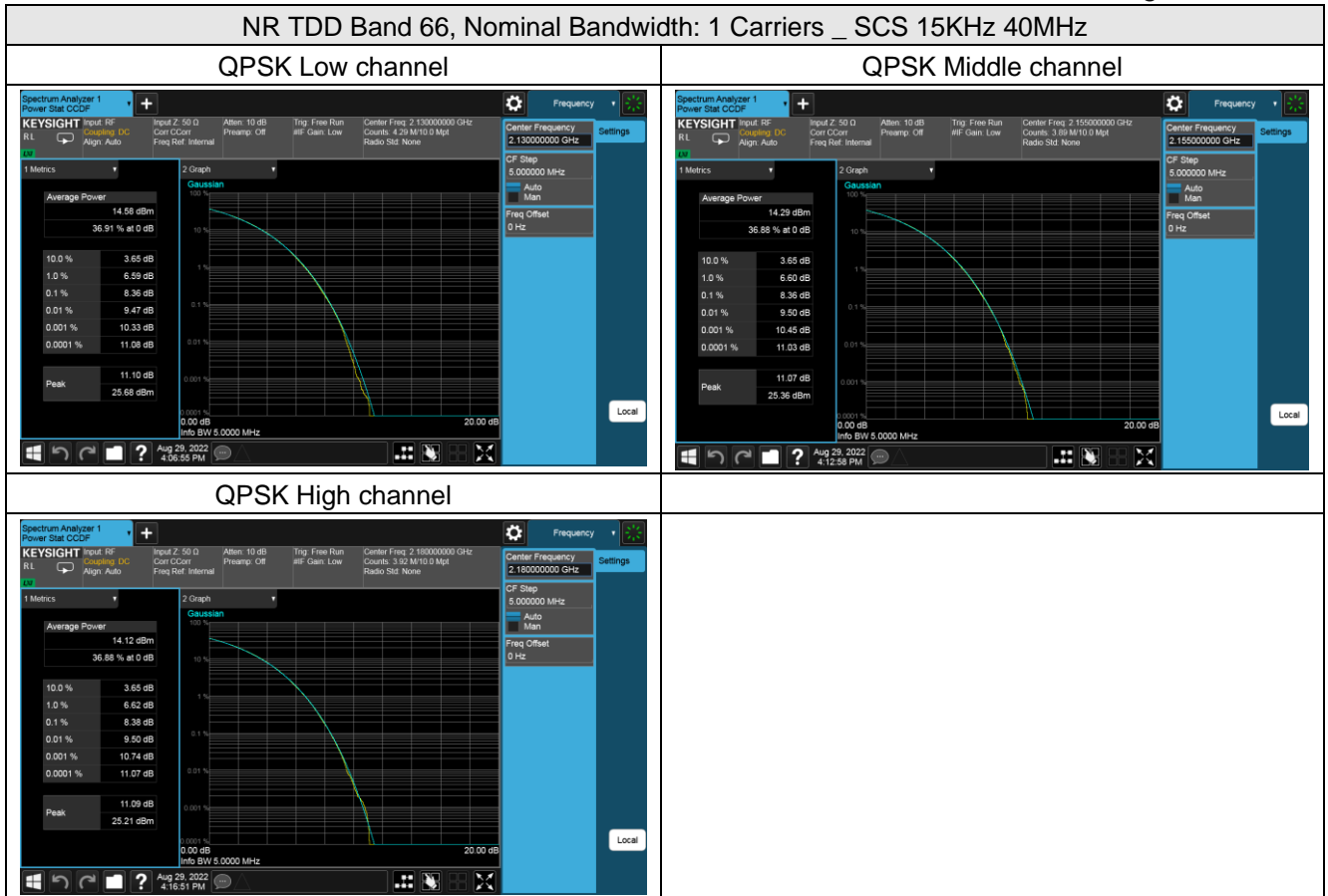
