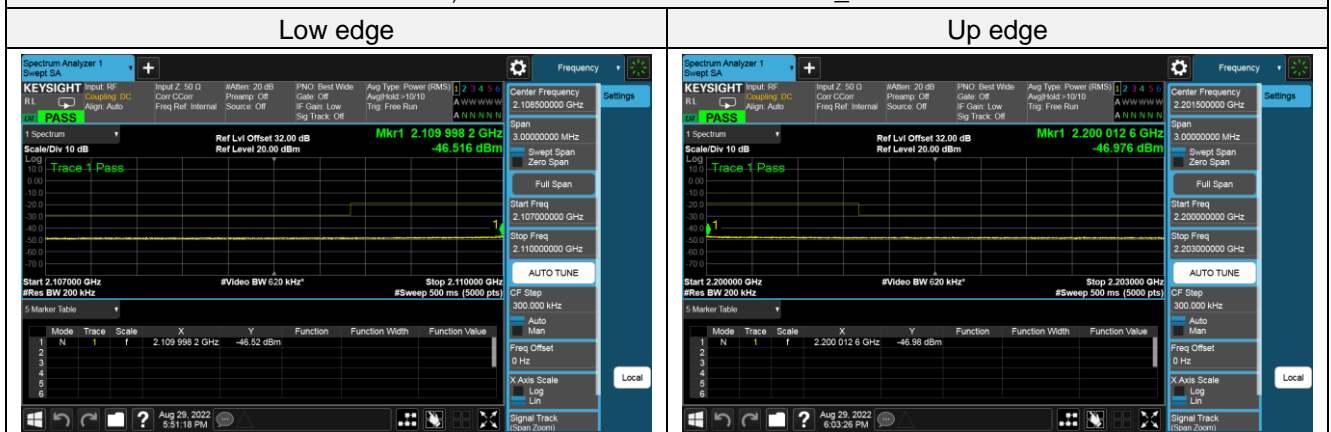
NR TDD Band 66, Nominal Bandwidth: 1 Carriers _ SCS 15KHz 40MHz

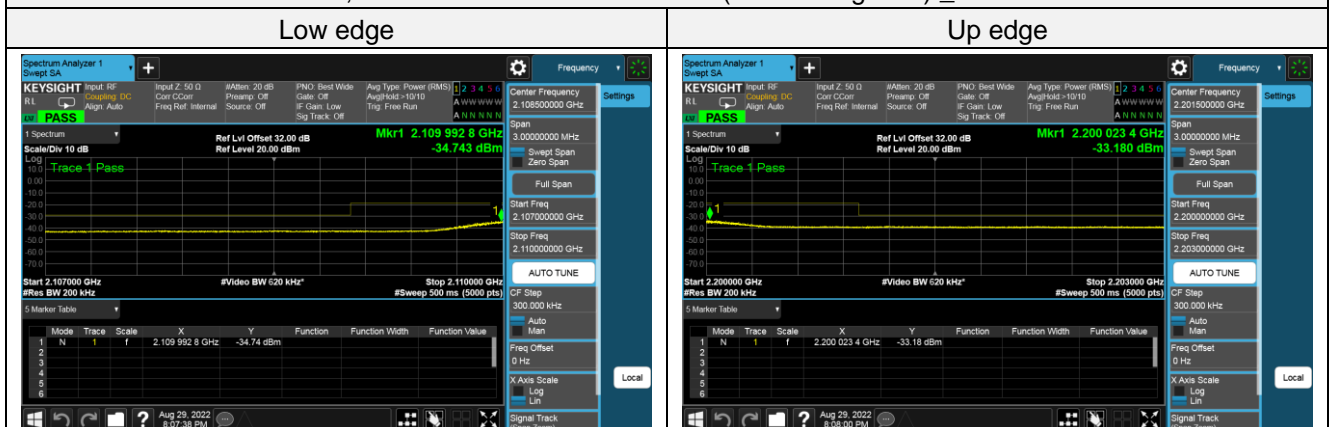
