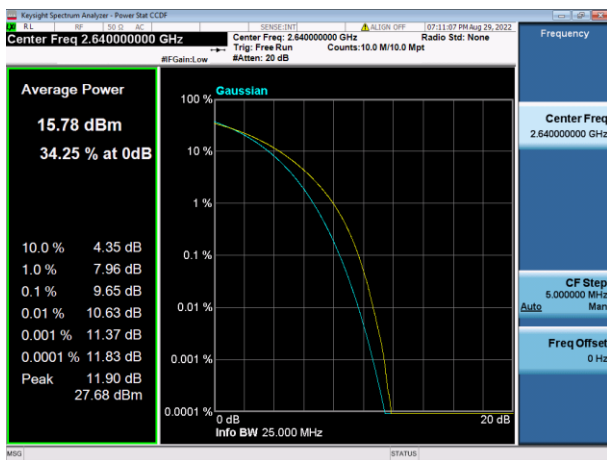
QPSK Low channel

QPSK High channel

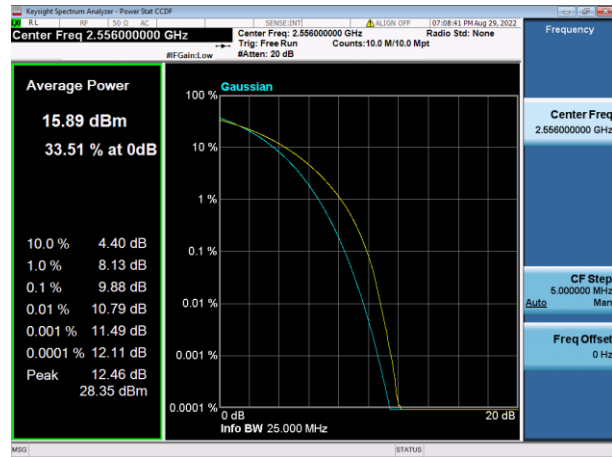

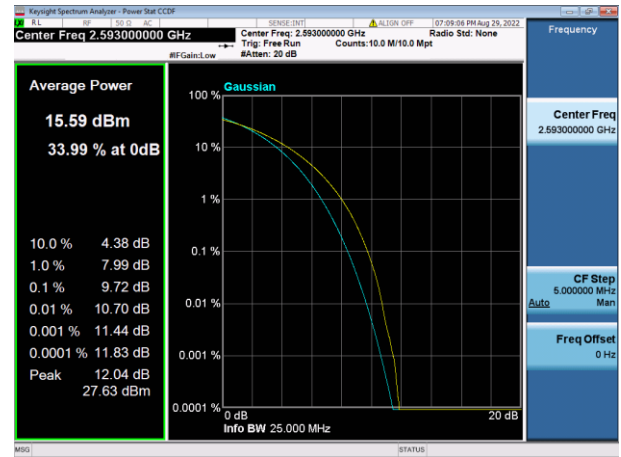

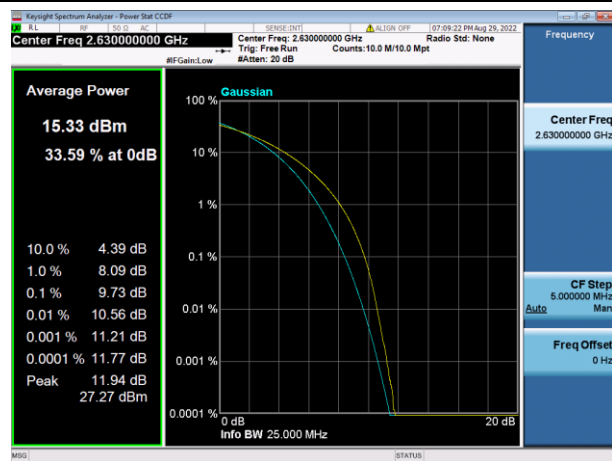
