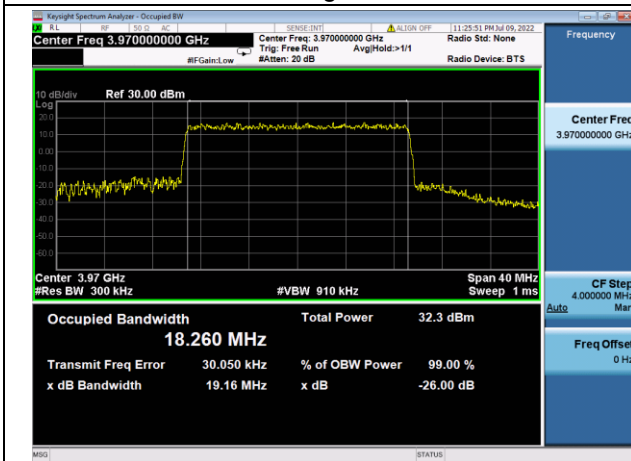
QPSK Low channel
