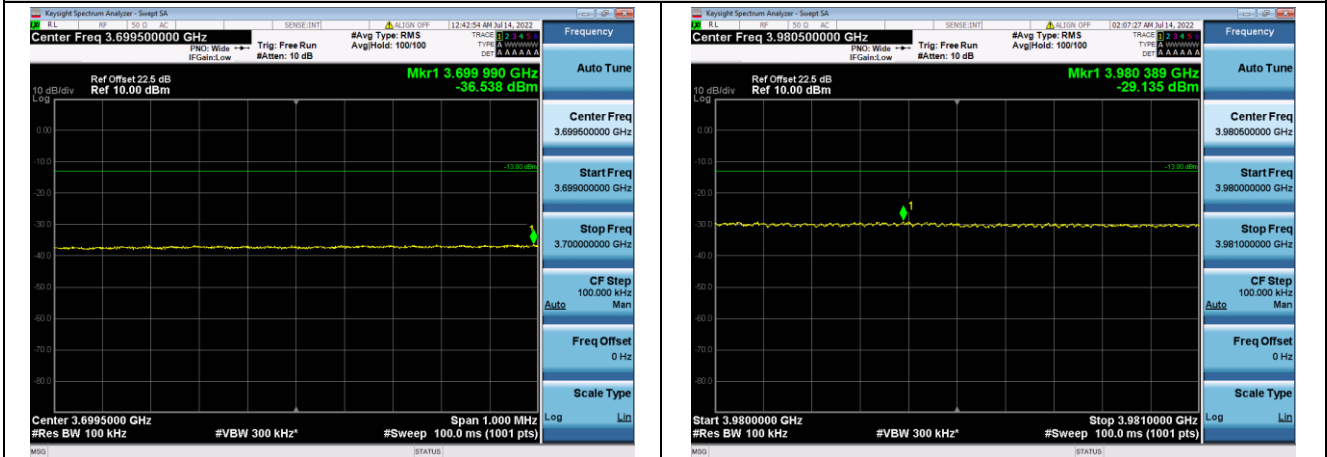

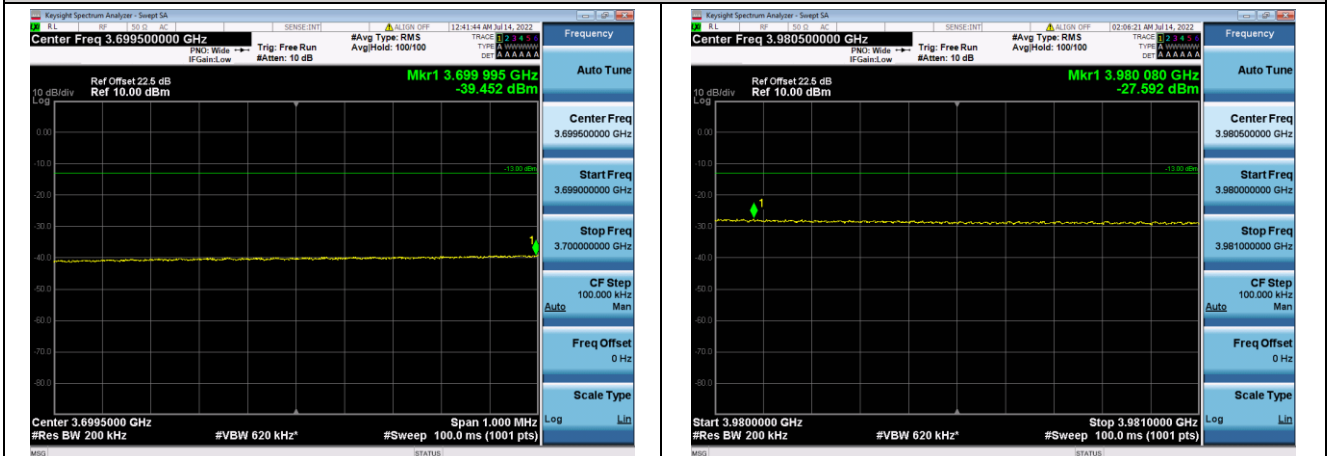

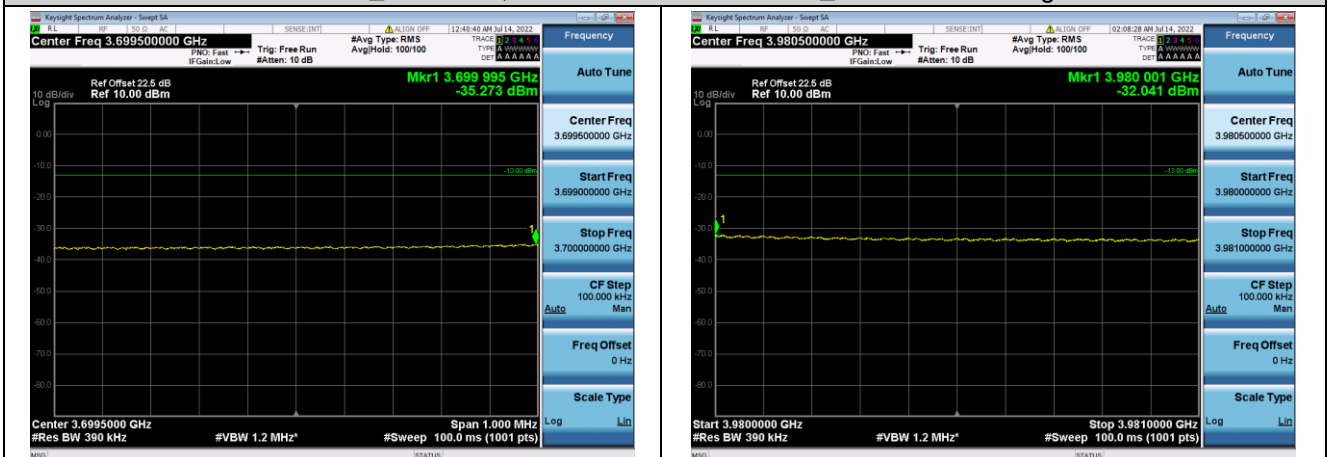
5G NR Band n77 \_ SCS 30K, Nominal Bandwidth: 10M \_ Low channel+ High channel



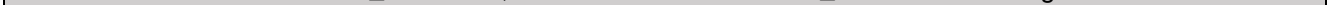
5G NR Band n77 \_ SCS 30K, Nominal Bandwidth: 20M \_ Low channel+ High channel



5G NR Band n77 \_ SCS 30K, Nominal Bandwidth: 40M \_ Low channel+ High channel

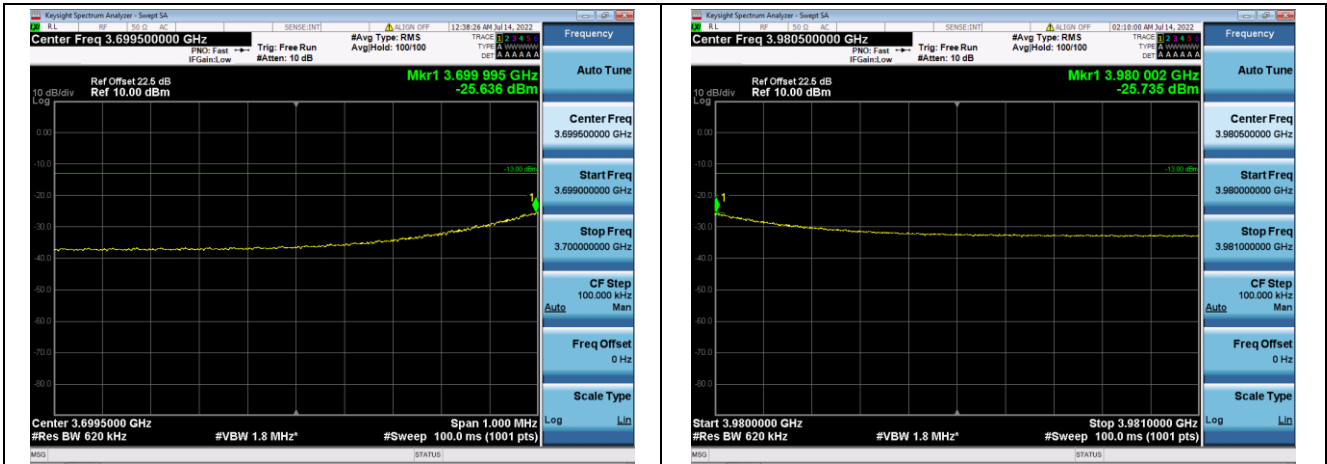


5G NR Band n77 \_ SCS 30K, Nominal Bandwidth: 60M \_ Low channel+ High channel

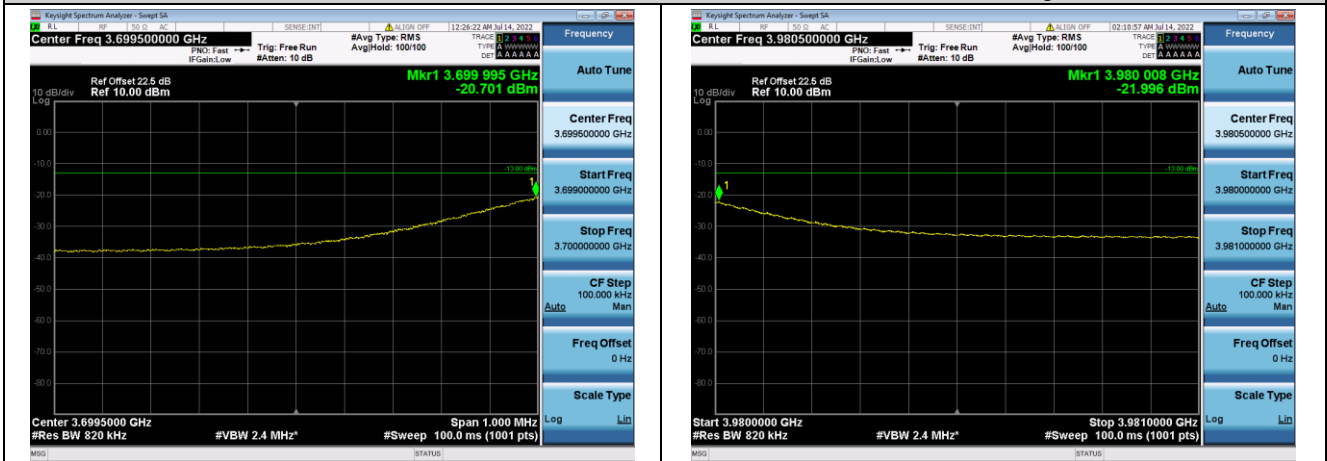

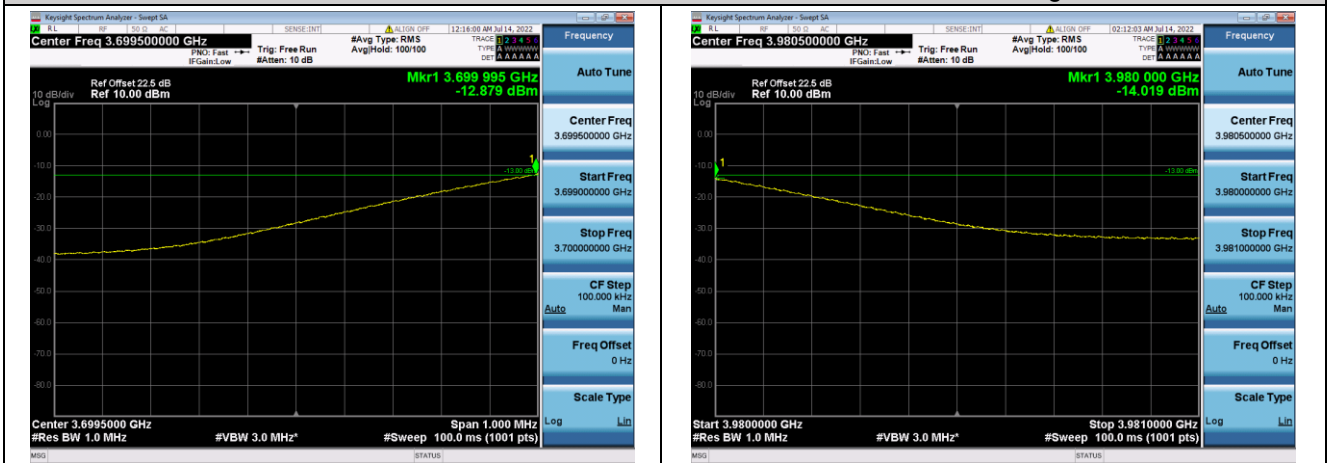

5G NR Band n77 \_ SCS 30K, Nominal Bandwidth: 80M \_ Low channel+ High channel

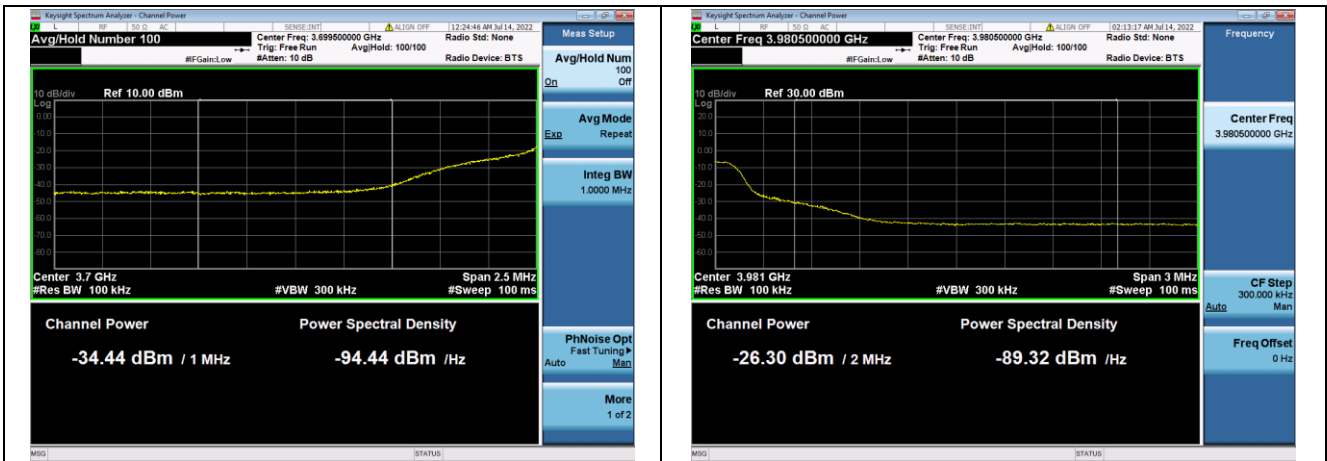


5G NR Band n77 \_ SCS 30K, Nominal Bandwidth: 100M \_ Low channel+ High channel

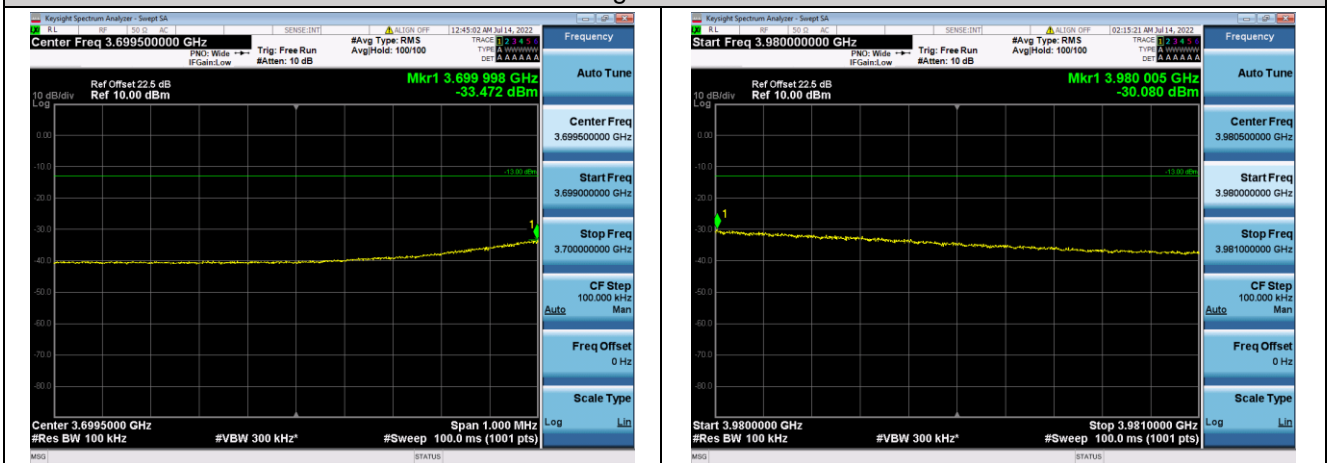
