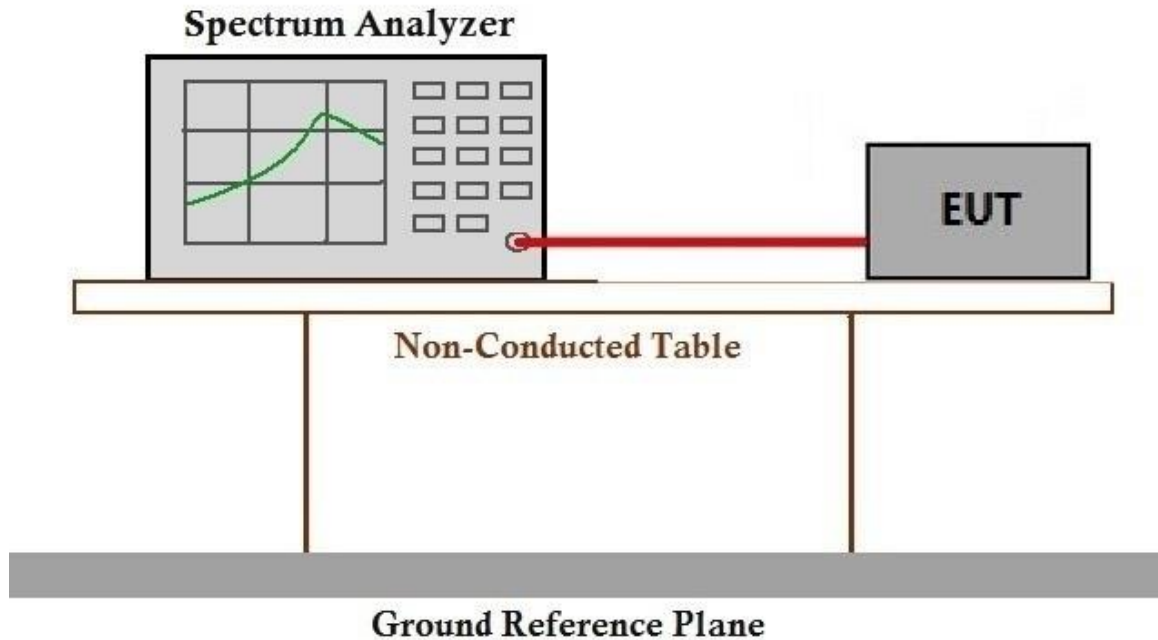

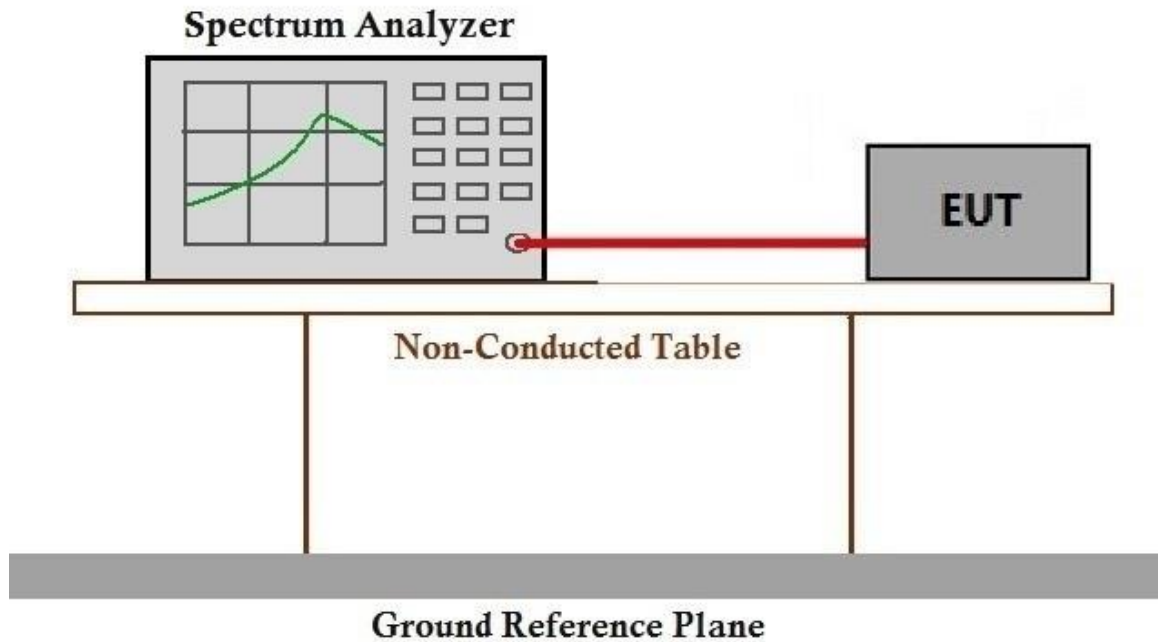

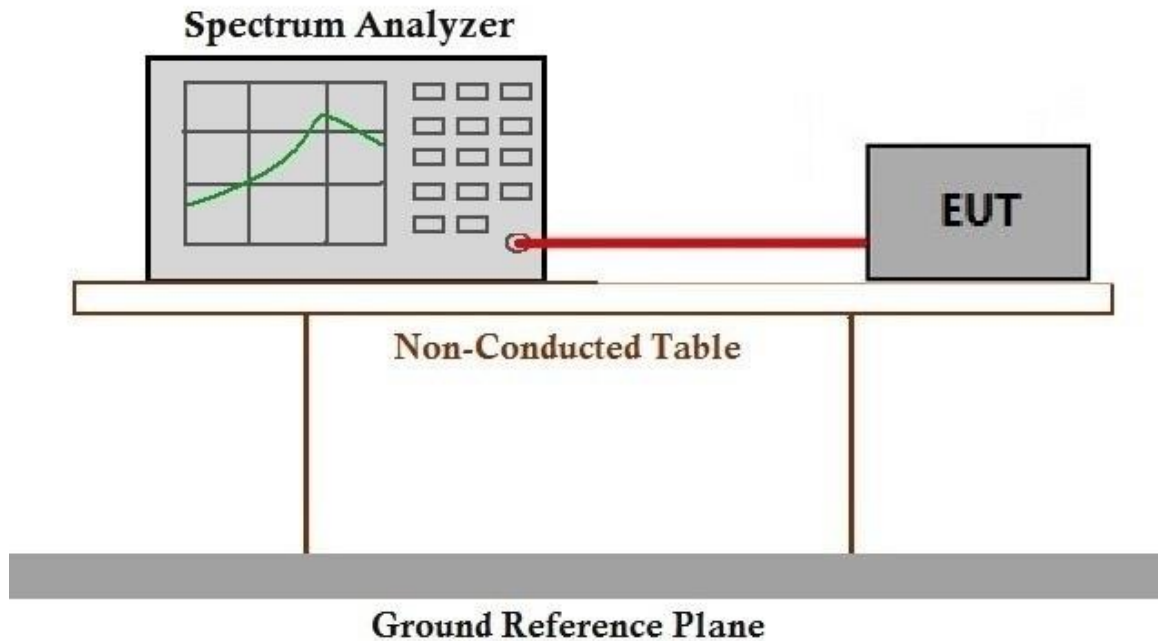

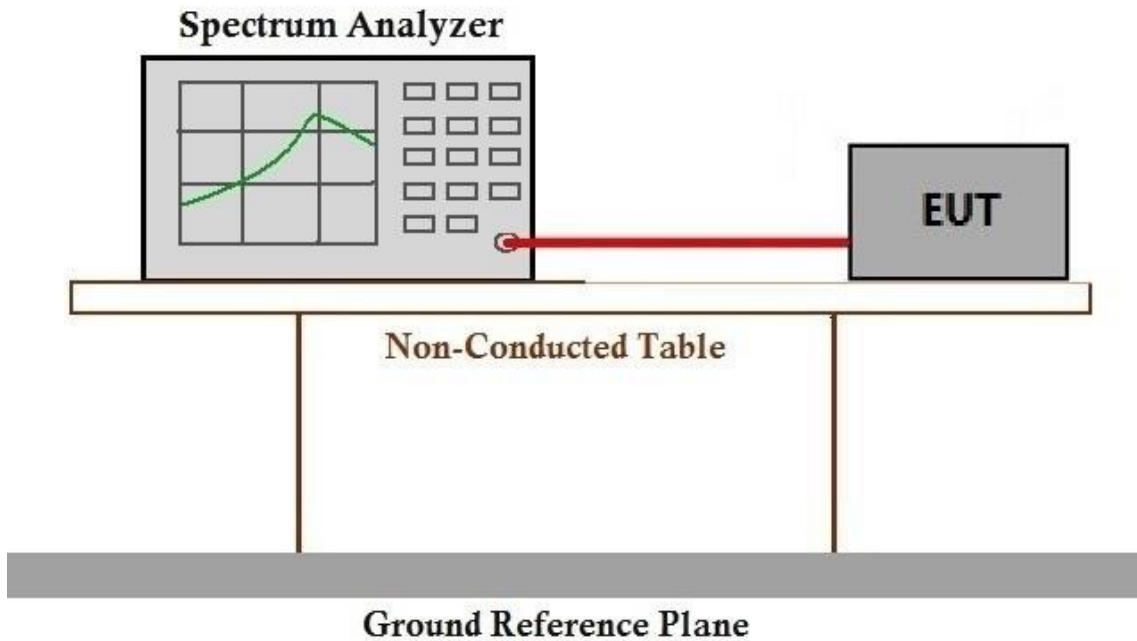

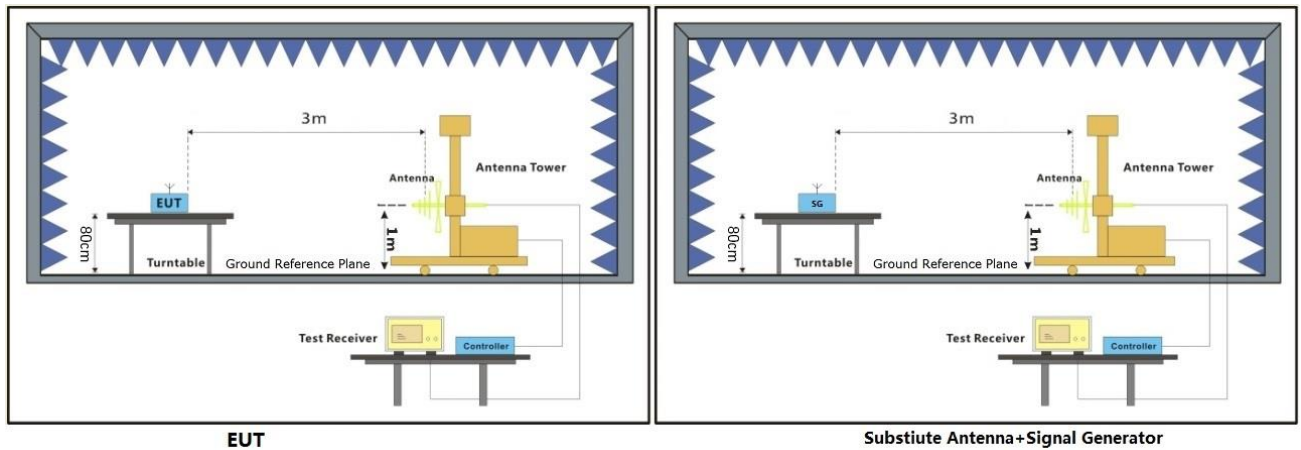

### 6.6.3 Measurement Procedure and Data

#### Test Procedure:

- (1) On a test site, the EUT shall be placed on a turntable and in the position closest to the normal use as declared by the user.
- (2) The test antenna shall be oriented initially for vertical polarization located 3m from the EUT to correspond to the transmitter.
- (3) The output of the antenna shall be connected to the measuring receiver and either a peak or quasi-peak detector was used for the measurement as indicated on the report. The detector selection is based on how close the emission level was approaching the limit.
- (4) The transmitter shall be switched on; if possible, without the modulation and the measurement receiver shall be tuned to the frequency of the transmitter under test.
- (5) The test antenna shall be raised and lowered through the specified range of height until the measuring receiver detects a maximum signal level.
- (6) The transmitter shall then be rotated through 360° in the horizontal plane, until the maximum signal level is detected by the measuring receiver.
- (7) The test antenna shall be raised and lowered again through the specified range of height until the measuring receiver detects a maximum signal level.
- (8) The maximum signal level detected by the measuring receiver shall be noted.
- (9) The measurement shall be repeated with the test antenna set to horizontal polarization.

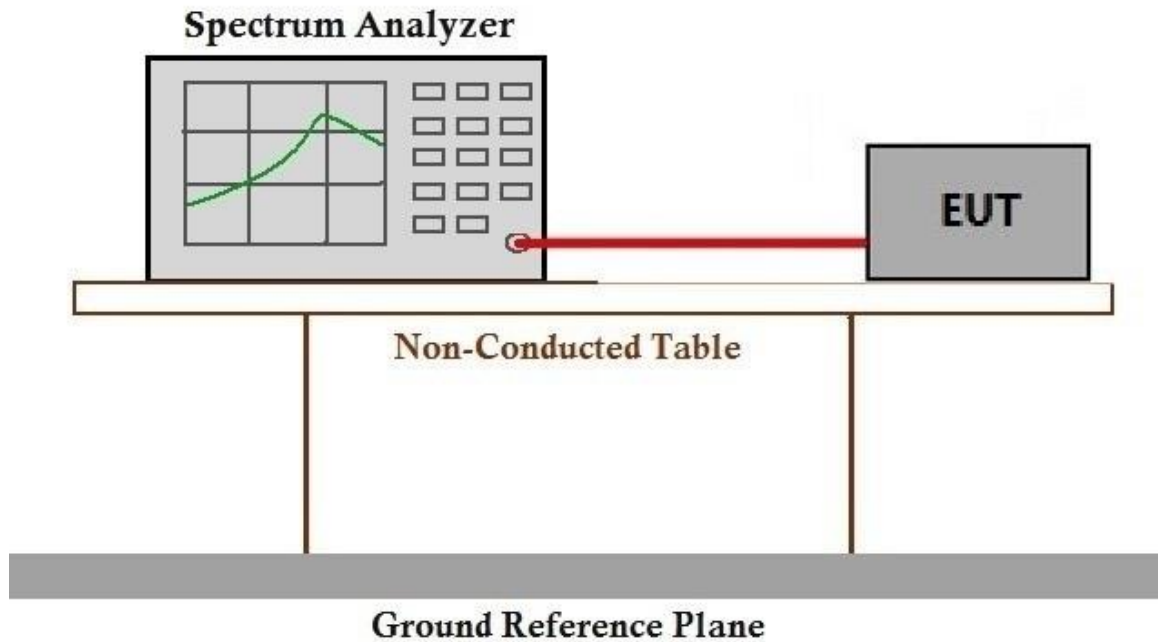
