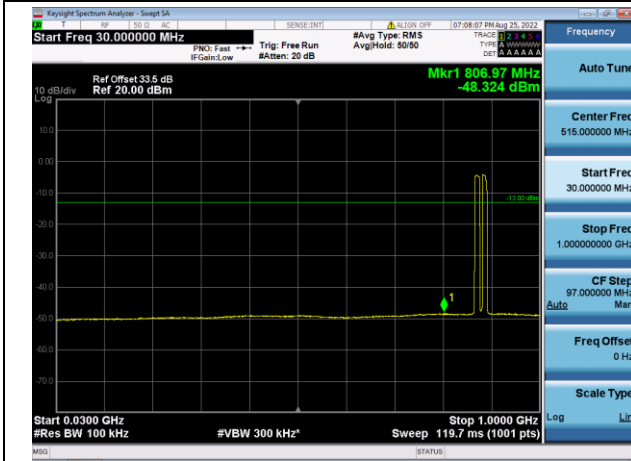

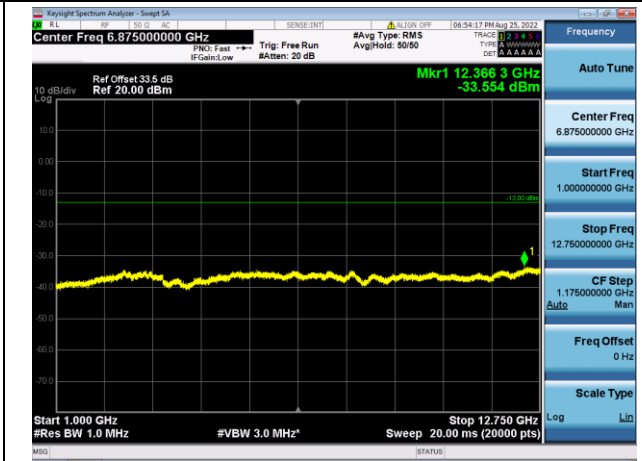
QPSK - 150kHz~30MHz
