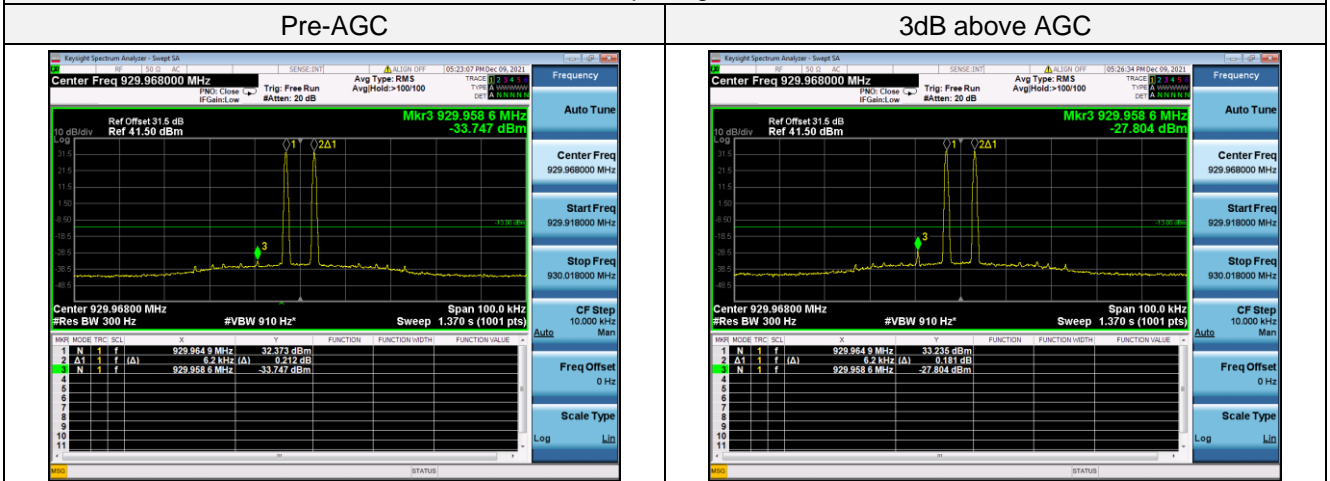

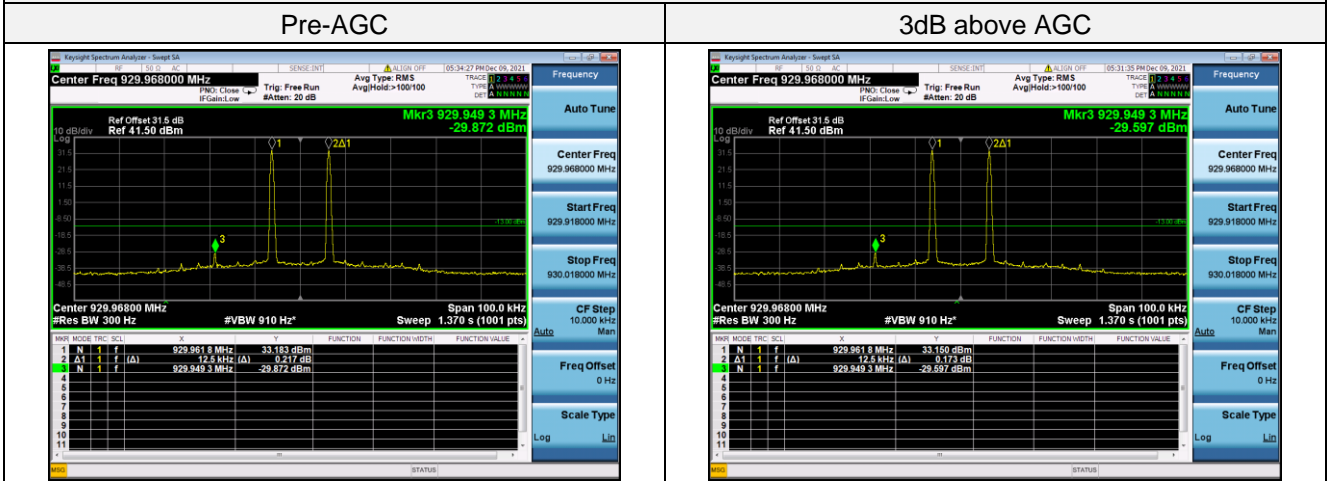

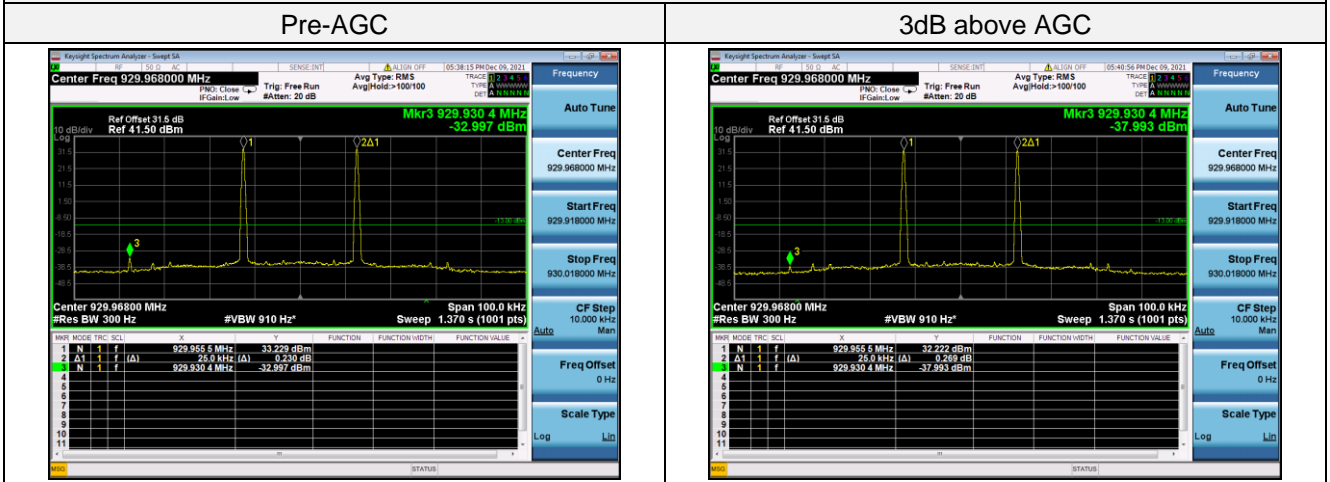

Channel Spacing: 25kHz

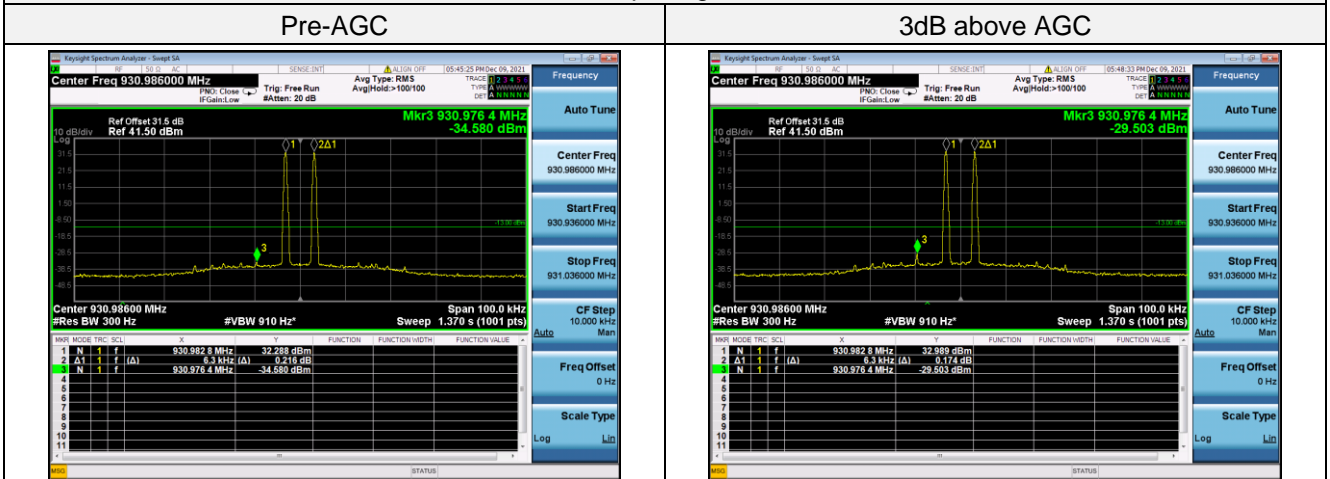

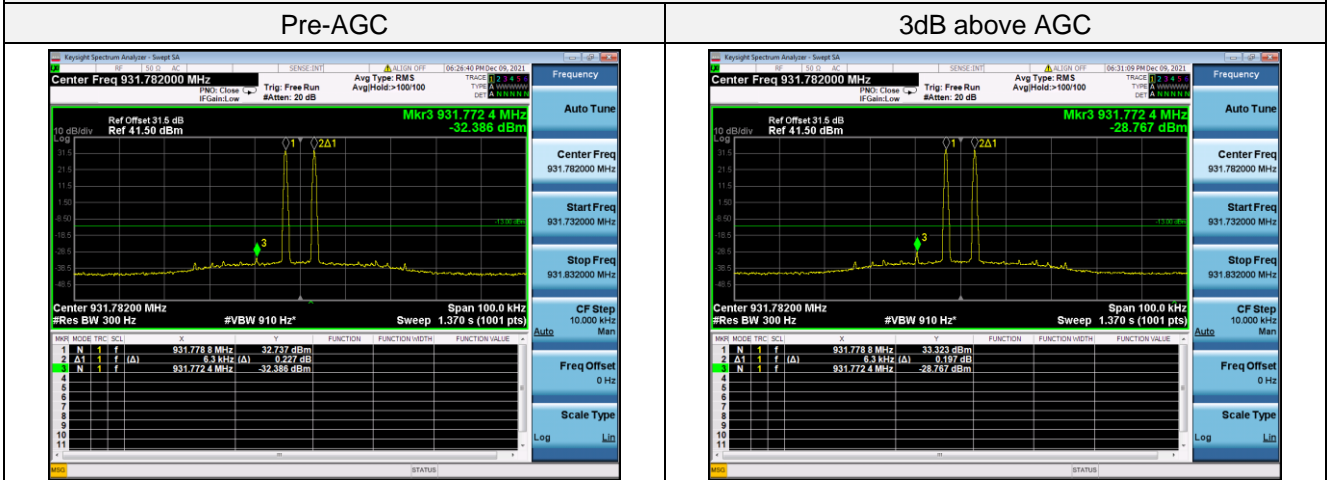

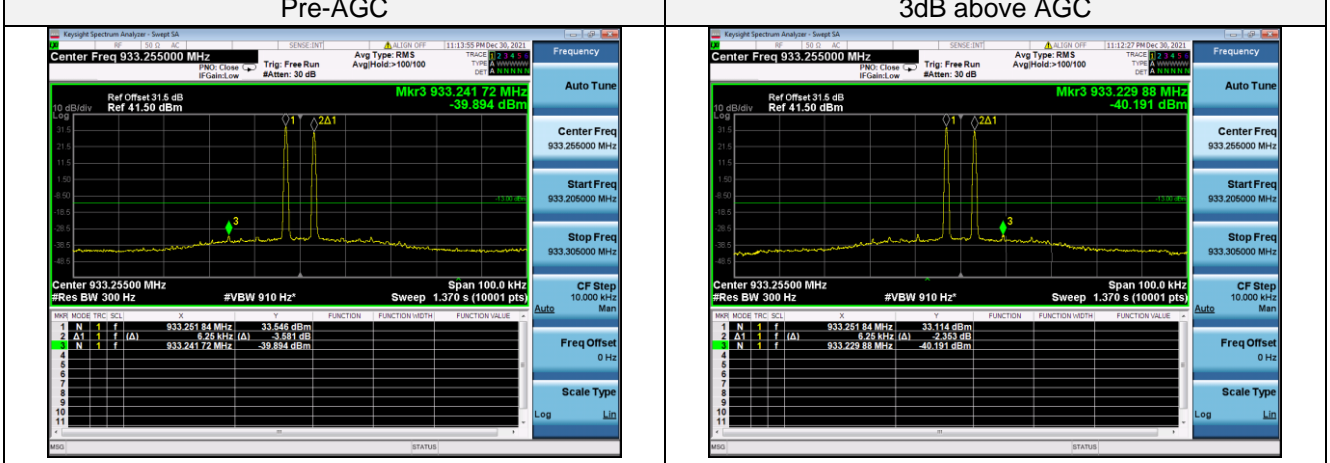
